**Australian Securities and Investments Commission
Corporations Act 2001 - Paragraph 601QA(1)(a) - Exemption**

Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission exempts the person specified in Schedule A from paragraph 601FC(1)(d) of the Act, to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests of the same class equally, in the case set out in Schedule B on the conditions set out in Schedule C for so long as the conditions are met.

Schedule A

MAP Airports Limited ACN 075 295 760 (*MAPL*) in its capacity as the responsible entity of MAP Airports Trust 1 ARSN 099 597 921 (*MAT1*) and MAP Airports Trust 2 ARSN 099 597 896 (*MAT2*) (together, the *Trusts*)

Schedule B

Where MAPL acts in accordance with the constitutions of the Trusts that permit it to:

1. require certain Foreign Holders to dispose of MAP Stapled Securities; or
2. dispose of MAP Stapled Securities held by Foreign Holders on their behalf;

in order:

- (a) that the Trusts retain the declaration that each of the Trusts is a substantially Australian investment fund under the Ownership Regulations; or
- (b) to avoid MAPL becoming a foreign person under the Ownership Provisions or Ownership Regulations; or
- (c) to avoid any breach or potential breach of the Ownership Provisions or non compliance or potential non compliance with the Ownership Regulations (together, the *Foreign Ownership Restrictions*) in relation to any Airport Investment by the Trusts or MAPL.

Schedule C

1. MAPL reasonably concludes and documents its conclusion in writing that it would be in the best interests of holders of MAP Stapled Securities to exclude Foreign Holders from holding MAP Stapled Securities;
2. Any Product Disclosure Statement for MAP Stapled Securities that is required to be given under the Act discloses the disposal mechanisms provided for by this instrument;

3. MAPL forwards to Foreign Holders as soon as reasonably practicable the proceeds upon disposal of MAp Stapled Securities subject to any allowable deductions for all reasonable costs and expenses of, or incidental to, the disposal of MAp Stapled Securities;
4. MAPL ensures that a permanent flag is maintained on the ASX Trade trading system of the ASX regarding the Foreign Ownership Restrictions; and
5. MAPL must provide a summary of all information regarding the Foreign Ownership Restrictions to all holders of MAp Stapled Securities in:
 - (a) the annual financial reports and half-year financial reports that are required to be sent to members under the Act or the ASX Listing Rules; and
 - (b) the New Investor Packs.

Interpretation

In this instrument:

ASX means the financial market operated by ASX Limited ACN 008 624 691.

Airport Investment means any direct or indirect investment by MAT1 or MAT2 in or in connection with an airport operator company (as defined in the *Airports Act 1996* (Cth)) or the holding company of an airport operator company.

Foreign Holder means a holder of MAp Stapled Securities who is defined as a foreign person pursuant to the *Airports Act 1996* (Cth).

MAp Stapled Securities means an interest in MAT1 and an interest in MAT2 which, under the terms on which each is to be traded, must be transferred together.

New Investor Pack means the documents that MAPL sends to a person after that person has acquired MAp Stapled Securities on the ASX for the first time.

Ownership Provisions means Part 3 of, and the Schedule to, the *Airports Act 1996* (Cth).

Ownership Regulations means the *Airports (Ownership – Interests in Shares) Regulations 1996* (Cth).




