Australian Securities and Investments Commission
Corporations Act 2001 – Paragraphs 911A(2)(l), 992B(1)(a), and 1020F(1)(a) –
Exemptions

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the Corporations Act 2001.

Title

2. This instrument is ASIC Instrument 11-1349.

Commencement

3. The exemptions in paragraphs 4 and 7 of this instrument commence on the date of signing. The exemptions in paragraphs 5 and 6 of this instrument commence on the date of gazettal.

Exemptions

4. The Issuer is exempt from Part 7.9 of the Act where the Issuer does any of the following:
 - a. makes an eligible offer;
 - b. offers to arrange for the issue of financial products under an eligible offer;
 - c. issues a financial product under an eligible offer.
5. The Issuer is exempt from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer made in the circumstances covered by paragraph 4 of this instrument (including any general advice given in the offer document) where the offer document for the eligible offer includes a statement to the effect that any advice given by the Issuer in connection with the eligible offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
6. The Issuer is exempt from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of dealing in a financial product in connection with an eligible offer covered by paragraph 4 of this instrument.
7. The Issuer is exempt from section 992A of the Act in relation to eligible offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Conditions

8. The Issuer making the eligible offer must:
- a. include that eligible offer in an offer document;
 - b. take necessary steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document;
 - c. provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee, such as the identity or entitlement of the employee) not later than 7 days after the first provision of that material to an employee;
 - d. ensure that the eligible offer is substantially on the terms set out in the offer document;
 - e. ensure that the eligible offer is not made to or accepted by more than 10 eligible employees; and
 - f. prepare and provide to every eligible employee who has accepted an eligible offer a Monthly Business Report within 7 days of the end of each month until 7 April 2014.

Interpretation

In this instrument:

eligible employee means a person who resides in Australia and who is at the time of an eligible offer, employed by the Issuer or Australian wholly-owned subsidiary of the Issuer at the level of senior manager or equivalent or higher;

eligible offer means an offer for the issue of performance units made under the Plan and extended only to eligible employees and for nil monetary consideration;

financial product advice has the meaning given by section 766B;

general advice has the meaning given by section 766B;

Issuer means Exide Technologies, a body corporate incorporated in the state of Delaware in the US and whose securities are traded on the NASDAQ Global Market;

Monthly Business Report means a document in writing that contains information about the Issuer's operating income for a particular month and cumulative operating income for the financial year to date, including information on all the components used to calculate operating income as described in the Rules of the Plan;

offer has a meaning affected by section 1010C;

offer document means a document in writing that sets out an offer under the Plan and which includes or is accompanied by:

- a. a copy of the Rules of the Plan under which the offer is made; and
- b. a description of how the Issuer's operating income and earning of performance units under the Plan will be calculated;

Plan means the employee incentive scheme that is known as at the date of this instrument as the Exide Technologies 2009 Stock Incentive Plan; and

Rules of the Plan means the written terms of the Plan that are substantially the same as the terms set out in the 2011 Performance Unit Grant Agreement and Plan provided by email to ASIC on 2 December 2011.

 - “(2A) A licensee need not provide the consumer with a Key Facts Sheet at or by the time it would otherwise be required to be provided if the licensee, acting reasonably, cannot prepare the Key Facts Sheet unless the licensee has made an assessment of whether to provide credit to the consumer under the standard home loan to which the Key Fact Sheet relates.
 - (2B) A licensee that relies on subsection (2A) must provide the consumer with the Key Facts Sheet as soon as practicable after the licensee has made the assessment.”


