Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 741(1)(b) – Declaration

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraph 741(1)(b) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 12-0103.

Commencement

3. This instrument commences on 24 January 2012.

Declaration

- Chapter 6D of the Act applies to Abacus Group Holdings Limited ACN 080 604 619 (AGHL), Abacus Group Projects Limited ACN 104 066 104 (AGPL) and Abacus Storage Operations Limited ACN 112 457 075 (ASOL) as if:
 - (a) subsection 711(6) were omitted; and
 - (b) subsection 723(1) were omitted.

Where this instrument applies

5. This instrument applies in relation to the Explanatory Memorandum dated 13 January 2012 which invites holders of ABP Stapled Securities and ASF Stapled Securities to attend meetings to be held on 24 February 2012 to consider and vote on proposals which if passed would, amongst other things, result in the shares of each of AGHL, AGPL, ASOL being stapled to the interests in AT, AIT and ASPT.

Interpretation

6. In this instrument:

ABP Stapled Securities means a share in AGHL, an interest in AT, a share in AGPL and an interest in AIT which, under the terms on which each is to be traded, must be transferred together.

AIT means Abacus Income Trust ARSN 104 934 287.

ASF Stapled Securities means a share in ASOL and an interest in ASPT which, under the terms on which each is to be traded, must be transferred together.

ASPT means Abacus Storage Property Trust ARSN 111 629 559.

AT means Abacus Trust ARSN 096 572 128.

Explanatory Memorandum means the notices of meeting, the prospectus and the Product Disclosure Statement dated 13 January 2012 in respect of the Stapling Transaction.

Stapling Transaction means the proposed arrangement by which shares in each of AGHL, AGPL, ASOL are to be stapled to interests in AT, AIT and ASPT.

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this
instrument under subsection 669(1) of the Corporations Act 2001. (the Act).

Title

2. This instrument is ASIC Instrument [12-0106].

Commencement

This instrument commences on 27 January 2012.

Declaration

- 4. ASIC declares that Chapter 6A of the Act applies to Kingsgate Consolidated Limited ACN 000 837 472 (*Kingsgate*) as if modified or varied as follows:
 - (a) in paragraph 661B(1)(a), after "in the prescribed form", insert "(omitting the holder's name and address)";
 - (b) in paragraph 661B(1)(c):
 - (i) omit "the notice", insert "a copy of the notice which includes the holder's name and address"; and
 - (ii) after "each other person", insert "for whom the bidder has registered addresses";
 - (c) in paragraph 661B(1)(d):
 - (i) after "give a copy", insert "of the notice referred to in paragraph (a)"; and
 - (ii) omit ".", insert ";";
 - (d) after paragraph 661B(1)(d), insert:
 - "(e) if the bidder does not have registered addresses for all holders provide an announcement to each relevant market operator at the time that it gives the copy of the notice under paragraph (d) that, without identifying any holder, states that the bidder does not have registered addresses for all holders and those holders who do not receive a notice pursuant to paragraph (c) within one week following the lodgement of the notice pursuant to paragraph (b) should contact the bidder's company secretary; and

- (f) if the bidder did not have a registered address for a holder at the time of providing notices to holders pursuant to paragraph (c) but is subsequently notified, or becomes aware, of the holder's registered address – provide the notice referred to in paragraph (c) to that holder and a statement explaining the effect of section 661E notwithstanding the date the notice is provided pursuant to this paragraph and the terms set out in the notice.";

- (k) in paragraph 663B(1)(d), after "give a copy of those documents", insert "referred to in paragraph (a) and subparagraph (c)(ii)";

- (I) in paragraph 663B(1)(d), delete "it", insert "the notice referred to in paragraph (a)";
- (m) in paragraph 663B(3), after "the notice", insert "referred to in subparagraph (c)(i)";
- (n) in paragraph 663B(4), after "the notice" where it first appears, insert "referred to in subparagraph (c)(i)";
- (o) in subsection 664C(1), after "in the prescribed form", insert "(omitting the holder's name and address)";
- (p) in subparagraph 664C(2)(b)(i), delete "the notice", insert "a copy of the notice which includes the holder's name and address";
- (q) in paragraph 664C(2)(d), after "give copies of those documents", insert "referred to in paragraph (a) and subparagraphs (b)(ii) and (b)(iii)";
- (r) in subsection 664C(4), after "the notice", insert "referred to in subparagraph (2)(b)(i)"; and
- (s) in subsection 664C(5), after "the notice" where it first appears, insert "referred to in subparagraph (2)(b)(i)"; and
- (t) in subparagraph 666B(1)(a) after "661B", insert "(or, in respect of holders for whom the person does not at the relevant time have a registered address, a copy of the compulsory acquisition notice lodged with ASIC that includes the holder's name)".

Where this instrument applies

- 5. This instrument applies with respect to the compulsory acquisition by Kingsgate of the following (as defined in the bidder's statement lodged by Kingsgate with ASIC on 2 November 2011):
 - (a) Laguna Fully Paid Shares;
 - (b) Type 1 Laguna Partly Paid Shares;
 - (c) Type 2 Laguna Partly Paid Shares; and
 - (d) Equity Participation Shares

where:

- (e) the compulsory acquisition is subsequent to the off-market takeover bid by Kingsgate for Laguna Resources NL ACN 008 460 366; and

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 911A(2)(l), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) — Exemptions

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 911A(2)(1), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 12-0109.

Commencement

This instrument commences on gazettal.

Exemption

- 4. ASIC exempts Discovery Metals Limited ACN 104 924 423 (the Issuer) from Part 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer.
- 5. ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in this instrument have not been met.
- 6. ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 4 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that eligible employees should

consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

7. ASIC exempts:

- (a) the Issuer; and
- (b) any related body corporate of the Issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by paragraph 4 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by paragraph 4 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or a related body corporate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in a financial product; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 8. ASIC exempts the Issuer from section 992A of the Act in relation to eligible offers covered by paragraph 4 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Where this instrument applies

9. This instrument applies on the conditions set out below and for so long as the conditions are met.

Conditions

- 10. The Issuer must ensure that the eligible offer is substantially on the terms set out in the Rules of the Plan.
- The Issuer must:
 - (a) include the offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the

employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and

- 12. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
- 13. the Issuer must take reasonable steps to ensure that the number of shares to be issued on vesting of a Performance Right when aggregated with:
 - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme, or like scheme (including the Plan) to be accepted, vested or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years pursuant to any employee share scheme, or like scheme (including the Plan) extended only to eligible employees of the Issuer;

but disregarding any offer made, or option acquired, or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that did not need disclosure to investors because of section 708; or
- (e) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (f) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts Interpretation Act 1901.

Interpretation

In this instrument:

- 1. current market price means in relation to a share, the price published on the financial market operated by ASX Limited ACN 008 624 691 (ASX) as the final price for the previous day on which the share was traded on that financial market.
- 2. *eligible employee* means a person who is, at the time of an eligible offer, a full or part-time employee or director of the Issuer or of a related body corporate of the Issuer.
- 3. *eligible offer* means an offer for the issue of a Performance Right that is made under the Plan.
- 4. financial product advice has the meaning given by section 766B of the Act.
- 5. general advice has the meaning given by section 766B of the Act.

- 6. offer has a meaning affected by section 1010C of the Act.
- 7. offer document means a document setting out an offer under the Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the Rules of the Plan; and
 - (b) if a summary (rather than a copy) of the Rules of the Plan is given includes an undertaking that during the period (the offer period) in which an eligible employee may acquire the financial products offered, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the Plan.
 - (c) specifies in respect of the shares:
 - (i) the acquisition price in Australian dollars; or
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australia dollar equivalent of that price were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the Issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee the current market price of the shares.
- 8. Performance Right means an unsecured right under the Plan to acquire, by way of issue or transfer, a fully paid ordinary share in the Issuer in accordance with the Rules of the Plan.
- 9. Plan means the terms and conditions of the employee share scheme, or like scheme, that is known at the date of this instrument as the Discovery Metals Limited ACN 104 924 423 Performance Rights Plan which is:
 - (a) extended only to eligible employees; and
 - (b) governed by the Rules of the Plan.
- 10. Rules of the Plan means the written rules of the Plan as at the date of this instrument that are substantially the same as the rules set out in the Discovery Metals Limited ACN 104 924 423 Performance Rights Plan Rules provided to ASIC as an attachment to an electronic email dated 18 January 2012.

Commencement

3. This instrument commences on the day it is signed.

Order

4. ASIC relieves XRT Limited (administrators appointed) ACN 076 348 000 (the *company*) from section 250N of the Act in relation to the annual general meeting of the company for the calendar year ending 31 December 2011.

Where this order applies

5. This order applies for so long as the company maintains arrangements for answering, free of charge, reasonable enquiries from its members about the consequences of the external administration of the company.

Where this order ceases to apply

6. This order ceases to apply on 30 September 2012

Title

2. This instrument is ASIC Instrument [12-0114].

Commencement

3. This instrument commences on the date of its gazettal.

Exemptions

- 4. M Payments Pty Ltd ACN 126 015 227 (*MPayments*), who provides financial services in relation to a Combined Facility, does not have to comply with subsection 911A(1), section 992A and Part 7.9 of the Act in relation to those financial services.
- 5. The exemptions in paragraph 4 are not available to MPayments if it does not comply with the conditions in paragraph 6 or 7.

Conditions

- 6. MPayments must take reasonable steps to ensure all of the following are satisfied:
 - (a) before or at the time the Combined Facility is offered to a person as a retail client, the person is given a written document (the *disclosure document*) which sets out the terms and conditions of the Combined Facility and separately sets out in a prominent manner:
 - (i) information about whether any of the terms and conditions of the facility may be unilaterally varied by the issuer and a statement of how a person (the *client*) who holds the Combined Facility may get information about the new terms and conditions;
 - (ii) information about whether there is a date (the expiry date) after which the Combined Facility cannot be used for the making of noncash payments (regardless of whether there is an amount standing to the credit of the facility at the end of the relevant day) and information about where the expiry date may be found out;

- (iii) information about the procedures for dealing with any unauthorised or mistaken transactions relating to the Combined Facility or the loss or theft of the device (if any) referred to in subparagraph (c)(i);
- (iv) fees or charges for acquiring and using the Combined Facility and where any such fees or charges are subject to change during the life of the Combined Facility, a statement of how the client may get information about the new fees or charges;
- (v) the name and contact details of MPayments, as the issuer of the Combined Facility;
- (vi) information about the internal dispute resolution processes relevant to each facility component of the Combined Facility and how they can be accessed by a client;
- (b) the disclosure document is worded and presented in a clear, concise and effective manner;
- (c) where the Combined Facility is subject to an expiry date:
 - if the client is provided with a physical device to use the Combined Facility — the expiry date is prominently set out on the device in a manner that makes it clear that it is an expiry date;
 - (ii) otherwise the expiry date is set out in the disclosure document or in a written statement that is attached to the disclosure document;
- (d) a convenient means is available, that involves no charge by the issuer or the associates of the issuer, for the client to do all of the following:
 - (i) check the amount standing to the credit of the Combined Facility;
 - (ii) if subparagraph (c)(ii) applies check any relevant expiry date that applies to the Combined Facility;
 - (iii) obtain at reasonable intervals a record of the past 10 transactions (or such transactions that have occurred) under the Combined Facility;
- (e) if the terms and conditions of the Combined Facility are unilaterally varied, or the fees or charges for using the Combined Facility are changed during the life of the Combined Facility:
 - a statement setting out the effect of the variation or change is displayed in a clear and prominent notice at each place of business where the Combined Facility may be acquired in an area that is accessible to the public;

- (ii) information about the variation or change is made available to the client in accordance with the statement in subparagraph 6(a)(i) or 6(a)(iv);
- (iii) the new terms and conditions or fees and charges are made available to the client on request at each place of business where the Combined Facility may be acquired; and
- (iv) if the issuer makes available information about the Combined Facility on an Internet website — information about the variation or change, and the new terms and conditions or fees and charges are made available on the website in a manner reasonably likely to come to the attention of persons seeking information about the Combined Facility;
- (f) if a Combined Facility is issued to a person as a retail client, the issuer maintains adequate internal dispute resolution processes in accordance with the Australian Standard on Complaints Handling (AS ISO 10002-2006) as at 5 April 2006;
- 7. MPayments gives ASIC notice in writing when the Combined Facility ceases to be a low value non-cash payment facility.

Interpretation

8. In this instrument:

Combined Facility means a facility comprised of two component facilities, a low value non-cash payment facility and a loyalty scheme.

debit card has the meaning given by subsection 12DL(5) of the Australian Securities and Investments Commission Act 2001.

device includes a certificate, voucher, token, card, coin or other object by which a person may use a low value non-cash payment facility.

facility has a meaning affected by section 762C of the Act.

issuer has the meaning given by subsection 761E(4) of the Act.

low value non-cash payment facility means a facility through which, or through the acquisition of which, a person makes non-cash payments and in relation to which the following are satisfied:

(a) the total amount available for the making of non-cash payments under all facilities of the same class held by any person at any one time does not exceed \$1,000;

- (b) the total amount available for making non-cash payments under all facilities of the same class does not exceed \$10,000,000 at any time;
- (c) the facility is a prepaid debit card that can be used to make payments through the MPayments network; and
- (d) the facility is issued by MPayments.

loyalty scheme means a facility through which, or through the acquisition of which, a person makes non-cash payments in relation to which all of the following apply:

- (a) the facility is issued as part of a scheme the sole or main purpose of which is to promote the purchase of goods from, or the use of the services of, the issuer of the facility or another person;
- (b) a person who holds the facility is allocated credits (however described and whether or not a monetary value is expressly attributed to the credits) as a result of the purchase of goods from, or the use of the services of, the issuer of the facility or the other person;
- (c) the credits allocated under the facility can be used to make a payment or part payment for goods or services or to obtain some other benefit; and
- (d) the facility is issued by MPayments.

makes non-cash payments has the meaning given by section 763D of the Act.

offer has a meaning affected by subsection 1010C(2) of the Act.

retail client has the meaning given by section 761G of the Act.

- 4. Chapter 5C of the Act applies to ING Investment Management Limited ACN 003 731 959 (the *responsible entity*) in its capacity as responsible entity for the ING Wholesale Global Property Securities Fund ARSN 115 202 358 (the *scheme*) as if section 601FL were modified or varied as follows:
 - (a) in subsection (1) omit all the text after the word "it", substitute:

"must either:

- (a) call a members' meeting to explain its reason for wanting to retire and to enable the members to vote on a resolution (which must be an extraordinary resolution if the scheme is not listed) to choose a company to be the new responsible entity; or
- (b) propose a related body corporate of the responsible entity to be the new responsible entity in accordance with subsection (1A).";
- (b) after subsection (1) insert:
