- (d) as soon as practicable and in any event within 2 business days after the last member has given its written consent, the responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and

Declaration

- 4. Chapter 5C of the Act applies to Cromwell Property Securities Limited ACN 079 147 809 (*CPSL*) in its capacity as the responsible entity of the registered schemes specified in paragraph 5 as if section 601FL of the Act were modified or varied as follows:
 - (a) in subsection (1) omit all the text after the word "it" and substitute:

"must either:

- (D) how members can access on the responsible entity's web site current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur; and
- (ii) state prominently that if:
 - (A) members who together hold at least 5% of the total value of the interests held by members; or
 - (B) 100 members,

who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and

- (iii) be accompanied by a form which can be ticked to ask for a vote; and
- (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) The responsible entity must prominently disclose on its web site current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur.
- (d) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with

Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.

- (e) If there is a postal vote:
 - (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent; and
 - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
 - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
 - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
- (f) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed."; and
- (c) after subsection (1), insert the following subsection:
 - "(2A) If a postal vote is arranged under paragraph (1A)(d) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.
 - (2B) If:
 - (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and
 - (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and
 - (c) the entity has consented in writing to becoming the scheme's responsible entity,

- (d) as soon as practicable and in any event within 2 business days after the end of the period in which a member may ask for such a vote, the current responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and

Title

2. This instrument is ASIC Instrument 12-0420.

Commencement

3. This instrument commences on gazettal.

Exemption

- 4. Technip S.A., a company registered with the Trade and Companies Register of Paris (the *issuer*) and a related body corporate of the issuer does not have to comply with:
 - (a) Parts 6D.2 and 6D.3 (except section 736) of the Act where the issuer or a related body corporate of the issuer makes an offer for the issue of Share Appreciation Rights under the Plan;
 - (b) Part 7.9 of the Act where the issuer or the related body corporate of the issuer:
 - (i) makes an offer, issues or offers to arrangement for the issue of Share Appreciation Rights under the Plan; or
 - (ii) makes a recommendation to acquire Share Appreciation Rights under the Plan, except where the issuer or the related body corporate of the issuer is aware, or ought reasonably to be aware, that the conditions of this order have not been met;
 - (c) the requirement to hold an Australian financial services licence under subsection 911A(1) of the Act for:
 - (i) the provision of a financial service consisting of general advice reasonably given in connection with an offer under the Plan (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only; and

- (ii) dealing in a financial product in connection with an offer under the Plan where any acquisition by purchase or disposal of the product (by the issuer or a related body corporate) occurs either:
 - (A) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (B) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place; and
- (d) sections 736 and 992A of the Act in relation to an offer under the Plan made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
- 5. Societe Generale, a limited liability company registered with the French commercial register of companies under the number RCS Paris 552 120 222 (the *custodian*) does not have to comply with the requirement to hold an Australian financial services licence under subsection 911A(1) of the Act for:
 - (a) the provision of a custodial or depository service in connection with an offer under the Plan and an offer under the Previous Plan where the custodian performs their duties in good faith and has sufficient resources to perform those duties; and
 - (b) dealing in a financial product in the course of or providing a custodial or depository service covered by subparagraph (a).
- 6. Crédit Agricole Corporate and Investment Bank, a company registered with the French commercial register of companies under the number RCS Nanterre 304 187 701(the *warrant issuer*) does not have to comply with:
 - (a) the requirement to hold an Australian financial services licence under subsection 911A(1) of the Act for the following financial services:
 - (i) the provision of general advice to a related body corporate of the issuer reasonably given in connection with the issue of a arrant where the advice includes a statement to the effect that any advice given, is general advice only, and that the related body corporate of the issuer should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice; and
 - (ii) dealing in a financial product in connection with the issue of a Warrant to a related body corporate of the issuer.
 - (b) sections 992A and 992AA in relation to the offer of a Warrant covered by paragraph 7, made in the course of, or because of, unsolicited meetings or

telephone calls reasonably held or made in connection with the issue of the Warrant.

- 7. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an offer covered by paragraph 4 of this order from Part 7.9 of the Act where:
 - (a) a recommendation is made that a person to whom such an offer has been made, acquires the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in this order have not been met.

Where this instrument applies

- 8. This instrument applies where the issuer:
 - (a) meets the requirements (including, for the avoidance of doubt, definitions) of ASIC Class Order [CO 03/184] (the *class order*) as in force on the date of this instrument and as amended from time to time by a disallowable legislative instrument within the meaning of the *Legislative Instrument Act 2003*, except the definition of:
 - (i) 'eligible offer' in paragraph 9 of the Interpretation, and
 - (ii) 'offer document' in paragraph 15 of the Interpretation; and
 - (b) would meet the requirements of the class order if the definition of an 'eligible offer' in paragraph 9 of the Interpretation was to read:
 - "9. "eligible offer" means an offer for issue or sale of:
 - (a) fully-paid shares in an issuer in the same class as shares which have been quoted on the Euronext Paris throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; or
 - (b) options for the issue or transfer of shares referred to in paragraph (a) where each of the options is offered for no more than nominal consideration; or
 - (c) share appreciation rights in relation to shares referred to in paragraph (a),

made under an employee share scheme extended only to eligible employees of the issuer;" and

- (c) would meet the requirements of the class order if, in the definition of an 'offer document' in paragraph 15 of the Interpretation, subparagraphs 15(c) and (d) were to read:
 - "(c) specifies in respect of the share appreciation rights or the shares to which the share appreciation rights relate:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the eligible offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were the formula applied at the date of the eligible offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the issuer who has a registered office in this jurisdiction will, during the period which an eligible employee may acquire the shares, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of the shares to which the share appreciation rights relate; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that subparagraph as updated to that date."; and
- (d) would meet the requirements of the class order if, in the Interpretation, the following definition were inserted:
 - "16A. "share appreciation rights" means a right to be allocated a fully paid ordinary share in the capital of an issuer, or to receive a cash amount equivalent value to such a share."

Conditions

9. The issuer must comply with the conditions of the class order.

Interpretation

10. In this instrument:

Euronext Paris means the regulated market operated by Euronext Paris SA.

Plan means the Technip Capital 2012 Employee Share Plan, the terms of which are substantially in the same form as those provided to ASIC on 13 and 28 March 2012.
