**Enabling legislation**

1. The Australian Securities and Investments Commission makes this instrument under paragraph 1020F(1)(c) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument [12-0453].

**Commencement**

3. This instrument commences on 10 April 2012.

**Declaration**

4. Part 7.9 of the Act applies in relation to an interest (a *shortfall interest*) in Real Estate Capital Partners USA Property Trust ARSN 114 494 503 (the *Trust*) to which the divestiture order relates as if section 1012C of the Act were omitted.

**Where this instrument applies**

5. This instrument applies in relation to:
  - (a) an offer for sale of a shortfall interest by Frost Holdings Pty Ltd ACN 000 596 985 (*Frost*) in accordance with the divestiture order; and
  - (b) any subsequent offer for sale of a shortfall interest by a person that is made within 12 months after the sale of the interest by Frost (whether or not the person making the offer acquired the interest from Frost or another person).

**Interpretation**

6. In this instrument:

*divestiture order* means Order 3 of the orders made by the Takeovers Panel on 28 March 2012 following a declaration of unacceptable circumstances made by the Panel on the same day in relation to the affairs of the Trust.

**Enabling Legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 655A(1)(b) of the *Corporations Act 2001 (Act)*.

**Title**

2. This instrument is ASIC Instrument [12-0457].

**Commencement**

3. This instrument commences on the date it is signed.

**Declaration**

4. Chapter 6 of the Act applies to Minemakers Limited ACN 116 296 541 (the *Bidder*) as if:
  - (a) Section 612 were modified or varied by inserting “, other than a contravention of subsection 630(3) where the bidder subsequently extends the offer period under subsection 650C(3)” after “(conditional offers)”;
  - (b) Subsection 630(2) were modified or varied by inserting “(including, for the avoidance of doubt, an extension under subsection 650C(3))” after “If the offer period is extended by a period”;
  - (c) Subsection 650C were modified or varied by inserting after subsection 650C(2):
    - “(3) If the bid is subject to a defeating condition and the bidder has not given the notice under subsection 630(3) on the date for giving notice of the status of the condition (prior to any extension of the offer period in accordance with this subsection), the bidder may extend the offer period after the date for giving notice of the status of the condition if:
      - (a) the bidder's voting power in the target has not increased to more than 20%; and
      - (b) the bidder has not previously extended the offer period under this subsection.”;
  - (d) Paragraph 650E(1)(b) were modified or varied by inserting “or extends the offer period under subsection 650C(3)” after “the bidder varies the offers under the bid in a way that postpones for more than 1 month the time when the bidder has to meet their obligations under the bid”; and


- (e) Paragraph 650E(2)(a) were modified or varied by inserting “if the bidder has extended the offer to a date under subsection 650C(3) (the *extended date*), give the bidder notice at least 8 days before the extended date, and in any other case” before “give the bidder notice”.

**Where this instrument applies**

6. This instrument applies where:

- (a) the Bidder has made an off-market takeover bid for all of the ordinary shares in UCL Resources Limited ACN 002 118 872 (the *Target*), in respect of which a bidder’s statement was lodged with ASIC on 20 February 2012;
- (b) the Bidder’s voting power in the Target at the date of this instrument has not increased to more than 20%; and
- (c) the Bidder has:
- (i) prepared a notice extending the offer period to 8 May 2012 (*Extension Notice*);
  - (ii) prepared a notice stating that the new date for giving notice of the status of conditions to which the offer is subject, as required by subsection 603(3) of the Act, is 1 May 2012;
- (collectively the *Notices*)
- (iii) lodged the Extension Notice with ASIC;
- (iv) given the Notices to:
- (A) the Target;
  - (B) ASX Limited ACN 008 624 691; and
  - (C) everyone to whom offers were made under the bid; and
- (v) lodged a supplementary bidder’s statement with ASIC explaining the Notices and giving notice to persons who have accepted that they may withdraw their acceptance by giving the bidder notice at least 8 days before the end of the offer period referred to in the Extension Notice.

**ORDERS**

**REAL ESTATE CAPITAL PARTNERS USA PROPERTY TRUST**

The Panel made a declaration of unacceptable circumstances on 28 March 2012.

**THE PANEL ORDERS**

1. Frost must not:
  - (a) rely on any right it may have to terminate the underwriting arrangement as a consequence of the application to the Panel in this matter, the declaration of unacceptable circumstances and these orders or
  - (b) rely on clauses 10.3 or 12.1 of the underwriting agreement with RCU in relation to any 'losses' (as defined in the underwriting agreement) that it incurs as a consequence of the application to the Panel in this matter, the declaration of unacceptable circumstances and these orders other than the reasonable costs and expenses incurred by Frost in considering and responding to the application to the Panel.
2. Frost must:
  - (a) divest shortfall units as set out in these orders and
  - (b) until completion of these orders, not otherwise deal with or vote any shortfall units.
3. Within 10 business days of these orders RCU must, on behalf of Frost, offer eligible unit holders any shortfall units obtained by Frost under the rights issue on terms to the following effect:
  - (a) the price is the rights issue price
  - (b) the offer is open for 2 weeks from the date the last of the offers is dispatched
  - (c) eligible unit holders who did not take up their full entitlement in the rights issue are offered as many units as is necessary for them to take up what were their full original entitlements
  - (d) eligible unit holders who accept for units under order 3(c) are treated as if they had subscribed for those units pursuant to the rights issue

- (e) eligible unit holders (including Frost) are invited to apply for any units remaining after the acceptances in order 3(c) have been satisfied in full. Applications must be filled as follows:
- (i) each unit holder who has applied for additional units will be allocated their pro rata share of the shortfall having regard to their unit holdings at the record date. If a unit holder has made a shortfall application for an amount less than the amount of units that the unit holder would otherwise be allocated under this process, the unit holder will be allocated the amount applied for and
  - (ii) if, following allocation of the shortfall in the first round, there remains any shortfall, the above allocation process will be repeated in rounds until either all the shortfall has been allocated or all shortfall applications have been satisfied in full.

For avoidance of doubt the Corporations Act limits apply to the acquisition of shortfall units (other than by Frost)

- (f) the money (in cheque or other form acceptable to RCU) for the units accepted under order 3(c) is to be sent to RCU with the acceptance. The money is to be banked in a special purpose trust account no later than the end of the day of receipt and
  - (g) the money (in cheque or other form acceptable to RCU) for the units applied for under order 3(e) must be paid within 2 business days of notification to the applicant of the proposed allocation. If not, the units may be re-allocated. Frost is not obliged to pay for any proposed allocation of units under order 3(e).
4. The offer must be made in a letter of offer dispatched to eligible unit holders.
  5. Within 5 business days of the close of the offer, RCU must:
    - (a) scale back the applications if necessary
    - (b) disclose in a market announcement the scale back and its detailed calculation methodology
    - (c) register the transfers of the units and
    - (d) pay over the money, and account, to Frost for the units sold (other than in relation to those units allocated to Frost).
  6. Frost must provide proper transfers for the sale of the units.
  7. Frost must pay to RCU the reasonable costs of dispatching the offers and processing the acceptances, applications and refunds (if any).
  8. RCU must issue any refund due to an applicant within 5 business days of transfers being completed.
  9. RCU must extend the closing date of the rights issue by no less than 2 business days and promptly make an ASX announcement after it has done so.

DECLARATION OF UNACCEPTABLE CIRCUMSTANCES**

**REAL ESTATE CAPITAL PARTNERS USA PROPERTY TRUST**


**CIRCUMSTANCES**

1. Real Estate Capital Partners USA Property Trust (RCU) has a 0.98 for 1 rights issue underway, announced by the responsible entity of RCU (Real Estate Capital Partners Managed Investments Limited – RE) on 1 March 2012.
2. The rights issue is renounceable and rights trading ended on 21 March 2012.
3. The rights issue is fully underwritten by Frost Holdings Pty Ltd (Frost), which has voting power of 19.82% in RCU.
4. If no unit holders (other than Frost) take up their entitlement under the rights issue, Frost would obtain voting power of 59.51% in RCU.
5. Frost discouraged RCU or RE from implementing a dispersion strategy in relation to the rights issue, other than allowing the rights issue to be renounceable.
6. All reasonable steps to minimise the potential control impact of the rights issue on RCU were not taken.
7. It appears to the Panel that the circumstances are unacceptable having regard to:
  - (a) the effect that the Panel is satisfied the circumstances have had, are having, will have or are likely to have on:
    - (i) the control, or potential control, of RCU or
    - (ii) the acquisition, or proposed acquisition, by a person of a substantial interest in RCU and/or
  - (b) the purposes of Chapter 6 set out in section 602 of the Corporations Act 2001 (Cth) (Act).
8. The Panel considers that it is not against the public interest to make a declaration of unacceptable circumstances. It has had regard to the matters in section 657A(3).



Corporations Act 2001 — Subsection 601QA(1) — Declaration**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 601QA(1) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 12-0467.

**Commencement**

3. This instrument commences on the day it is signed.

**Declaration**

4. Chapter 5C of the Act applies to Macquarie Alternative Assets Management Limited ACN 103 237 181 (the *responsible entity*) in its capacity as responsible entity of:

- (a) VOLition Fund (ARSN 136 856 383); and
- (b) Macquarie Switch (ARSN 135 971 756)

(the *schemes*),

as if section 601FL were modified or varied as follows:

- (a) in subsection (1) omit all the text after the word “it” and substitute:

“must either:

- (a) call a members’ meeting to explain its reason for wanting to retire and to enable the members to vote on a resolution (which must be an extraordinary resolution if the scheme is not listed) to choose a company to be the new responsible entity; or
- (b) propose a related body corporate of the responsible entity to be the new responsible entity in accordance with subsection (1A).”;

- (b) after subsection (1) insert:

“(1A) The requirements for proposing a related body corporate (the *proposed responsible entity*) to be the new responsible entity are as follows:

- (a) The responsible entity must give members of the scheme notice of a proposal to choose the proposed responsible entity, to be the scheme's new responsible entity.
- (b) The notice to members must:
- (i) set out the following information:
    - (A) the responsible entity's reasons for wanting to retire;
    - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity;
    - (C) information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur;
    - (D) how members can access on the responsible entity's website current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur; and
  - (ii) state prominently that if:
    - (A) members who together hold at least 5% of the total value of the interests held by members; or
    - (B) 100 members,who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and
  - (iii) be accompanied by a form which can be ticked to ask for a vote; and
  - (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) The responsible entity must prominently disclose on its website current information about the proposed timing of

the retirement of the responsible entity and the manner in which that retirement will occur.

- (d) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.
  - (e) If there is a postal vote:
    - (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent; and
    - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
      - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
      - (B) only votes received by the responsible entity within 28 days after the sending of the voting paper will be counted.
  - (f) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed.”;
- (c) after subsection (2) insert:
- “(2A) If a postal vote is arranged under paragraph (1A)(d) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.
  - (2B) If:
    - (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and

(b) insufficient members ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and

(c) the entity has consented in writing to becoming the scheme's responsible entity,

then:

(d) as soon as practicable and in any event within 2 business days after the end of the period in which a member may ask for such a vote, the current responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and

(e) the notice must be accompanied by a certificate from the current responsible entity that it reasonably considers that the appointment of the proposed responsible entity would be in the best interests of members with a summary of the responsible entity's reasons as to why this is the case; and

(f) unless ASIC reasonably believes that the appointment of the proposed responsible entity would not be in the best interests of members, ASIC must comply with the notice as soon as practicable after the notice and summary are lodged."

#### **Where this declaration applies**

5. This declaration applies where Macquarie Financial Products Management Limited ACN 095 135 694 has consented in writing to becoming the new responsible entity of the schemes.

6. This declaration ceases to apply on 6 July 2012.

**992B(1)(a), 1020F(1)(a) and 1020F(1)(b) —Exemptions**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 601QA(1)(a), 741(1)(a), 911A(2)(l), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 12-0468.

**Commencement**

3. This instrument commences on the date of its gazettal.

**Exemptions**

4. ASIC exempts:
  - (a) the issuer;
  - (b) a related body corporate of the issuer; and
  - (c) any person who, by way of contract between the person and the issuer, in connection with an eligible offer, acts for or on behalf of the issuer, from Parts 6D.2, 6D.3 (except section 736) and 7.9 where that person:
    - (d) makes an eligible offer;
    - (e) offers to arrange for the issue of financial products under an eligible offer;
    - (f) issues a financial product under an eligible offer,on the conditions set out in paragraph 10 of this instrument and for so long as the conditions are met.
5. ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 where a person (other than a person covered by paragraph 4 of this instrument) makes a recommendation to acquire financial products under an eligible offer, except where the person is aware, or ought reasonably to be aware, that any of the conditions set out in paragraph 10 have not been met.
6. ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of paragraph 4 of this instrument from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of

general advice reasonably given in connection with an offer referred to in that paragraph (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

7. ASIC exempts:

(a) the issuer who is exempt from Part 6D.2 or Part 7.9 because of paragraph 4 of this instrument; and

(b) a related body corporate of the issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

(c) the provision of a custodial or depositary service in connection with an eligible offer covered by the exemption in paragraph 4 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and

(d) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph 7(c) of this instrument; and

(e) dealing in a financial product in connection with an eligible offer covered by the exemption in paragraph 4 of this instrument where any acquisition by purchase or disposal of the product (by the issuer or related body corporate of the issuer) occurs either:

(i) through a person who holds an Australian financial services licence authorising the holder to deal in those financial products; or

(ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in those financial products in the relevant place.

8. ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of paragraph 4 of this instrument from sections 736, 992A and 992AA in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with an eligible offer.

9. ASIC exempts:

(a) the issuer;

(b) a related body corporate of the issuer; or

- (c) any person who, by way of contract between the person and the issuer, in connection with an eligible offer, acts for or on behalf of the issuer,

from subsection 601ED(5) in relation to the operation of a managed investment scheme relating to an eligible offer covered by the exemption in paragraph 4 of this instrument.

### Conditions

10. The following conditions apply:

- (a) the issuer must ensure that the eligible offer must be substantially on the terms set out in the letter from Freehills to ASIC dated 17 February 2012, titled 'Cap Gemini: Employee Share Offering 2012' on behalf of the issuer; and
- (b) the person making the offer must:
- (i) include that offer in an offer document; and
  - (ii) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
  - (iii) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- (c) the issuer must take reasonable steps to ensure that Capgemini Australia complies with any undertaking required to be made in the offer document by reason of this instrument; and
- (d) the issuer must take reasonable steps to ensure that the number of shares the subject of the offer when aggregated with:
- (i) the number of shares in the same class which would be issued were each outstanding offer with respect to shares and units of shares, under an employee share scheme to be accepted or exercised; and
  - (ii) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (iii) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
