**Australian Securities and Investments Commission****Corporations Act 2001 – Paragraphs 601QA(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) - Exemption**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from compliance with section 601ED of the Act, in the case specified in Schedule B on the conditions set out in Schedule D.
2. Under paragraph 911A(2)(l) of the Act, ASIC exempts the person specified in Schedule A from the requirement to hold an Australian financial services licence for the provision of financial services, in the case specified in Schedule C.
3. Under paragraph 992B(1)(a) of the Act, ASIC exempts the person specified in Schedule A from compliance with section 992AA, in the case specified in Schedule C on the conditions set out in Schedule D.
4. Under paragraph 1020F(1)(a) of the Act, ASIC exempts the person specified in Schedule A from compliance with Part 7.9 of the Act, other than Divisions 5 and 5A of Part 7.9, in the case specified in Schedule C on the conditions set out in Schedule D.
5. This instrument will cease to apply if condition 8 of Schedule D is not complied with.

**Schedule A**

Community Housing Canberra Ltd ACN 081 354 752 (*Operator*).

**Schedule B**

The Operator operates a managed investment scheme (the *Scheme*) under which:

- (a) owners of real property will rent their properties to third parties under the NRASA;
  - (b) the owners of real property under the Scheme will be entitled to receive rent from the tenants and will be required to pay all outgoings;
  - (c) the Operator or the owners of real property will be entitled to receive annual payments from the Federal and State or Territory governments available under the NRASA, which may include the issue of individual or

consolidated tax offset certificates by the Department to the Operator or to the owners of real property; and

- (d) the Operator will distribute to the owner of a real property under the Scheme the benefit of all annual payments or certificates the Operator receives from the Federal and State or Territory governments available under the NRASA for the real property.

#### **Schedule C**

1. The Operator issues or arranges to issue an interest in the Scheme; or
2. The Operator offers to issue or to arrange for the issue of an interest in the Scheme.

#### **Schedule D**

1. The Operator must give a Disclosure Document to a person at or before the time the Operator offers to issue an interest in the Scheme or offers to arrange for the issue of an interest in the Scheme, or issues an interest in the Scheme, to that person.
  2. The Operator or an independent person appointed by the Operator must maintain a trust account in which any annual payments received from the Federal, State and Territory governments under the NRASA must be held pending the distribution to the owners of real property under the Scheme.
  3. The Operator or an independent person appointed by the Operator must retain copies of any notification given by the Department to the Operator of:
    - (a) the annual payments made or to be made by the Federal government to the owners of real property under the NRASA; and
    - (b) the tax offset certificates issued by the Department directly to the relevant owners of real property,for the period of 7 years after the date of the Disclosure Document.
  4. The Operator will notify ASIC that a Disclosure Document is in use.
  5. The Operator will lodge a notice with ASIC, in electronic form, advising of the occurrence of any of the following events as soon as practicable, and in any event within 5 business days, after the occurrence of the event:
    - (a) a copy of the Disclosure Document is first given to someone; or
    - (b) a change is made to fees and charges set out in the Disclosure Document; or
    - (c) an interest in the Scheme ceases to be available.

6. The Operator must keep a copy of the Disclosure Document for the period of 7 years after the date of the Disclosure Document.
7. During the period of 7 years from the date of the Disclosure Document, the Operator must:
  - (a) make a copy of the Disclosure Document available to ASIC if asked to do so by ASIC; and
  - (b) comply with any reasonable request from any other person for a copy of the Disclosure Document.
8. Within 5 business days from when the Operator became or should reasonably have become aware of matters that give it reason to believe that it has failed or is likely to fail to comply with a condition of this Schedule D, the Operator must notify full particulars of that failure to ASIC (to the extent that the Operator knows those particulars or would have known them if it had undertaken reasonable enquiries).

**Interpretation**

In this instrument:

**Department** means the Department of Sustainability, Environment, Water, Population and Communities (Cth), its successor or any other body that performs similar functions for the purposes of the NRASA.

**Disclosure Document** means a document which must include the following:

1. confirmation from the Operator that individual tax offset certificates may be issued by the Department directly to the owners of real property and that the Operator or an independent person appointed by the Operator will keep copies of any notification given by the Department to the Operator of:
    - (a) the annual payments made or to be made by the Federal government to the owners of real property under the NRASA; and
    - (b) the tax offset certificates issued by the Department directly to the relevant owners of real property,for the period of 7 years after the date of the Disclosure Document;
  2. a description of the Scheme;
  3. a description of the main features of the interests in the Scheme;
  4. details of the main terms and conditions of the offer;
  5. a description of how the Scheme will generate returns for investors;
  6. the details of any fees and charges payable by the owner in relation to his, her or its participation in the Scheme;

7. a description of the Operator and its credentials in operating the Scheme;
8. a description of the credentials of any person engaged by the Operator to provide services for the Scheme on the Operator's behalf;
9. provide answers to the questions, other than sub subparagraphs 2(a)(iii), 2(b)(i), 2(d)(i) and 2(d)(iii), of Schedule F to ASIC Class Order [CO 02/303], as in force on the date of this instrument and as amended from time to time by a disallowable legislative instrument within the meaning of the *Legislative Instrument Act 2003*, sufficiently to enable a typical investor in the interests in the Scheme to make an informed decision whether to invest in an interest in the Scheme; and
10. a prominent statement to the effect that a person should consider whether to consult:
  - (a) an investment adviser who is either a financial services licensee or an authorised representative of a financial services licensee;
  - (b) a taxation adviser; and
  - (c) a lawyer,before making a decision to become a member of the Scheme.

*NRASA* means the *National Rental Affordability Scheme Act 2008*.

1. The Australian Securities and Investments Commission makes this instrument under subsection 741(1) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument [12/0469].

**Commencement**

3. This instrument commences on 13 April 2012.

**Declaration**

4. Chapter 6D of the Act applies to Kingform Health Hometextile Group Limited ACN 153 801 766 (the *Issuer*) as if Part 6D.2 were modified or varied as follows:
  - (a) omit paragraph 723(3)(b), substitute:
    - “(b) the securities are not admitted to quotation within 3 months after the later of:
      - (i) the date of the disclosure document; and
      - (ii) the date of the latest supplementary disclosure document for the offer lodged with ASIC which:
        - (A) discloses that the securities are not admitted to quotation; and
        - (B) gives applicants 1 month to withdraw their application and be repaid”;





Corporations Act 2001 - Paragraph 601QA(1)(b) - Declaration**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 12-0471.

**Commencement**

3. This instrument commences on 13 April 2012.

**Declaration**

4. Chapter 5C of the Act applies to The Trust Company (Australia) Limited ACN 000 000 993 in its capacity as the responsible entity of the Green Triangle Forest Operating Trust ARSN 156 005 677 (*Trust 1*) and the Green Triangle Forest Investment Trust ARSN 156 005 604 (*Trust 2*) as if the following provisions of that Chapter were modified or varied:

- (a) after section 601FE insert:

**“601FEA      Modification of duties: stapled securities**

- (1) This section applies to a registered scheme where the interests in the scheme and interests in another registered scheme are components of stapled securities.
  - (2) For the purposes of paragraphs 601FC(1)(c) and 601FD(1)(c), an obligation to act in the best interests of the members of the scheme is an obligation to act in the best interests of the members of the scheme having regard to their interests as members of both schemes.
  - (3) For the purposes of paragraphs 601FC(1)(e), 601FD(1)(d) and 601FD(1)(e), and subsection 601FE(1), an obligation to not make use of information, or not make improper use of position, in order to cause detriment to the members of the scheme is an obligation not to do those things in order to cause detriment to the members of the scheme having regard to their membership of both schemes.”;
-

- (b) in section 601GAA as notionally inserted by ASIC Class Order [CO 05/26]:
- (i) in subsection (1) omit “subsections (2) to (8).”, substitute “subsections (2) to (8) and (9A).”;
  - (ii) after subsection (9) insert:

“(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:

    - (a) the constitution makes provision for the issue price of stapled securities;
    - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests in the scheme;
    - (c) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the constitution;
    - (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.”;
- (c) after subsection 208(2) as notionally inserted by section 601LC, insert:
- “(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if all the following conditions are satisfied:
- (a) the benefit either:
    - (i) is given out of the scheme property of a registered scheme; or
    - (ii) could endanger the scheme property;
  - (b) all of the interests in the scheme and all of the interests in another registered scheme are components of stapled securities;
  - (c) the benefit is given by:

- (i) the responsible entity of the scheme; or
  - (ii) an entity that the responsible entity controls; or
  - (iii) an agent of, or person engaged by, the responsible entity;
- (d) the benefit is given to:
- (i) an entity wholly owned, whether directly or indirectly, by the scheme; or
  - (ii) the other scheme or an entity that is wholly owned, whether directly or indirectly, by the other scheme; or
  - (iii) an entity wholly owned, whether directly or indirectly, jointly by the scheme and the other scheme.

(2B) For the purposes of this section:

- (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.”;

(d) insert after section 601PC:

**“601PD      Stapled securities**

For the purposes of this Chapter:

*stapled securities* means two or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and

- (b) there are no financial products in the same class as those financial products which may be transferred separately.”.

**Where this declaration applies**

4. This declaration applies where each interest in Trust 1 must, under the terms upon which it is to be traded, only be transferred with each interest in Trust 2.

**Where this declaration ceases to apply**

5. This declaration ceases to apply if:
- (a) a component of a Stapled Security is issued which on the terms on which it is to be traded, can be transferred separately without also transferring any other component; or
- (b) interests in any class other than the class of interests in Trust 1 and Trust 2 that are already on issue as at the date of this instrument are issued.

**Interpretation**

6. In this instrument:

*Stapled Security* means an interest in Trust 1 and an interest in Trust 2 which, under the terms on which each is to be traded, must be transferred together.

**Exemption**

4. Living and Leisure Australia Management Limited ACN 101 634 315 (*LLAML*) as responsible entity for the Living and Leisure Australia Trust ARSN 092 701 589 (*LLAT*) is exempt from complying with Part 5C.5 of the Act, except sections 601JF and 601JG.

**Where this instrument applies**

5. This instrument applies where:
  - (a) *LLAML* has made an application for deregistration of *LLAT* under the Act; and
  - (b) *LLAT* is deregistered by ASIC no later than 30 June 2012.

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 601QA(1) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 12-0480.

**Exemption**

3. ASIC exempts Australian Unity Funds Management Limited ACN 071 497 115 (*AUFM*) in its capacity as the responsible entity of the following registered schemes (each, a *Scheme*):
  - (a) Australian Unity High Yield Mortgage Trust ARSN 113 151 705; and
  - (b) Australian Unity Wholesale High Yield Mortgage Trust ARSN 113 151 947,
 from paragraph 601FC(1)(d) of the Act in relation to allowing AUFM to pay some or all of the net proceeds of the winding up of each Scheme to members.

**Where this instrument applies**

4. The constitution of the Scheme allows AUFM to pay some or all of the net proceeds of winding up of the Scheme to a member.
5. AUFM is satisfied that:
  - (a) the member has experienced hardship or is likely to experience hardship if the member is not paid their entitlement to the net winding up proceeds on a preferential basis; or
  - (b) where the member is an operator—a person (*instructor*) who has asked the operator to request AUFM to pay the instructor's entitlement to the net winding up proceeds on a preferential basis has experienced hardship or is likely to experience hardship if the payment is not made on a preferential basis; or
  - (c) where the member is dead—a beneficiary of the estate has experienced hardship or is likely to experience hardship if the executor or administrator of the estate is not allowed to receive the payment of the entitlement to the net winding up proceeds on a preferential basis.
6. A decision by AUFM to allow a hardship payment is based on the following criteria and conditions:

|   | <u>Hardship<br/>Withdrawal Criteria</u> | <u>Condition</u>   |

| 1 | Severe Financial Hardship               | The amount requested is needed to enable the person to meet reasonable and immediate living expenses for themselves and/or their dependants. |

| 3 | Compassionate Grounds | <p>The amount requested is needed by the person (and/or the person's dependant):</p> <p>(a) to help pay for medical costs (and transport costs) required to treat a life-threatening illness or injury, to alleviate acute or chronic pain, or to alleviate an acute or chronic mental disturbance where 2 registered medical practitioners (at least one of whom must be a specialist) have provided certified statements confirming the medical condition to this effect;</p> <p>(b) to fund specific modifications (to a principal place of residence or vehicle) that are necessary to accommodate special needs arising from a severe disability;</p> <p>(c) to assist with funeral and other expenses related to the death of the person or the person's dependants;</p> <p>(d) to enable the person to provide care for another person who is dying from a terminal illness, including home care;</p> <p>(e) to prevent the person's mortgagee (lender) from selling the person's principal place of residence;</p> <p>(f) to meet a binding financial obligation entered into by the person prior to AUFM's decision to terminate the Scheme; or</p> <p>(g) to meet expenses in other cases consistent with grounds mentioned in paragraphs (a) to (f),</p> <p>where the person does not otherwise have the financial capacity to meet the expense.</p> |
| 4 | Permanent Incapacity  | Where the person has ceased gainful employment by reason of mental or physical ill-health and the responsible entity is satisfied that the person is unlikely ever again to engage in gainful employment of the type for which the person is reasonably qualified by education, training or experience.   |

7. AUFM must not allow a hardship payment to be made unless AUFM is satisfied that:

- (a) following that payment, the scheme property would include sufficient liquid assets to enable AUFM to satisfy its obligations under the constitution of the Scheme in relation to the winding up of the Scheme; and
- (b) satisfying the request for a hardship payment:
  - (i) would not result in more than 4 hardship payments for any member, instructor or beneficiary (as applicable) in any calendar year; and
  - (ii) would not result in the total amount of hardship payments for any member, instructor or beneficiary (as applicable) in any calendar year exceeding \$100,000; and
- (c) any hardship payment would not exceed the specific amount the subject of the request for payment in respect of the hardship of the member, instructor or beneficiary (as applicable); and
- (d) where subparagraph (5)(b) applies - any hardship payment to an operator will be paid to the instructor after deduction of any fees and charges payable to the operator; and
- (e) where subparagraph (5)(c) applies - any hardship payment to an executor or administrator of the estate will be paid to the beneficiary after deduction of any fees and charges payable to the executor or administrator.

#### Conditions

- 8. If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship payment:
  - (a) AUFM or its nominee must act reasonably in exercising a discretion covered by paragraph (6);
  - (b) AUFM must ensure that the records which it keeps under section 988A of the Act document how and why a decision to permit or refuse a request for a hardship payment; and
  - (c) AUFM must retain the documents covered by subparagraph (8)(b) for 7 years after they cease to be current.

#### Revocation

- 9. ASIC Instrument 09-00847 is revoked to the extent it applies to the Schemes.

#### Interpretation

In this instrument:

*another person*, when used in paragraph (d) of item 3 in the table in paragraph (6), means any natural person;


*hardship payment* means a payment by AUFM of some or all of the net proceeds of winding up a Scheme to a person in priority to other members of the Scheme where AUFM is satisfied that one of subparagraphs (a), (b) or (c) of paragraph (5) of this instrument applies;

*operator* means a person who is a member of a Scheme in its capacity as responsible entity or custodian of a registered scheme, a life company, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the *Superannuation Industry (Supervision) Act 1993*, trustee of a self-managed superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* or provider or acquirer in relation to a custodial arrangement as defined in section 10121A; and

*person* means:

- (a) a member of a Scheme;




