## Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(b) – Declaration

## **Enabling legislation**

The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraph 601QA(1)(b) of the Corporations Act 2001 (the
Act).

#### Title

This instrument is ASIC Instrument 12-0505.

#### Commencement

This instrument commences on 8 May 2012.

#### Declaration

- 4. Chapter 5C of the Act applies to Bodiam RE Limited ACN 145 968 574 (Bodiam RE) in its capacity as the responsible entity of the IEF Real Estate Entertainment Group ARSN 108 982 627 (IEF) as if section 601GAA as notionally inserted into the Act by ASIC Class Order [CO 05/26] were modified or varied as follows:
  - in paragraph 601GAA(3)(h), after "subsection (12A)"", insert "or subsection (12AA)"; and
  - (b) after subsection 601GAA(12A), insert:
    - "(12AA) For the purposes of subsection (3), the responsible entity may issue interests to an associate as an underwriter where the issue is made under an underwriting agreement between the responsible entity and the associate that is entered on terms that are no more favourable to the associate than terms that would be reasonable in the circumstances if the responsible entity and the associate were dealing at arm's length."

#### Where this instrument applies

3 This instrument commences on 24 April 2012.

## Declaration

- ASIC declares that Chapter 5C of the Act applies to APN Funds Management Limited ACN 080 674 479 in its capacity as responsible entity of the APN Property for Income Fund ARSN 090 467 208 and APN Property for Income Fund 2 ARSN 113 296 110 (collectively, the Schemes) (APN) until the earlier of 24 April 2017 or each of the Schemes becomes liquid as if Part 5C.6 of the Act were modified or varied as follows:
  - in subsection 601KB(1), after 'that particular assets are available and able to be converted to money' insert ', or that particular assets are available to be distributed,';
  - (b) in paragraph (c) subsection 601KB(3), after 'those assets' insert 'that will be converted to money in time to satisfy withdrawal requests that members may make in response to the offer'.

## Where this instrument applies

- 5 APN makes a withdrawal offer for each of the Schemes where:
  - (a) the withdrawal offer is made on terms set out in the Offer Document;
  - (b) a withdrawal request made in response to the withdrawal offer is satisfied, for each interest, by:
    - payment of a cash amount equal in value to the percentage of liquid assets in the Scheme multiplied by the Scheme's withdrawal price on the relevant calculation date; and

- (ii) a transfer of units in the APN Unlisted Property Fund ARSN 156 183 872 (APN UPF), equal in value to the percentage of illiquid assets in the Scheme multiplied by the Scheme's withdrawal price on the relevant calculation date;

## Interpretation

In this instrument:

Offer Document means a document that is substantially the same as the draft document entitled 'APN Property for Income Fund Withdrawal Offer' that was provided to ASIC on 24 April 2012.

**product disclosure statement** means the draft product disclosure statement for the APN UPF which is substantially the same as that provided to ASIC on 24 April 2012.

withdrawal price means an amount that will be paid to a member upon withdrawal of an interest.

The following terms have a meaning given by the Act:

- interest,
- liquid assets,
- liquid schemes,

- managed investment scheme,
- member,
- product disclosure statement,
- registered scheme.

## Australian Securities and Investments Commission Corporations Act 2001 - Paragraphs 741(1)(a), 911A(2)(1), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) - Exemptions

- Under paragraphs 741(1)(a) and 1020F(1)(a) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) exempts the following persons:
  - (a) the Issuer; and
  - (b) the Plan Trustee

from Parts 6D.2 and 6D.3 (except section 736) and Part 7.9 of the Act where the person:

- (c) makes an eligible offer; or
- (d) offers to arrange for the issue of financial products under an eligible offer; or
- (e) issues a financial product under an eligible offer; or
- (f) issues a financial product on the vesting of a Performance Right that was issued under an eligible offer,

on the conditions set out in the Schedule and for so long as the conditions are met.

- 2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
  - (a) a recommendation is made (by a person other than the Issuer or the Plan Trustee) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
  - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
- 3. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 4. Under paragraph 911A(2)(1) of the Act, ASIC exempts:
  - (a) the Issuer; and
  - (b) a related body corporate of the Issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or an associate) occurs either:
  - through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
  - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

#### Schedule

The following conditions apply:

- the Issuer must ensure that the eligible offer is substantially on the terms set out in the draft general terms of the Plan provided to ASIC as an attachment to an electronic mail dated 30 April 2012; and
- 2. the Issuer must:
  - (a) include the offer in an offer document; and
  - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
  - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and

- 4. the Company must take reasonable steps to ensure that the number of shares to be issued on the vesting of a Performance Right when aggregated with:
  - (a) the number of shares in the same class which would be issued were:
    - each outstanding offer with respect to Performance Rights made under the Plan to be accepted and the Performance Rights to have vested; and
    - each outstanding offer with respect to shares, units of shares and options to acquire unissued shares under any other employee share scheme to be accepted or exercised; and
  - (b) the number of shares in the same class issued during the previous 5 years under:
    - (i) the Plan where the Performance Rights issued under the Plan have vested; and
    - (ii) any other employee share scheme extended only to eligible employees,

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Company as at the time of the offer; and

- 5. in the case where an offer of stapled securities is made through a trust:
  - (a) the Plan Trustee must hold the stapled securities on trust for each person (a beneficiary) who acquires equitable interests in stapled securities under an eligible offer; and
  - (b) the Plan Trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the Plan Trustee or a place of business of the Issuer during normal business hours or such other time as is agreed with beneficiaries; and

- (c) the Plan Trustee must ensure that each stapled security in relation to which a beneficiary holds an equitable interest is identified in the written financial records as being held on account of that beneficiary; and
- (d) the Plan Trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
- (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the Plan Trustee to sell at or above the current market price the stapled securities to which he or she is entitled to under the deed; and
- (f) the Plan Trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
- (g) the Issuer must ensure that the trust deed contains covenants binding the Plan Trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the stapled securities in which they hold an equitable interest as if they were the legal owner of the stapled securities, including the right to:
  - direct the Plan Trustee how the voting rights attaching to the stapled securities shall be exercised, either generally or in any particular case; and
  - (ii) receive the income deriving from the stapled securities, including dividends and distributions declared by the Issuer in respect of those stapled securities.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts Interpretation Act 1901.

#### Interpretation

In this instrument:

- except where otherwise stated, references to provisions are to provisions of the Act; and
- the Plan or any other employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee; and
- 3. associated body corporate of the Issuer means:
  - (a) a body corporate that is a related body corporate of the Issuer; or
  - (b) a body corporate that has voting power in the Issuer of not less than 20%; or

- (c) a body corporate in which the Issuer has voting power of not less than 20%; and
- 4. ASX means the market operated by ASX Limited (ACN 008 624 691).
- Australian dollar equivalent in relation to a price, means a price calculated by
  reference to the relevant exchange rate published by an Australian bank no earlier
  than the business day before the day to which price relates; and
- 6. Company means Westfield Holdings Limited ACN 001 671 496; and
- current market price means, in relation to a stapled security, the price published
  by the ASX on which the stapled security is quoted as the final price for the
  previous day on which the stapled security was traded on that financial market;
  and
- eligible employee means a person who is, at the time of an eligible offer, a full or
  part-time employee or director of the Company or of an associated body corporate
  of the Company; and
- 9. *eligible offer* means an offer for the issue of a Performance Right that is made under the Plan; and
- 10. financial product advice has the meaning given by section 766B of the Act; and
- 11. general advice has the meaning given by section 766B of the Act; and
- 12. Issuer means the Company, Westfield America Management Limited ACN 072 780 619 as responsible entity of Westfield America Trust, and Westfield Management Limited ACN 001 670 579 as the responsible entity of Westfield Trust; and
- 13. market price means, as at any date, in relation to a stapled security, the volume weighted average of the price of stapled securities traded on the ASX over the 10 ASX trading days immediately preceding the date on which the market price is to be calculated or if no trading of stapled securities occurred during such period, the last price of a stapled security published by the ASX; and
- 14. offer has a meaning affected by sections 700, 702 and 1010C of the Act; and
- 15. offer document means a document setting out an offer under the Plan that:
  - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
  - (b) if a summary (rather than a copy) of the rules of the Plan is given includes an undertaking that during the period (the offer period) during which an eligible employee may acquire the financial products offered under the Plan, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and

- (c) specifies in respect of the stapled securities that may be acquired on the vesting of a Performance Right:
  - (i) the acquisition price in Australian dollars; or
  - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
  - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which, the Issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
  - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of stapled securities of the same class as those that will be acquired by the eligible employee when the Performance Right offered to the eligible employee vests; and
  - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and

Westfield Employee Share Plan Trust means a trust established by the Company under the Westfield Performance Rights Plan Trust Deed where the terms of the trust are substantially in the terms set out in the draft general terms of the Westfield Performance Rights Plan Trust provided to ASIC as an attachment to an electronic mail dated 30 April 2012; and
- Westfield America Trust means the Westfield America Trust ARSN 092 058 449;
   and
- 23. Westfield Trust means Westfield Trust ARSN 090 849 746.

## **Enabling legislation**

The Australian Securities and Investments Commission (ASIC) makes this

1020F(1)(b) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument 12-0590.

#### Commencement

This instrument commences on the date of gazettal.

## Exemption

- GR Engineering Services Limited ACN 121 542 738 (the issuer) does not have to comply with:
  - (a) Parts 6D.2 and 6D.3 (except section 736) of the Act where the issuer makes an offer for the issue of Performance Rights and Share Appreciation Rights under the Plan;
  - (b) Part 7.9 of the Act where the issuer:
    - makes an offer, issues or offers to arrange for the issue of Performance Rights and Share Appreciation Rights under the Plan; or
    - (ii) makes a recommendation to acquire Performance Rights and Share Appreciation Rights under the Plan;
  - (c) the requirement to hold an Australian financial services licence under subsection 911A(1) of the Act for:
    - (i) the provision of a financial service consisting of general advice reasonably given in connection with an offer under the Plan (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only;

- (ii) the provision of a custodial or depository service in connection with an offer under the Plan where the issuer or wholly-owned subsidiary of the issuer performs their duties in good faith and has sufficient resources to perform those duties;
- (iii)dealing in financial product in the course or providing a custodial or depository service covered by subparagraph (ii); and
- (iv)dealing in a financial product in connection with an offer under the Plan where any acquisition by purchase or disposal of the product (by the issuer or a related body corporate) occurs either:
  - through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
  - (B) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place; and
- (d) sections 736 and 992A of the Act in relation to an offer under the Plan made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
- Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an offer covered by paragraph 4 from Part 7.9 of the Act where:
  - (a) a recommendation is made that a person to whom such an offer has been made, acquire the financial product as a retail client; and
  - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in this instrument have not been met.

## Where this instrument applies

- 6. This instrument applies where the issuer:
  - (a) meets the requirements (including, for the avoidance of doubt, definitions) of ASIC Class Order [CO 03/184] (the class order) as in force on the date of this instrument and as amended from time to time by a disallowable legislative instrument within the meaning of the Legislative Instrument Act 2003, except the definition of:
    - (i) 'eligible employee' in paragraph 8 of the Interpretation, and
    - (ii) 'eligible offer' in paragraph 9 of the Interpretation, and

## (iii)'offer document' in paragraph 15 of the Interpretation; and

- (b) would meet the requirements of the class order if the definition of an 'eligible employee' in paragraph 8 of the Interpretation was to read:
  - "8." eligible employee" means, in relation to the issuer, a person who is at the time of an offer under the Plan:
  - (a) a full or part-time employee of the issuer or of an associated body corporate of the issuer; or
  - (b) a director of the issuer, or of an associated body corporate of the issuer, who holds a salaried employment or office in the issuer or in a related body corporate; or
  - (c) a contractor which is:
    - (i) an individual that has:
      - (A) performed work for the issuer, or a related body corporate of the issuer, for more than 12 months; and
      - (B) received 80% or more of their income in the preceding year from the issuer or a related body corporate of the issuer; or
    - (ii) a company where each of the following are satisfied in relation to the company:
      - (A) throughout the previous 12 months, the company has had a contract in place with the issuer, or a related body corporate of the issuer, for the provision of the services of an individual (the contracting individual) to the issuer;
      - (B) the contracting individual has performed work for the issuer, or a related body corporate of the issuer, for more than 12 months;
      - (C) the contracting individual has been the only member of the company for more than 12 months; and
      - (D) more than 80% of the aggregate income of the company and the contracting individual from all sources (other than from each other) in the preceding 12 months was received

from the issuer or a related body corporate of the issuer;

- (d) a casual employee who:
  - (i) has been in employment with the issuer or an associated body corporate of the issuer for more than 12 months; and
  - (ii) the issuer or the associated body corporate of the issuer regards as equivalent to either a full or part-time employee."; and
- (c) would meet the requirements of the class order if the definition of an 'eligible offer' in paragraph 9 of the Interpretation was to read:
  - "9. "eligible offer" means an offer for issue or sale of:
    - (a) fully-paid shares in an issuer in the same class as shares which have been quoted on the ASX throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; or
    - (b) performance rights in relation to shares referred to in paragraph (a), made under an employee share scheme extended only to eligible employees of the issuer; or
    - (c) share appreciation rights in relation to shares referred to in paragraph(a), made under an employee share scheme extended only to eligible employees of the issuer;" and
- (d) would meet the requirements of the class order if, in the definition of an 'offer document' in paragraph 15 of the Interpretation, subparagraphs 15(c) and (d) were to read:
  - "(c) specifies in respect of the performance rights and share appreciation rights or the shares to which the performance rights and share appreciation rights relate:
    - (i) the acquisition price in Australian dollars;
    - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the eligible offer; or
    - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were the formula applied at the date of the eligible offer; and

- (d) includes an undertaking, and an explanation of the way in which, the issuer who has a registered office in this jurisdiction will, during the period which an eligible employee may acquire the shares, within a reasonable period of the employee requesting, make available to the employee:
  - the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of the shares to which the performance rights and share appreciation rights relate; and
  - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that subparagraph as updated to that date."; and
- (e) would meet the requirements of the class order if, in the Interpretation, the following definitions were inserted:
  - "16A."performance right" means a right to subscribe for and/or acquire one fully paid ordinary share in the capital of an issuer, where no consideration is payable for the exercise of the right to subscribe for and/or acquire such a share.
  - 16B. "share appreciation right" means a right to receive a future issue or transfer of a fully paid ordinary share in the capital of the issuer that is calculated by reference to the performance of the market price of such a share."

#### Conditions

7. The issuer must comply with the conditions of the class order.

## Interpretation

8. In this instrument:

ASX means the financial market operated by ASX Limited ACN 008 624 691.

**Plan** means the GR Engineering Services Limited Equity Incentive Plan, the terms of which are substantially in the same form as those provided to ASIC on 4 April 2012.

**Performance Right** means a right to subscribe for and/or acquire one share on the terms set out in the Plan, where no consideration is payable for the exercise of the right to subscribe for and/or acquire a share.

**Share Appreciation Right** means a right to receive a future issue or transfer of a share that is calculated by reference to the performance of the market price of the share on the terms set out in the Plan.

  - i. sub-section 707(1) were modified by omitting ", (3)"; and
  - ii. sub-sections 707(3) and (4) were omitted.
- 5. Part 7.9 of the Act applies to:
  - Westfield Management Limited ACN 001 670 579 (WML), as the responsible entity of Westfield Trust ARSN 090 849 746 (WT);
  - Westfield America Management Limited ACN 072 780 619 (WAML), as the responsible entity of Westfield America Trust ARSN 092 058 449 (WAT); and
  - c. a holder of an interest in WAT and an interest in WAML,

as if:

- i. paragraphs 1012C(3)(b) and (4)(c) were modified by omitting ", (6)"; and

Plan Trustee means Amondi Pty Limited ACN 087 465 763 as trustee of the Westfield Employee Share Plan Trust or a related body corporate of WHL appointed as trustee of the Westfield Employee Share Plan Trust in accordance with the rules of the Plan; and

stapled security means a share in WHL, an interest in the WAT, and an interest in WT which, under the terms on which each is to be traded, must be transferred together; and

Westfield Employee Share Plan Trust means a trust established by WHL under the Westfield Performance Rights Plan Trust Deed where the terms of the trust are substantially in the terms set out in the draft general terms of the Westfield Performance Rights Plan Trust provided to ASIC as an attachment to an electronic mail dated 30 April 2012.
