# Australian Securities and Investments Commission Corporations Act 2001 –Paragraph 655A(1)(b) – Declaration

#### **Enabling legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this declaration under paragraph 655A(1)(b) of the Corporations Act 2001 (Act).

# Title

2. This instrument is ASIC Instrument 12-0678.

#### Commencement

3. This instrument commences on 28 May 2012.

#### **Declaration**

4. Chapter 6 of the Act applies to Alesco Corporation Limited ACN 008 666 064 (**Target**) as if items 11 and 12 of the table in subsection 633(1) of the Act where modified by omitting the words:

"no later than 15 days after the target receives a notice that all offers have been sent as required by item 6"

and replacing them with:

"no later than whichever occurs last out of 12 June 2012 and the date which is 15 days after the target receives a notice that all offers have been sent as required by item 6".

# Where this declaration applies

5. This declaration applies to an off-market takeover bid made by DuluxGroup (Nominees) Pty Limited ACN 156 611 540 for all of the ordinary shares in Target in respect of which a bidder's statement was lodged with ASIC on 10 May 2012 where, within one day of the commencement of this instrument, the Target makes an announcement to the Australian Stock Exchange about the effect of this modification and includes a recommendation that shareholders should take no action until they have considered the target's statement.

# Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(a), 911A(2)(1) and 1020F(1)(a) – Exemption

# **Enabling Legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 601QA(1)(a), 911A(2)(1) and 1020F(1)(a) of the Corporations Act 2001 (Act).

#### Title

2. This instrument is ASIC Instrument 12/0689.

#### Commencement

3. This instrument commences on gazettal.

#### **Exemptions**

- 4. Yancoal Australia Limited ACN 111 859 119 (Yancoal), Gloucester Coal Ltd ACN 008 881 712 (Gloucester) and the Broker do not have to comply with:
  - a. section 601ED of the Act in relation to a Gloucester Scheme Sale Facility;
  - b. Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in a Gloucester Scheme Sale Facility; and
  - c. the requirement to hold an Australian financial services licence for the provision of the following financial services:
    - (i) dealing in an interest in a Gloucester Scheme Sale Facility; and
    - (ii) the provision of general advice in relation to an interest in a Gloucester Scheme Sale Facility.
- 5. To avoid doubt, to the extent Yancoal, Gloucester or the Broker invites a holder of a share in Gloucester to make an offer to sell Yancoal Security through a Gloucester Scheme Sale Facility, Yancoal, Gloucester and Broker do not have to comply with Division 5A of Part 7.9 of the Act.

# Where this instrument applies

- 6. The exemptions under paragraphs 4 and 5 apply in relation to a Gloucester Scheme Sale Facility where that facility satisfies all of the following:
  - a. the financial products that may be sold through a Gloucester Scheme Sale Facility are Yancoal Securities that are admitted to quotation on the Licensed Market

operated by the ASX; and

- b. under the terms of a Gloucester Scheme Sale Facility:
  - (i) the Yancoal Securities to be sold through the Gloucester Scheme Sale Facility are pooled; and
  - (ii) the Broker sells the Yancoal Securities in the ordinary course of trading on the Licensed Market operated by the ASX; and
  - (iii) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by Yancoal and Gloucester) are distributed to participating holders; and
  - (iv) each participating holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the Implementation Date as defined in the Scheme Booklet.

#### Conditions of the relief

- 7. The Scheme Booklet:
  - a. must contain the following statements and information:
    - (i) with respect to the Electing Small Gloucester Shareholder Facility, information about the date by which Electing Small Gloucester Shareholders must make an election to participate in the Electing Small Gloucester Shareholder Facility; and
      - (ii) with respect to the Electing Small Gloucester Shareholder Facility, information about the minimum and maximum number (if any) of Yancoal Securities an Electing Small Gloucester Shareholder can sell through the Electing Small Gloucester Shareholder Facility. With respect to the Ineligible Foreign Gloucester Shareholders Facility, the facility will operate automatically and will apply to all of the Yancoal Securities that the Ineligible Foreign Gloucester Shareholders would otherwise have received as consideration under the Scheme; and
      - (iii) information about any expenses relating to the sale of Yancoal Securities that will be paid by the participating holders; and
      - (iv) a statement to the effect that there is no public market for Yancoal Securities; and
      - (v) a statement of the expected commencement date of official quotation of Yancoal Securities on ASX; and
      - (vi) information about how the proceeds of sale of Yancoal Securities sold through the facility will be allocated between participating holders; and

- (vii) information about any other significant characteristics or features of the Gloucester Scheme Sale Facility or of the rights and obligations of persons who elect to participate in the Electing Small Gloucester Shareholder Facility; and
- (viii) information about any alternatives that the participating holder may have to participating in the Gloucester Scheme Sale Facility.
- b. must be worded and presented in a clear, concise and effective manner; and
- c. may be given in printed or electronic form and, if given in electronic form, must, as far as practicable, be given in a way that will allow the holder to print or save a copy of it; and
- d. may be made up of 2 or more separate documents that are given at the same time and by the same means; and

# Exclusion from reliance

8. Yancoal, Gloucester and the Broker are excluded from relying on subparagraph 4(c) of this instrument if it becomes aware of matters that give it reason to believe that it has failed in a material respect to comply with a condition of this instrument and does not give full particulars of the failure to ASIC in writing within 15 business days after becoming so aware.

#### Interpretation

9. In this instrument:

ASX means the financial market operated by ASX Limited ACN 008 624 691.

**Broker** means the holder of an Australian financial services licence and participating organisation of ASX appointed by Yancoal to sell the Yancoal Securities under the Gloucester Scheme Sale Facility or its affiliated nominee entity.

*Electing Small Gloucester Shareholder* means a Shareholder who holds 200 or fewer shares in Gloucester under the Gloucester Scheme and has validly elected to participate in the Electing Small Gloucester Shareholders Facility.

Electing Small Gloucester Shareholders Facility means a facility provided in connection with the Gloucester Scheme under which the Broker will sell Yancoal Securities that would otherwise have been issued as consideration under the Scheme to Electing Small Gloucester Shareholders with the proceeds of such sales net of expenses (to the extent (if any) that they are not met by Yancoal or Gloucester) being remitted to Electing Small Gloucester Shareholders.

facility has a meaning affected by section 762C of the Act.

Gloucester Scheme means a compromise or arrangement under Part 5.1 of the Act that is between Gloucester and holders of its ordinary shares as described under the Scheme Booklet.

Gloucester Scheme Sale Facility means either the Ineligible Gloucester Shareholders Facility or Electing Small Gloucester Shareholders Facility as described under the Scheme Booklet.

holder has the meaning given by section 761A of the Act.

*Ineligible Gloucester Shareholder* means a Shareholder who is not eligible to be issued Yancoal Securities under the terms of the Gloucester Scheme having regard to the location of their registered address as shown in Gloucester's Register of Members.

Ineligible Gloucester Shareholder Facility means a facility provided in connection with the Gloucester Scheme under which the Broker will sell Yancoal Securities that would otherwise have been issued as consideration under the Scheme to Ineligible Gloucester Shareholders with the proceeds of such sales net of expenses (to the extent (if any) that they are not met by Yancoal or Gloucester) being remitted to Ineligible Gloucester Shareholders.

*Licensed Market* has the meaning given by section 761A of the Act.

participating holder means a person who is either:

- (a) an Ineligible Foreign Shareholder; or
- (b) an Electing Small Gloucester Shareholder.

**Register of Members** means the register of members of Gloucester required to be set up and maintained under section 169 of the Act.

**Scheme Booklet** means the explanatory statement sent to a Shareholder that is substantially in the same form as that registered with ASIC on or about 30 April 2012 which sets out information concerning the Gloucester Scheme.

**Shareholder** means a shareholder in Gloucester as at the record date for determining entitlements to consideration under the Gloucester Scheme.

**Yancoal Security** means a fully paid ordinary share in Yancoal and a CVR share in Yancoal (subject to scale back in accordance with the Gloucester Scheme).

# Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(b) and 1020F(1)(a) – Declaration and Revocation

#### **Enabling legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 601QA(1)(b) and 1020F(1)(a) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument 12-0690.

#### Commencement

3. This instrument commences on 31 May 2012.

# Revocation

4. This instrument revokes ASIC Instrument [06/1139] dated 19 December 2006.

#### Declaration

- 5. Chapter 5C of the Act applies to ING Management Limited ACN 006 065 032 in its capacity as the responsible entity of the ING Real Estate Community Living Fund ARSN 107 459 576 (*ILF Fund*) and the ING Real Estate Community Living Management Trust ARSN 122 928 410 (*ILF Trust*) as if the following provisions of that Chapter were modified or varied:
- (a) after section 601FE insert:

# "601FEA Modification of duties: stapled securities

- (1) This section applies to a registered scheme where the interests in the scheme, interests in another registered scheme (the *stapled scheme*) and shares in a company (the *stapled company*) are components of stapled securities.
- (2) For the purposes of paragraphs 601FC(1)(c) and 601FD(1)(c), an obligation to act in the best interests of the members of the scheme is an obligation to act in the best interests of the members of the scheme having regard to their interests as members of the scheme, of the stapled scheme and of the stapled company.
- (3) For the purposes of paragraphs 601FC(1)(e), 601FD(1)(d) and 601FD(1)(e), and subsection 601FE(1), an obligation to not make use of information, or not make improper use of position, in order to cause

detriment to the members of the scheme is an obligation not to do those things in order to cause detriment to the members of the scheme having regard to their membership of each of the scheme, the stapled scheme and the stapled company.";

- (b) in section 601GAA as notionally inserted by ASIC Class Order [CO 05/26]:
  - (i) in subsection (1) omit "subsections (2) to (8).", substitute "subsections (2) to (8) and (9A).";
  - (ii) after subsection (9) insert:
    - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
      - (a) the constitution makes provision for the issue price of stapled securities;
      - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests in the scheme;
      - (c) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the constitution;
      - (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.";
- (c) after subsection 208(2) as notionally inserted by section 601LC, insert:
  - "(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if all the following conditions are satisfied:
    - (a) the benefit either:
      - (i) is given out of the scheme property of a registered scheme; or
      - (ii) could endanger the scheme property;
    - (b) all of the interests in the scheme, all of the interests in another scheme (the *stapled scheme*) and all of the shares in a company (the *stapled company*) are components of stapled securities;

- (c) the benefit is given by:
  - (i) the responsible entity of the scheme; or
  - (ii) an entity that the responsible entity controls; or
  - (iii) an agent of, or person engaged by, the responsible entity;
- (d) the benefit is given to:
  - (i) an entity wholly owned, whether directly or indirectly, by the scheme; or
  - (ii) an entity wholly owned, whether directly or indirectly, by the stapled scheme; or
  - the stapled company or an entity that is wholly owned, whether directly or indirectly, by the stapled company;
     or
  - (iii) an entity wholly owned, whether directly or indirectly, jointly by the scheme, the stapled scheme and the stapled company.
- (2B) For the purposes of this section:
  - (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the secondmentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
  - (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.";
- (d) insert after section 601PC:

# "601PD Stapled securities

For the purposes of this Chapter:

stapled security means two or more financial products including at least one interest in a registered scheme where under the terms on which each of the products are to be traded, they must be transferred together.".

# Where this declaration applies

6. This declaration applies where each ordinary interest in ILF Fund, each ordinary interest in ILF Trust and each ordinary share in Ingenia Communities Holdings Limited ACN 154 444 925 (*IGCH*), must, under the terms on which each is to be traded, only be transferred together (*Stapled Security*).

# Where this declaration ceases to apply

- 7. This declaration ceases to apply if:
- (a) a component of a Stapled Security is issued which on the terms on which it is traded, can be transferred separately without also transferring any other component of a Stapled Security; or
- (b) any interest in ILF Fund (other than an ordinary interest), any interest in ILF Trust (other than an ordinary interest) or any share in IGCH (other than an ordinary share) is issued.

# **Enabling legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 741(1)(b) and 1020F(1)(c) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument 12-0691.

#### Commencement

3. This instrument commences on 31 May 2012.

#### Declaration

- Chapter 6D of the Act applies to Ingenia Communities Holdings Limited ACN 154 444 925 (*IGCH*) as if that Chapter were modified or varied by omitting paragraph 708(13)(b) and substituting:
  - "(b) an offer of fully-paid shares in a body to 1 or more existing holders of shares in the body, under a plan for the reinvestment of at least one of the following:
    - (i) dividends in respect of shares in the body;
    - (ii) distributions in respect of managed investment products which, under the terms on which they may be traded, must only be transferred together with shares in the body.".
- 5. Part 7.9 of the Act applies in relation to ING Management Limited ACN 006 065 032 in its capacity as the responsible entity of the ING Real Estate Community Living Fund ARSN 107 459 576 (*ILF Fund*) and the ING Real Estate Community Living Management Trust ARSN 122 928 410 (*ILF Trust*) as if paragraph 1012D(3)(b) were modified or varied as follows:
  - (a) omit "either:" and substitute "one or more of the following applies:";
  - (b) in subparagraph (i), omit "or" (second occurring);
  - (c) in subparagraph (ii), omit "facility." and substitute "facility;";
  - (d) after subparagraph (ii), insert:

- "(iii) in a recommendation situation—the advice that constitutes the relevant conduct relates to an offer of managed investment products, under a plan for the reinvestment of at least one of the following:
  - (A) distributions in respect of the managed investment products;
  - (B) dividends in respect of shares in a body which, under the terms on which they may be traded, must only be transferred together with the managed investment products;
- (iv) in an issue situation—the offer or issue that constitutes the relevant conduct is an offer or issue of managed investment products, under a plan for the reinvestment of at least one of the following:
  - (A) distributions in respect of the managed investment products;
  - (B) dividends in respect of shares in a body which, under the terms on which they may be traded, must only be transferred together with the managed investment products.".

# Where this instrument applies

- 6. This declaration applies where:
  - (a) each ordinary interest in ILF Fund, each ordinary interest in ILF Trust and each ordinary share in IGCH, must, under the terms on which each is to be traded, only be transferred together (*Stapled Security*); and
  - (b) an offer or issue of, or recommendation to acquire a component of a Stapled Security is made, under a plan for the reinvestment of dividends in respect of shares in IGCH or distributions in respect of interests in ILF Fund and ILF Trust.

# Where this declaration ceases to apply

- 7. This declaration ceases to apply if:
  - (a) a component of a Stapled Security is issued which on the terms on which it is traded, can be transferred separately without also transferring any other component of a Stapled Security; or
  - (b) any interest in ILF Fund (other than an ordinary interest), any interest in ILF Trust (other than an ordinary interest) or any share in IGCH (other than an ordinary share) is issued.

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 1020F(1)(c) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument 12-0692.

#### Commencement

3. This instrument commences on 31 May 2012.

#### Declaration

- 4. Part 7.9 of the Act applies to ING Management Limited ACN 006 065 032 (IML) in its capacity as the responsible entity of the ING Real Estate Community Living Fund ARSN 107 459 576 (ILF Fund) and the ING Real Estate Community Living Management Trust ARSN 122 928 410 (ILF Trust) as if subsection 1017E(2) as notionally inserted by subregulation 7.9.08(4) of the Corporations Regulations 2001 were modified or varied as follows:
  - (a) at the beginning of paragraph 1017E(2)(b), insert "subject to paragraph (ba),"; and
  - (b) after paragraph 1017E(2)(b), insert:
    - "(ba) any money may be paid into the account, provided that:
      - (i) money paid to acquire the financial product together with any securities or financial products that must, under the terms on which the financial product is to be traded, be transferred with the financial product; and
      - (ii) any other money to which this section applies; and
      - (iii) interest on the amount from time to time standing to the credit of the account,

is identified and held in accordance with all other provisions of this section; and".

#### Where this instrument applies

6. This instrument applies where:

- (a) each ordinary interest in ILF Fund, each ordinary interest in ILF Trust and each ordinary share in Ingenia Communities Holdings Limited ACN 154 444 925 (*IGCH*), must, under the terms on which each is to be traded, only be transferred together (*Stapled Security*); and
- (b) IML receives money paid to acquire Stapled Securities.

# Where this declaration ceases to apply

- 7. This declaration ceases to apply if:
  - (a) a component of a Stapled Security is issued which on the terms on which it is traded, can be transferred separately without also transferring any other component; or
  - (b) any interest in ILF Fund (other than an ordinary interest), any interest in ILF Trust (other than an ordinary interest) or any share in IGCH (other than an ordinary share) is issued.

#### Title

2. This instrument is ASIC Instrument 12-0693.

#### Commencement

This instrument commences on 31 May 2012.

#### Exemption

4. ING Management Limited ACN 006 065 032 (IML) in its capacity as the responsible entity of the ING Real Estate Community Living Fund ARSN 107 459 576 (ILF Fund) and the ING Real Estate Community Living Management Trust ARSN 122 928 410 (ILF Trust), does not have to comply with paragraph 601FC(1)(d) of the Act, to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests of the same class equally.

#### Where this instrument applies

- 5. IML determines that Excluded Foreign Securityholders will be required to participate in the Sale Facility and will not be offered and issued shares in Ingenia Communities Holdings Limited ACN 154 444 925 (*IGCH*), under the Proposal;
- 6. IML reasonably concludes and documents its conclusions in writing that:
  - (a) either:
    - (i) it is unlawful (under the laws of the relevant foreign jurisdiction) to offer and issue Excluded Foreign Securityholders shares in IGCH; or
    - (ii) it is unduly onerous for IGCH to offer and issue Excluded Foreign Securityholders shares in IGCH having regard to:
      - (A) the number of members in that jurisdiction;
      - (B) the number and value of the interests held by members in that jurisdiction; and
      - (C) the cost of and process for seeking advice as to the requirements for doing so in relation to those jurisdictions and/or the cost of

complying with legal requirements and the requirements of any relevant regulatory authority applicable to making the offer of, or issuing the shares in IGCH in that jurisdiction; and

- (b) having regard to the rights and interests of all members of ILF Fund and ILF Trust it would be in the best interests of all members of ILF Fund and ILF Trust to determine that Excluded Foreign Securityholders will be required to participate in the Sale Facility and will not be offered and issued shares in IGCH under the Proposal;
- 7. as at the close of trading on ASX on 29 February 2012, the Stapled Securities held by Excluded Foreign Securityholders comprise no more than 2.05% of all Stapled Securities on issue.

#### Interpretation

8. In this instrument:

ASX means the financial market operated by ASX Limited ACN 008 624 691.

**Excluded Foreign Securityholder** means a holder of a Stapled Security whose address in the register of members of the ILF Trust and ILF Fund is a place outside Australia (and its external territories), New Zealand and Hong Kong as at the Record Date.

Explanatory Memorandum means the notice of meeting and explanatory statement dated 26 April 2012 in respect of the Proposal.

facility has a meaning affected by section 762C of the Act.

**New Stapled Security** means an ordinary interest in ILF Fund, an ordinary interest in ILF Trust and an ordinary share in IGCH, which must, under the terms on which each is to be traded, only be transferred together.

**Proposal** means the proposal under which shares in IGCH are to be issued to members of ILF Fund and ILF Trust, which if approved, would result in each holder of a Stapled Security becoming a holder of a New Stapled Security.

Record Date means 1 June 2012.

register of members means the register of members required to be set up and maintained under section 169 of the Act.

Sale Facility means a facility described in the Explanatory Memorandum through which an Excluded Foreign Securityholder transfers its Stapled Securities to RBS Morgans Limited ACN 010 669 726 (RBS) or Berne No. 132 Nominees Pty Ltd ACN 010 413 591 (BNPL), and, following implementation of the Proposal, RBS or BNPL sells the New Stapled Securities the Excluded Foreign Securityholder would otherwise have been entitled to hold under the Proposal.

Stapled Security means an ordinary interest in ILF Fund and an ordinary interest in ILF Trust, which must, under the terms on which each is to be traded, only be transferred together.

- 4. (a) ING Management Limited ACN 006 065 032 (*IML*) in its capacity as the responsible entity of the ING Real Estate Community Living Fund ARSN 107 459 576 (*ILF Fund*) and the ING Real Estate Community Living Management Trust ARSN 122 928 410 (*ILF Trust*);
  - (b) RBS Morgans Limited ACN 010 669 726 (RBS); and
  - (c) Berne No. 132 Nominees Pty Ltd ACN 010 413 591(*BNPL*),

do not have to comply with:

- (d) section 601ED of the Act in relation to the Sale Facility;
- (e) Divisions 2 to 4 of Part 7.9 of the Act in relation to an interest in the Sale Facility; and
- (f) the requirement to hold an Australian financial services licence for the provision of the following financial services:
  - (i) dealing in an interest in the Sale Facility; and
  - (ii) the provision of general advice in relation to an interest in the Sale Facility.

- (ii) a statement that the market price of New Stapled Securities is subject to change from time to time; and
- (iii) information about how to obtain up-to-date information on the market price of New Stapled Securities; and
- (iv) information about any expenses relating to the sale of New Stapled Securities that will be paid by the Excluded Foreign Securityholders; and
