**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraphs 911A(2)(l) and 1020F(1)(a) – Exemptions**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001 (Act)*.

**Title**

2. This instrument is ASIC Instrument 12-0392.

**Commencement**

3. This instrument commences on 1 July 2012.

**Exemptions**

4. Austbrokers AEI Transport Pty Limited ACN 123 670 002 (the *Issuer*) is exempted from Part 7.9 of the Act where the Issuer:

(a) makes an eligible offer; or

(b) issues a financial product under an eligible offer,

on the conditions set out in this instrument and for so long as the conditions are met.

5. The Issuer is exempted under paragraph 911A(2)(l) of the Act from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 4 of this instrument (including any general advice given in the Licensing Agreement) where the Licensing Agreement, or a document given with the Licensing Agreement for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that Eligible Employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
6. The Issuer is exempted from the requirement to hold an Australian financial services licence for the provision of the financial services consisting of dealing in a financial product in connection with an eligible offer covered by paragraph 4 of this instrument.

**Conditions**

The following conditions apply:

7. The Issuer must ensure that the eligible offer is on the terms set out in the Licensing Agreement;
8. The Issuer must ensure it provides to the Licensee information in relation to the value of the Portfolio as specified in the Licensing Agreement; and
9. The Issuer must ensure upon termination of the Licensing Agreement, the Licensee is paid under the Licensing Agreement an amount no less than the amount of the consideration the Licensee paid to enter into the Licensing Agreement.

**Interpretation**

In this instrument:

*eligible offer* means an offer for a licence or financial products made under the Licensing Agreement.

*Financial products* has the meaning given by Division 3 Part 7.1 of the Act.

*financial product advice* has the meaning given by section 766B of the Act.

*general advice* has the meaning given by section 766B of the Act.

*Licensee* is the person named in the Licensing Agreement who is a senior account manager employed by the Issuer.


*Licensing Agreement* means an agreement to be entered into on 1 July 2012 by the Issuer and the Licensee, that:

- (a) details the consideration (licence fee), including how it is calculated, that the Licensee must pay to enter into the Licensing Agreement;
- (b) specifies the circumstances in which the Issuer will buy back the licence, the price, including how it is calculated, the Issuer will pay the Licensee to buy back the licence and date of payment;
- (c) specifies that the Issuer will value the Portfolio and give financial information about the Portfolio to the Licensee at least on an annual basis or as requested by the Licensee. If the Licensee makes such a request, the Issuer will provide the information within 10 business day of the licensee making that request; and
- (c) contains the same terms as the document entitled "Portfolio Licence Agreement" provided to ASIC on 23 May 2012.

*Portfolio* means a portfolio within the Issuer's business identified by an Issuer and specified under a schedule that forms part of the Licensing Agreement, being a portfolio that the revenue is dependent on the Licensee.




