#### Title

1. This instrument is Australian Securities and Investments Commission (*ASIC*) Instrument 10-0469.

#### **Declarations**

- 2. Under paragraphs 926A(2)(c) and 951B(1)(c) of the *Corporations Act* 2001 (the *Act*), ASIC declares that Part 7.6 (other than Divisions 4 and 8) and Part 7.7 of the Act apply to the persons specified in Schedule A in the case set out in Schedule B as if subsection 761G(7) of the Act were modified by inserting after paragraph 761G(7)(a) the following:
  - "(aa) the financial product is, or the financial services relate to a financial product that is, an interest in a managed investment scheme where all offers of interests in the scheme have only been made to persons who:
    - (i) own or have agreed to purchase an interest in real property in connection with the scheme purchased for an amount; or
    - (ii) are being offered an interest in real property in connection with the scheme for an amount,

of not less than \$500,000 (which amount may include any amounts paid for any associated chattels, costs and expenses);"

#### Schedule B

#### Where:

- 1. Firstlight Noosa Owners' Association Ltd ACN 141 935 435(*FLNOA*) is a body corporate operated as a managed investment scheme;

# Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(a), 911A(2)(l) and 992B(1)(a) -Exemption

- 1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from compliance with section 601ED of the Act, in the case specified in Schedule B on the conditions specified in Schedule E for so long as they are met.
- 2. Under paragraph 911A(2)(1) of the Act, ASIC exempts the person specified in Schedule A from the requirement to hold an Australian financial services licence for the provision of financial services, in the case specified in Schedule C on the conditions specified in Schedule E for so long as they are met.
- 3. Under paragraph 992B(1)(a) of the Act, ASIC exempts the person specified in Schedule A from compliance with section 992AA of the Act, in the case specified in Schedule D on the conditions specified in Schedule E for so long as they are met.

#### Schedule A

Quantum Housing Group Pty Ltd ACN 141 554 798 as trustee for the Quantum Affordable Housing Unit Trust (*Operator*).

#### Schedule B

The Operator operates a managed investment scheme (Scheme) under which:

- (a) owners of real property make their properties available to the Operator for participation under the *National Rental Affordability Scheme Act 2008* (*NRASA*);
- (b) the Operator will be entitled to receive tax offsets and annual payments from the federal and state governments under the NRASA;
- (c) the owners of real property under the Scheme will be responsible for the renting of their properties and will be entitled to receive rent from the tenants and to pay all outgoings;

#### Schedule C

The Operator issues or arranges to issue an interest in the Scheme.

#### Schedule D

The Operator offers an interest in the Scheme for issue in the course of, or because of, an unsolicited meeting or telephone call with another person reasonably held or made in connection with the offer.

#### Schedule E

- 1. Any offer to issue interests in a managed investment scheme in the case referred to in Schedule B must be made under a product disclosure statement which complies with Part 7.9 of the Act and a copy of such a product disclosure statement must be given by the Operator to persons in circumstances where the Operator is required to do so in accordance with Part 7.9 of the Act.
- 2. The Operator must ensure that the Scheme is a member of an external dispute resolution scheme that complies with paragraphs 912A(2)(b) of the Act and 7.6.02 of the *Corporations Regulations 2001*.

# Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) — Exemptions

- 1. Under paragraph 741(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts each of the persons specified in Schedule A, from Parts 6D.2 and 6D.3 (except section 736) of the Act where it makes an eligible offer, on the conditions set out in Schedule B and for so long as the conditions are met.
- 2. Under paragraph 911A(2)(l) of the Act, ASIC exempts each of the persons specified in Schedule A, on the conditions set out in Schedule B and for so long as the conditions are met, from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 3. Under paragraph 911A(2)(1) of the Act, ASIC exempts each of the persons specified in Schedule A, from the requirement to hold an Australia financial services licence for the provision of a financial service consisting of dealing in a financial product in connection with an eligible offer, on the conditions set out in Schedule B and for so long as the conditions are met.
- 4. Under paragraph 911A(2)(1) of the Act, ASIC exempts:
  - (a) each of the persons specified in Schedule A; and
  - (b) any associate of a person specified in Schedule A,

from the requirement to hold an Australian financial services licence for the provision of the following financial services, on the conditions set out in Schedule B and for so long as the conditions are met:

- (c) the provision of a custodial or depository service in connection with an eligible offer where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties;
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer where any acquisition by purchase or disposal of the product (by a person specified in Schedule B or an associate that person) occurs either:

- (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
- (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts each of the persons specified in Schedule A where that person makes an eligible offer, from sections 736, 992A and 992AA of the Act in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
- 6. Under paragraph 1020F(1)(a) of the Act, ASIC exempts each of the persons specified in Schedule A from Part 7.9 of the Act where the person:
  - (a) makes an eligible offer; or
  - (b) offers to arrange for the issue of financial products under an eligible offer; or
  - (c) issues a financial product under an eligible offer,

on the conditions set out in Schedule B and for so long as the conditions are met.

# Schedule A

- (a) FKP Limited ACN 010 729 950 (FKP); and
- (b) FKP Funds Management Limited ACN 089 800 082 (*FFML*), in its capacity as the responsible entity for the FKP Property Trust ARSN 099 648 754,

(collectively referred to as the FKP Property Group).

# Schedule B

The following conditions apply:

- 1. The eligible offer must be substantially on the terms set out in the Rules of the Plan;
- 2. The FKP Property Group must:
  - (a) include the offer in an offer document:
  - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and

- (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an eligible employee;
- 3. The FKP Property Group must comply with any undertaking required to be made in the offer document by reason of this instrument;
- 4. The FKP Property Group must take reasonable steps to ensure that the number of FKP Stapled Securities the subject of the offer when aggregated with:
  - (a) the number of FKP Stapled Securities in the same class which would be issued were each outstanding offer with respect to FKP Stapled Securities under an employee share scheme to be accepted; and
  - (b) the number of FKP Stapled Securities in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer;

but disregarding any offer made, or FKP Stapled Security issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction;
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999;
- (e) an offer that did not need disclosure to investors because of section 708;
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued FKP Stapled Securities in that class of the issuer as at the time of the offer; and

*Note:* where a document must be provided in writing it may be provided by electronic means. See section 5C of the Act and section 25 of the *Acts Interpretation Act 1901*.

#### Interpretation

In this instrument:

- 1. except where otherwise stated, references to provisions are to provisions of the Act;
- 2. the FKP Employee Security Plan shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
- 3. *approved foreign market* has the meaning given by Class Order [CO 03/184] *Employee Share Schemes*;
- 4. associated body corporate means:
  - (a) a body corporate that is a related body corporate of a person in Schedule
     A; or
  - (b) a body corporate that has voting power in a person in Schedule A of not less than 20%; or
  - (c) a body corporate in which a person in Schedule A has voting power of not less than 20%;
- 5. current market price means in relation to an FKP Stapled Security, the price published by the operator of the principal financial market on which FKP Stapled Securities are quoted as the final price for the previous day on which FKP Stapled Securities were traded on that financial market;
- 6. *custodial or depository service* has the meaning given by section 766E;
- 7. *eligible employee* means, in relation to the FKP Property Group, a person who is at the time of an offer under the FKP Employee Security Plan:
  - (a) a full or part-time employee of the FKP Property Group or of an associated body corporate, excluding directors of FKP; or
  - (b) a full or part-time employee of a Gandel Village Company, excluding directors of a Gandel Village Company;
- 8. *eligible offer* means an offer for the issue or sale of fully-paid FKP Stapled Securities where:
  - (a) the FKP Stapled Securities are in the same class as FKP Stapled Securities that have been quoted on the financial market operated by ASX Limited ACN 008 624 691 or an approved foreign market throughout the 12

- month period immediately before the offer without suspension for more than a total of 2 trading days during that period; and
- (b) the offer is made under the FKP Employee Security Plan that extends only to eligible employees;
- 9. **FKP Employee Security Plan** means the employee security plan for the FKP Property Group as governed by a document that is substantially in the terms set out in the Rules of the Plan;
- 10. *FKP Property Trust* means the managed investment scheme known as the FKP Property Trust ARSN 099 648 754, with the current responsible entity for the scheme being FFML;
- 11. **FKP Stapled Securities** means an ordinary share in FKP and an interest in the FKP Property Trust, where under the terms on which an ordinary share in FKP and an interest in the FKP Property Trust are to be traded, they must only be transferred together;
- 12. *financial product advice* has the meaning given by section 766B;
- 13. Gandel Village Company means any of the following companies:
  - (a) Fernbank Management Pty Ltd ACN 003 055 169;
  - (b) The Manors of Mosman Pty Ltd ACN 001 012 193;
  - (c) Pittwater Palms Management Pty Limited ACN 002 720 407; or
  - (d) Regency Services Pty Ltd ACN 002 180 065;
- 14. *general advice* has the meaning given by section 766B;
- 15. *offer* has a meaning affected by sections 700, 702 and 1010C;
- 16. *offer document* means a document setting out an offer under the Plan that:
  - (a) includes or is accompanied by a copy, or a summary, of the Rules of the Plan under which the offer is made;
  - (b) if a summary (rather than a copy) of the Rules of the Plan is given includes an undertaking that during the period (the *offer period*) during which an eligible employee may acquire the financial products offered or exercise options acquired under the scheme, the FKP Property Group will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the Plan;

- (c) specifies in respect of the FKP Stapled Securities:
  - (i) the acquisition price in Australian dollars;
  - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
  - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer;
- (d) includes an undertaking, and an explanation of the way in which, the FKP Property Group will, during the offer period, within a reasonable period of the eligible employee requesting, make available to the employee:
  - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of FKP Stapled Securities in the same class as those offered; and
  - (ii) where subparagraphs (c)(ii) or (c)(iii) apply, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by FKP, FFML in its own right or as responsible entity for the FKP Property Trust, a Gandel Village Company or an associate of any of these entities, for the purpose of acquiring FKP Stapled Securities under the FKP Employee Security Plan;
- 17. **Rules of the Plan** means the document entitled the FKP Employee Security Plan provided to ASIC on 12 May 2010.

Under paragraph 926A(2)(c) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) declares that Part 7.6 (other than Divisions 4 and 8) of the Act applies to the person specified in Schedule A in the case set out in Schedule C as if the following provisions were omitted, modified or varied:
  - (a) omit Note 2 in section 916D, substitute:
    - "Note 2: There are exceptions to this rule in sections 916E and 916EA"; and
  - (b) in subsection 916D(2B) omit "section 916E.", substitute "sections 916E or 916EA."; and
  - (c) in subsection 916E(1) omit "insurer.", substitute "insurer or provides general advice in relation to risk insurance products that are within the scope of the binder."; and
  - (d) in subsection 916E(2) omit "the binder:", substitute "the binder or provides general advice in relation to risk insurance products that are within the scope of the binder:"; and
  - (e) after section 916E insert:

# "916EA Licensees acting under authority other than binder

- (1) Despite section 916D, a financial services licensee (the *authorised licensee*) may be the authorised representative of another financial services licensee who is an insurer, if the authorised licensee acts under a written agreement (*written agreement*) which authorises the authorised licensee to deal in, and provide general advice in relation to, risk insurance products on behalf of the insurer.
- (2) For all purposes connected with contracts that are risk insurance products, or with claims against the insurer, in respect of which the authorised licensee acts under the written agreement:
  - (a) the authorised licensee is taken to act on behalf of the insurer and not the insured; and
  - (b) if the insured in fact relied in good faith on the conduct of the authorised licensee, the authorised licensee is

taken to act on behalf of the insurer regardless of the fact that the authorised licensee did not act within the scope of the authorisation.

- (3) This section does not apply where the licence of the authorised licensee covers the provision of any financial services in relation to the risk insurance products.".
- 2. Under paragraph 951B(1)(c) of the Act, ASIC declares that Part 7.7 of the Act applies to the persons specified in Schedule B in the case set out in Schedule C as if the following provisions were omitted, modified or varied:
