TAKE NOTICE: The Australian Securities and Investment Commission (ASIC) hereby issues an Infringement Notice to Navigator Resources Limited ACN 063 366 487 (Navigator) pursuant to s1317DAC(1) of the *Corporations Act 2001* (Corporations Act).

This Infringement Notice requires Navigator to pay a penalty to ASIC, on behalf of the Commonwealth, in the sum of \$33,000 (the Penalty).

This Infringement Notice is issued on 17 May 2012.

DETAILS OF THE ALLEGED CONTRAVENTION**The Facts**

On 8 June 2011, Navigator accepted a Mandate for Patersons Securities Limited (Patersons) to act as lead manager and underwriter to a proposed rights issue by Navigator (the Mandate Letter).

At 8.00 am Western Standard Time (WST) on 20 June 2011, Navigator made an announcement to ASX Limited (ASX) entitled "Equity Raising and Operation Update" (the Announcement). The Announcement included the following statements:

Key Points

- ◆ *Underwritten renounceable rights issue to raise a minimum of \$20.0 million and up to \$31.7 million to fund the cutback at Cockburn, retire debt and continue exploration*

EQUITY RAISING: Renounceable Rights Issue

In accessing the required level of funding, Navigator has engaged Patersons Securities Limited as Lead Manager and Underwriter to raise a minimum of \$20.0 million and up to \$31.7 million in a partially underwritten renounceable

rights issue to be offered to shareholders ... The rights issue will be structured as follows:

- ◆ *1 for 1 renounceable rights issue of shares to eligible shareholders at the record date;*
- ◆ *Issue price of 6.8 cents per share;*
- ◆ *Subscribers to receive 1 free attaching listed option for every 2 shares subscribed for, exercisable at 10 cents on or before 31 July 2014; and*
- ◆ *Minimum raising of \$20.0 million underwritten and up to \$31.7 million maximum funds raised (before costs).*

The above statements in the Announcement implied that Patersons was legally bound to underwrite Navigator's rights issue in the amount of \$20 million, subject only to the usual terms contained in underwriting agreements.

The implication that Patersons was legally bound to underwrite Navigator's rights issue was misleading because at the time of the Announcement, Patersons was not legally bound to underwrite Navigator's rights issue.

When it made the Announcement, Navigator was aware of the following information:

- (a) Patersons' appointment as underwriter of the rights issue would only take effect upon the execution of a formal underwriting agreement to be agreed between Patersons and Navigator and that no such formal underwriting agreement had yet been entered into; and
- (b) Patersons' appointment as underwriter to the rights issue was conditional upon, among other things, a satisfactory outcome (in Patersons' sole and absolute opinion) to Navigator's due diligence process, which due diligence process had not yet been completed,

(the Information).

The Contravention

This Infringement Notice has been issued because ASIC has reasonable grounds to believe that Navigator contravened s674(2) of the Act in the period between 8:00 am WST on 20 June 2011 and 7.19 am WST on 22 June 2011 in that:

- (a) Navigator is an entity to which s674(2) of the Act applies.
- (b) By 20 June 2011 Navigator was aware of the Information.
- (c) The Information was information that a reasonable person would expect, if it were generally available, to have a material effect on the price or value of securities of Navigator because:
 - Navigator needed to raise money to repay a debt facility on 30 June 2011.
 - Navigator had announced an underwritten renounceable rights issue to raise a minimum of \$20 million and up to \$31.7 million.

- The proposed fundraising was critical to Navigator.
 - The existence of a legally binding underwriting agreement indicated that a third party was prepared to purchase Navigator securities on the terms set out in the Announcement.
 - The fact that no legally binding underwriting agreement had been entered into would have signalled uncertainty to investors.
- (d) ASX Listing Rule 3.1 required Navigator to tell ASX of the Information from 8.00 am WST on 20 June 2011.
- (e) ASX Listing Rule 3.1A (the exception to ASX Listing Rule 3.1) did not apply to the Information because:
- (i) A reasonable person would have expected the Information to be disclosed to ASX;
 - (ii) The Information was not confidential; and
 - (ii) None of the matters referred to in ASX Listing Rule 3.1A.3 applied to the Information.
- (f) Between 8.00 am WST on 20 June 2011 when Navigator made the Announcement and 7.19 am WST on 22 June 2011 when the securities of Navigator were placed into a trading halt, the Information was not generally available.

Compliance with the Infringement Notice

Navigator may choose to comply with this Infringement Notice by paying the Penalty within the compliance period.

The compliance period for this Infringement Notice begins on 18 May 2012 and expires on 15 June 2012: s1317DAH(1) of the Act. ASIC may extend the compliance period for this Infringement Notice once, by up to 28 days: s1317DAH(3) of the Act. If this occurs ASIC will notify Navigator in writing.

Effect of issue and compliance with the Infringement Notice

The issue of this Infringement Notice, and subsequent compliance with it, is not an admission of liability by Navigator and cannot be regarded as a finding that Navigator has contravened s674(2) of the Act for any other purpose: s1317DAF(4) of the Act.

ASIC cannot take civil or criminal proceedings against Navigator for the alleged contravention specified in this Infringement Notice, either during the compliance period or after the Infringement Notice is complied with: s1317DAF(5) of the Act. However, certain proceedings may be commenced or continued against Navigator by third parties or by ASIC on behalf of third parties: s1317DAF(6) of the Act.

Effect of failure to comply with the Infringement Notice

ASIC cannot enforce compliance with this Infringement Notice: s1317DAF of the Act. However, if this Infringement Notice is not withdrawn in accordance with s1317DAI of the Act, it is open to ASIC to take the following action against Navigator:

- (a) ASIC may begin civil penalty proceedings against the entity under Part 9.4B of the Act seeking a declaration that Navigator breached the provision specified in this Infringement Notice and a pecuniary penalty order. The size of the pecuniary penalty is not limited to the amount specified in the Infringement Notice. The Court may under Part 9.4B impose a maximum penalty in relation to the alleged contravention of up to \$1 million;
- (b) ASIC may (if applicable) begin proceedings under s1324B of the Act seeking an order that specified information be disclosed in the manner required by this Infringement Notice;
- (c) ASIC may (if applicable) make an order under s91 of the *Australian Securities and Investments Commission Act* (the ASIC Act) for recovery of expenses of its investigation into the breach specified in this Infringement Notice. ASIC can also bring proceedings to enforce that order; and
- (d) ASIC can make a determination under ss708A(2), 713(6), 1012DA(2) or 1013FA(3) of the Act, or accept an enforceable undertaking under s93AA of the ASIC Act and bring proceedings to enforce the undertaking: s1317DAG of the Act.

Certain other proceedings may also be commenced or continued against Navigator by third parties or by ASIC on behalf of third parties: s1317DAG(4) of the Act.

Withdrawal of infringement notice

ASIC may withdraw this Infringement Notice at any time prior to compliance if it considers it appropriate to do so. If this Infringement Notice is withdrawn, any enforcement action may be taken by ASIC against Navigator, including:

- (a) civil proceedings under Part 9.4B of the Act;
- (b) a prosecution for an offence based on the provision specified in the notice.

Navigator may seek the withdrawal of this Infringement Notice by making a written representation to ASIC: s1317DAI(1) of the Act. Material provided to ASIC in such a representation is not admissible in evidence in proceedings against Navigator or a representative of the company: s1317DAI(2) of the Act.


