Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 741(1)(b) – Declaration

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 741(1)(b) of the Corporations Act 2011 (Act).

Title

2. This instrument is ASIC Instrument 11-0909.

Commencement

3. This instrument commences on 16 September 2011.

Declaration

4. Part 6.D of the Act applies to Global Mineral Resources Ltd ACN 140 767 022 (*Issuer*) as if:

Paragraph 723(3)(b) of the Act were omitted and the following substituted:

- "(b) the securities are not admitted to quotation within 3 months after the later of:
 - (i) the date of the disclosure document; and
 - (ii) the date of the latest supplementary disclosure document which discloses that the securities are not admitted to quotation and gives applicants 1 month to withdraw their application and be repaid;";

subparagraph 724(1)(b)(ii) were omitted and the following substituted:

- "(ii) the securities are not admitted to quotation within 3 months after the later of:
 - (A) the date of the disclosure document; and
 - (B) the date of the latest supplementary disclosure document which discloses that the securities are not admitted to quotation and gives applicants 1 month to withdraw their application and be repaid"; and

section 724 were modified or varied by inserting after subsection (1A):

- "(1B) Where a supplementary disclosure document of the kind referred to in subparagraph (1)(b)(ii)(B) is lodged, the person offering the securities must give the applicants:
 - (i) that latest supplementary disclosure document; and

(ii) 1 month to withdraw their application and be repaid their application money."

1. The Australian Securities and Investments Commission makes this instrument under subsection 741(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This declaration is ASIC Instrument [11-0980].

Commencement

3. This instrument commences on the date it is signed.

Declaration

- 4. ASIC declares that Chapter 6D of the Act applies to a person who holds a share in Site Group International Limited ACN 003 201 910 (*Site Group*) as if section 708A of the Act were modified by, after notional subsection 708A(12F) (as inserted by ASIC Class Order [CO 10/322], insert:
 - "(12G) For the purposes of paragraph (12C)(c), disregard a suspension that:
 - (a) is required by the market operator under the rules of the prescribed financial market;
 - (b) relates to a significant change to the nature or scale of activities of the body's activities under the rules of the prescribed financial market; and
 - (c) is lifted following compliance by the body of the rules of the prescribed financial market for admission to the official list of the prescribed financial market."

Where this instrument applies

5. This instrument applies to sale offers of securities in Site Group where the relevant securities are issued to a person by reason of the conversion of convertible notes in Site Group and where the convertible notes are issued on or about 24 October 2011.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) – Exemptions

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 741(1)(a), 911A(2)(1), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) of the Corporations Act 2001 (the *Act*).

Title

2. This instrument is ASIC Instrument 11-1012.

Commencement

3. This instrument takes effect on gazettal.

Exemptions

- 4. Senex Energy Limited ACN 008 942 827 (the *Issuer*) is exempted from Parts 6D.2, 6D.3 (except section 736) and 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer;
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer; or
 - (d) issues a financial product on the vesting or exercise of a Performance Right that was issued under an eligible offer,

that does not involve a contribution plan, on the conditions set out in this instrument and for so long as the conditions are met.

- 5. A financial product that is the subject of an eligible offer is exempted from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendations is not aware, and ought not reasonably to be aware, that any of the conditions set out in this instrument have not been met.

6. The Issuer is exempted from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 4 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that eligible employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

7. ASIC exempts:

- (a) the Issuer; and
- (b) any related body corporate of the Issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by the exemption in paragraph 4 where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course or providing a custodial or depositor services covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by paragraph 4 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or a related body corporate of the Issuer) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 8. The Issuer is exempted from sections 736, 992A and 992AA of the Act in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Conditions

The following conditions apply:

- 9. when making the offer the Issuer must:
 - (a) include the offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and

- (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 10. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
- 11. the Issuer must take reasonable steps to ensure that the number of shares to be issued on vesting of a Performance Right when aggregated with:
 - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme (including the Plan) to be accepted, vested or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years pursuant to any employee share scheme (including the Plan) extended only to eligible employees of the Issuer,

but disregarding any offer made, or Performance Right acquired, or option acquired, or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of Section 1012D of the Act; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts Interpretation Act 1901.

Interpretation

In this instrument:

- 12. except where otherwise stated, references to provisions are to provisions of the Act.
- 13. the Plan shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee.

- 14. ASX means the financial market operated by ASX Limited ACN 008 624 691.
- 15. *Australian dollar equivalent* in relation to a price means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates.
- 16. *current market price* means, in relation to a share, the price published on ASX as the final price for the previous day on which the share was traded on that financial market.
- 17. *eligible employee* means, in relation to the Issuer, a person who is at the time of an offer under the Plan:
 - (a) a full or part-time employee of the Issuer or of a related body corporate of the Issuer; or
 - (b) a director of the Issuer, or of a related body corporate of the Issuer, who holds a salaried employment or office in the Issuer or in a related body corporate; or
 - (c) a contractor which is:
 - (i) an individual that has:
 - (A) performed work for the Issuer, or a related body corporate of the Issuer, for more than 12 months; and
 - (B) received 80% or more of their income in the preceding year from the Issuer or a related body corporate of the Issuer; or
 - (ii) a company where each of the following are satisfied in relation to the company:
 - (A) throughout the previous 12 months, the company has had a contract in place with the Issuer, or a related body corporate of the Issuer, for the provision of the services of an individual (the *contracting individual*) to the Issuer;
 - (B) the contracting individual has performed work for the Issuer or a related body corporate of the Issuer, for more than 12 months;
 - (C) the contracting individual has been the only member of the company for more than 12 months; and
 - (D) more than 80% of the aggregate income of the company and the contracting individual from all sources (other than from each other) in the preceding 12 months was received from the Issuer or a related body corporate of the Issuer.
- 18. *eligible offer* means an offer for the issue of a Performance Right that is made under the Plan.
- 19. financial product advice has the meaning given by section 766B of the Act.

- 20. general advice has the meaning given by section 766B of the Act.
- 21. offer has a meaning affected by sections 700, 702 and 1010C of the Act.
- 22. offer document means a document setting out an offer under the Plan that:
 - includes or is accompanied by a copy, or a summary, of the Rules of the Plan;
 and
 - (b) if a summary (rather than a copy) of the Rules of the Plan is given includes an undertaking that during the period (the *offer period*) during which an eligible employee may acquire or exercise the Performance Rights offered under the Plan, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the Plan; and
 - (c) specifies in respect of the shares that may be acquired on the vesting or exercise of a Performance Right:
 - (i) the acquisition price (if any) in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australia dollar equivalent of that price were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the Issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the eligible employee:
 - (i) the current market price (or where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares that will be acquired by the eligible employee when the Performance Right offered to the eligible employee vests or is exercised; and
 - (ii) where subparagraph (c)(ii) or (c)(iii) applies, the information referred to in that paragraph as updated to that date.

23. Performance Right means:

- (a) an unsecured right to acquire, by way of issue or transfer, one fully paid ordinary share in the capital of the Issuer granted under the Rules of the Plan; or
- (b) where the right referred to in paragraph (a) has vested or has been exercised in accordance with the Rules of the Plan, but the fully paid ordinary share to which the right relates has not been issued or transferred to the eligible employee, an equitable interest in a fully paid ordinary share,

where

(c) each Performance Right is issued for nil consideration; and

- (d) the share to which the Performance Right relates is a fully paid ordinary share in the same class as shares that have been quoted on ASX throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period.
- 24. *Plan* means an employee share scheme that is known, as at the date of this instrument, as the Senex Energy Limited Employee Performance Rights Plan where:
 - (a) the scheme is extended only to eligible employees; and
 - (b) the scheme is governed by the Rules of the Plan.
- 25. *Rules of the Plan* means the written terms of the Plan known as at the date of this instrument, as the Senex Energy Limited Employee Performance Rights Plan Rules, as amended from time to time.

- (d) BetaShares Commodities Basket ETF Currency Hedged (Synthetic) ARSN 150 081 495 (the *Schemes*),

from paragraph 601FC(1)(d) of the Act in the case specified in Schedule A.

Schedule A

Where:

- (a) only an Authorised Participant that is an Australian Resident is permitted to redeem interests in the Schemes; and
- (b) the Product Disclosure Statement for the Schemes lodged with ASIC discloses full particulars of how the responsible entity may treat members of the same class differently as permitted by this instrument; and
- (c) interests of the Schemes remain admitted to Trading Status as an AQUA Product on the financial market operated by ASX Limited ACN 008 624 691 (ASX).

Interpretation

For the purposes of this instrument:

AQUA Product has the same meaning as defined in the ASX Operating Rules as at the date of this instrument.

ASX Operating Rules means ASX's current operating rules.

Australian Resident means, as at a particular time, any person or entity who satisfies all of the following requirements:

- (a) either:
 - (i) the person or entity provides the Responsible Entity, in a form acceptable to the Responsible Entity, with an undertaking that they:

- (A) have been an Australian Resident for the purposes of the *Tax Act* continuously from the beginning of the relevant financial year until that time; and
- (B) will continue to be an Australian resident for the purposes of the *Tax Act* at all times from that time until the end of the relevant financial year; or
- (ii) the Responsible Entity reasonably determines that the person or entity:
 - (A) is an Australian resident for the purposes of the *Tax Act* continuously from the beginning of the relevant financial year until that time; and
 - (B) will continue to be an Australian resident for the purposes of the *Tax Act* at all times from that time until the end of the relevant financial year;
- (b) the Responsible Entity, or any person who keeps records on behalf of the Responsible Entity, does not hold any records with an address for the person or entity which is outside Australia; and
- (c) the person or entity has not authorised the Responsible Entity to pay any amounts to the person or entity to a place or an account located outside Australia.

Authorised Participant means a Trading Participant as such term is defined in the ASX Operating Rules, as at the date of this instrument, who has entered into an authorised participant agreement with the Responsible Entity or such other person as the Responsible Entity determines.

Tax Act means the Income Tax Assessment Act 1936 (as amended) (1936 Act), the Income Tax Assessment Act 1997 (as amended) (1997 Act) or both the 1936 Act and the 1997 Act, as appropriate.

Trading Status has the same meaning as defined in the *ASX Operating Rules* as at the date of this instrument.

- 7. inserting after the words "(see subsection (4))" in subparagraph 1016E(1)(b)(i) "or no later than 7 days after the date of the issue of the product, if required"; and
- 8. inserting after the words "the relevant date" in subparagraph 1016E(1)(b)(ii) "or the date of issue of the product".

Schedule A

Where the Responsible Entity offers interests in the Schemes under a Product Disclosure Statement lodged with ASIC that discloses the full particulars of the issue of the financial product including:

- 1. the timing arrangements in relation to the quotation of newly issued financial products on the financial market operated by ASX Limited ACN 008 624 691 (ASX);
