



Title

2. This instrument is ASIC Instrument [11-1257].

Commencement

3. This instrument commences on 30 November 2011.

Declaration

4. Chapter 6D of the Act applies to Precious Metals Investments Limited ACN 144 973 259 (the *Issuer*) as if Part 6D.2 were modified or varied as follows:
 - (a) omit paragraph 723(3)(b), substitute:

“(b) the securities are not admitted to quotation within 3 months after the later of:
 - (i) the date of the disclosure document; and
 - (ii) the date of the latest supplementary disclosure document for the offer lodged with ASIC which:
 - (A) discloses that the securities are not admitted to quotation; and
 - (B) gives applicants 1 month to withdraw their application and be repaid”;
 - (b) in paragraph 724(1)(a), omit the words “and that condition is not satisfied within 4 months after the date of the disclosure document”, substitute:

“and that condition is not satisfied within 4 months after the later of:



- (i) that supplementary disclosure document; and
 - (ii) 1 month to withdraw their application and be repaid.”.

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 601QA(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 11-1258.

Commencement

3. This instrument commences on Gazettal.

Revocation

4. ASIC instrument 11-1231 is revoked.

Exemptions

5.
 - (a) Centro MCS Manager Limited ACN 051 908 984 in its capacity as the responsible entity of Centro Retail Trust ARSN 104 931 928 (*CRT RE*);
 - (b) Centro MCS Manager Limited ACN 051 908 984 in its capacity as the responsible entity of Centro DPF Holding Trust ARSN 153 269 759 (*DHT RE*);
 - (c) Centro MCS Manager Limited ACN 051 908 984 in its capacity as the responsible entity of Centro Australia Wholesale Fund ARSN 122 223 974 (*CAWF RE*);
 - (d) Centro Retail Limited ACN 114 757 783 (*CRL*);
 - (e) each of the Sale Nominee; and
 - (f) Link Market Services Limited ACN 083 214 537 (*Link*),

do not have to comply with:

- (g) section 601ED of the Act;

 - (ii) sending the CER EM and the Disclosure Document:
 - A. by post to the address for the Ineligible Foreign Securityholder in the Register of Members or an alternative address (if any) nominated by the Holder; or
 - B. to the fax number or electronic address (if any) nominated by the Ineligible Foreign Securityholder; and
 - (b) take reasonable steps to ensure the First Sale Facility is not operated during any period where a Control Transaction has been publicly proposed and has not ended.

11. In respect of the Second Sale Facility, the Second Sale Facility satisfies all of the following:

 - (b) under the terms of the Second Sale Facility:
 - (i) the financial products (the *relevant financial products*) of Ineligible Holders to be sold through the Second Sale Facility are pooled; and



Corporations Act 2001 — Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a), 1020F(1)(a)
and 1020F(1)(b) — Exemptions**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) of the *Corporations Act 2001 (the Act)*.

Title

2. This instrument is ASIC Instrument [11-1260].

Commencement

3. This instrument takes effect on gazettal.

Exemption

4. Under paragraphs 741(1)(a) and 1020F(1)(a) of the Act, ASIC exempts Union Resources Limited ACN 002 118 872 (*the issuer*) from Parts 6D.2, 6D.3 (excluding section 736) and 7.9 of the Act where the issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer;
 - (c) issues a financial product under an eligible offer,on the conditions set out in the schedule and for so long as the conditions are met.
5. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the issuer) that a person to whom an eligible offer has been made acquires the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the schedule have not been met.
6. Under paragraph 911A(2)(l) of the Act, ASIC exempts the issuer from the requirement to hold an Australian financial services licence for the provision of a financial service

consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 4 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the issuer in connection with the offer is general advice only, and that eligible person should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

7. Under paragraph 911A(2)(l) of the Act, ASIC exempts:

- (a) the issuer; and
- (b) any related body corporate of the issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial, or depository service in connection with an eligible offer covered by paragraph 4 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
 - (d) dealing in a financial product in the course of providing a custodial or depository services covered by paragraph (c); and
 - (e) dealing in a financial product in connection with an eligible offer covered by paragraph 4 of this instrument where any acquisition by purchase or disposal of the product (by the issuer or a related body corporate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
8. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the issuer from sections 736 and 992A of the Act in relation to eligible offers covered by paragraph 4 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Schedule

The following conditions apply:

- 1. The issuer must ensure that the eligible offer is substantially on the terms set out in the Union Resources Limited performance rights plan rules provided to ASIC as an attachment to an electronic mail dated 26 October 2011; and
- 2. The issuer must:
 - (a) include the offer in an offer document; and

- (b) take reasonable steps to ensure that any eligible person to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the eligible person such as the identity or entitlement of the eligible person) and of each accompanying document not later than seven days after the first provision of that material to an eligible person; and
3. The issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
4. The issuer must take reasonable steps to ensure that the number of shares to be issued on vesting of a performance right when aggregated with:
- (a) the number of shares in the same class which would be issued were each outstanding offers with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme (including the plan) to be accepted, vested or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years pursuant to any employee share scheme (including the plan) extended only to eligible person of the issuer;

but disregarding any offer made, or option acquired, or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that did not need disclosure to investors because of section 708; or
- (e) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (f) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act;

2. the plan shall not be regarded as extended to a person other than an eligible person only because such an eligible person may renounce an offer of financial products made to them under the scheme in favour of their nominee;
3. *Australian dollar equivalent* in relation to a price means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which the price relates;
4. *ASX* means the financial market operated by ASX Limited ACN 008 624 691;
5. *current market price* means in relation to a share, the price published by the operator of the ASX as the final price for the previous day on which the share was traded on the ASX;
6. *eligible person* means a person who is, at the time of an eligible offer, a full or part-time employee or executive director of the issuer or of a related body corporate of the issuer;
7. *eligible offer* means an offer for the issue of a performance right that is made under the plan;
8. *financial product advice* has the meaning given by section 766B of the Act;
9. *general advice* has the meaning given by section 766B of the Act;
10. *offer* has a meaning affected by section 1010C of the Act;
11. *offer document* means a document setting out an offer under the plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the plan; and
