Australian Securities and Investments Commission Corporations Act 2001 — Subsections 655A(1) and 673(1) — Declaration

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 741(1)(b) – Declaration

 - (i) for the convertible securities the information required by subsection 713(2); and
 - (ii) for the relevant securities the information required by subsections 713(2) to (5),
 - as if the notice were a prospectus; and
 - (b) the notice is worded and presented in a clear, concise and effective manner; and
 - (c) where the notice includes a statement by a person, or a statement said in the notice to be based on a statement made by a person:
 - (i) the person has consented to the statement being included in the notice in the form and context in which it is included;
 - (ii) the notice states that the person has given this consent; and
 - (iii) the person has not withdrawn this consent before the notice is given to the relevant market operator; and

 - (i) a misleading or deceptive statement in the notice; or



- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the Corporations Act (the Act) the Australian Securities and Investments Commission (ASIC) exempts Norton Gold Fields Limited ACN 112 287 797 (Norton Gold Fields) from Parts 6D.2 and 6D.3 (except section 736) and 7.9 of the Act in relation to an offer of the kind referred to in paragraph 1(a) of the First Exemption in ASIC Class Order [CO 03/184] (the Class Order) (as in force on the date of this instrument and as amended from time to time by a disallowable legislative instrument within the meaning of the Legislative Instruments Act 2003) on the conditions set out in the Schedule to the Class Order, and for so long as those conditions are met, as if the Class Order read in the way referred to in the Schedule to this instrument.
- 2. Under paragraph 911A(2)(1) of the Act, ASIC exempts Norton Gold Fields from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer of the kind, and on the same conditions, referred to in paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by Norton Gold Fields in connection with the offer is general advice only, and that eligible employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
