Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 741(1)(b) and 1020F(1)(c) – Variation

Under paragraphs 741(1)(b) and 1020F(1)(c) of the *Corporations Act 2001* the Australian Securities and Investments Commission ("ASIC") varies ASIC Instrument [05/1057] (the "Instrument") as follows:

1. In the heading, omit '**Paragraph 911A(2)(l) – Exemption**' and substitute '**Paragraphs 741(1)(b) and 1020F(1)(c) – Declaration**'; and
2. Omit all of the text under the heading and above Schedule A and substitute:
 - '1. Under paragraph 741(1)(b) of the *Corporations Act 2001* ("the Act"), the Australian Securities and Investments Commission ("ASIC") declares that Part 6D.2 of the Act applies to the persons referred to in Schedule A in the case specified in Schedule C as if subsection 708(13) were modified by omitting paragraph 708(13)(b) and substituting:

"(b) an offer of fully-paid shares in a body to one or more existing holders of shares in the body, under a plan for the reinvestment of one or both of:

 - (i) dividends in respect of shares in the body and one or more other bodies;
 - (ii) distributions in respect of interests in a registered managed investment scheme,

where, under the terms on which the shares and interests may be traded, those shares and interests must only be transferred together."
2. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies to the persons referred to in Schedule B in the case specified in Schedule C as if subsection 1012D(3) were modified by:
 - (a) omitting "either" at the beginning of paragraph 1012D(3)(b) and substituting "one or more of the following applies"; and
 - (b) omitting "or" at the end of subparagraph 1012D(3)(b)(i); and
 - (c) omitting "." at the end of subparagraph 1012D(3)(b)(ii) and substituting ";"; and

(d) inserting after subparagraph 1012D(3)(b)(ii): 0 6 / 0 1 0 7

"(iii) in a recommendation situation – the advice that constitutes the relevant conduct relates to an offer of interests a registered managed investment scheme, under a plan for the reinvestment of one or both of:

(A) distributions in respect of interests in the scheme;

(B) dividends in respect of shares in one or more bodies,

where, under the terms on which the shares in the body or bodies and the interests in the registered managed investment scheme may be traded, those shares and interests must be only transferred together;

(iv) in an issue situation – the offer or issue that constitutes the relevant conduct is an offer or issue of interests in a registered managed investment scheme, under a plan for the reinvestment of one or both of:

(A) distributions in respect of interests in the scheme;

(B) dividends in respect of shares in one or more bodies,

where, under the terms on which the shares in the body or bodies and the interests in the registered managed investment scheme may be traded, those shares and interests must be only transferred together.""; and

3. In Schedule A, omit '("MML")' and substitute:

'("MMHL"); and

Macquarie Media International Limited ("MMIL"), a body corporate incorporated under the Companies Act 1981 of Bermuda,

(the "Companies"); and

4. In "Schedule B, omit 'Macquarie Media Holdings Limited ACN 116 024 536'; and

5. Omit Schedule C and substitute:

'Schedule C

Offers and issues of Stapled Securities under a reinvestment plan (**Plan**) where all of the following apply:

- (a) the terms of the Plan permit the dividends (in respect of shares in the Companies) and distributions (in respect of interests in the Scheme) to be pooled prior to the offer or issue of Stapled Securities under the Plan;
- (b) the terms of the Plan require all participants in the Plan to be given notice of any subsequent amendments to the Plan;
- (c) each participant in the Plan has agreed in writing to the terms of the Plan upon election to participate;

'Interpretation

In this instrument:

Under paragraph 601QA(1)(a) of the *Corporations Act 2001*, the Australian Securities and Investments Commission ("ASIC") varies ASIC instrument [05/1056] (the "Instrument") as follows:

1. omit "**Paragraph 601QA(1)(b) – Declaration**" from the heading and substitute "**Paragraph 601QA(1)(a) – Exemption**";
2. omit paragraph 3. of Schedule C and substitute:
 - "3. The issued ordinary shares in the Companies (other than the A Special Share and B Special Share in Macquarie Media Holdings Limited ACN 116 024 536 ("MMHL") and Macquarie Media International Limited, a body corporate incorporated under the Companies Act 1981 of Bermuda, ("MMIL"), which do not form part of Stapled Securities) and the issued interests in the Scheme are and remain Stapled Securities;"
3. omit paragraph 5. of Schedule C and substitute:
 - "5. The RE ensures that if the Stapled Securities become subject to the foreign ownership rules as stipulated in ASX ASTC Settlement Rules Guidance Note No 4, dated 10 June 2005 and as in force on the date of this instrument, a flag is maintained on the Stock Exchange Automated Trading System of the financial market of ASX regarding those ownership restrictions; and"
4. omit paragraph 7. of Schedule C, substitute:
 - "7. Each Product Disclosure Statement for interests in the scheme and each prospectus for shares in MMHL and MMIL must summarise:
 - (a) the provisions contained in the constitutions of the Scheme, MMHL and MMIL that will be used to determine whether a person is an Ineligible Member; and
 - (b) the process that will be adopted to dispose of all or some of the interests in the Scheme that are held by an Ineligible Member."; and

5. under the heading "**Interpretation**":

(a) omit:

Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the "Act"), the Australian Securities and Investments Commission ("ASIC") varies ASIC Instrument [05/1058] (the "Instrument") as follows:

1. In paragraph 2, omit "a company" from paragraph 601FC(1)(c) of the Act, as modified by the Instrument, and substitute "one or more companies"; and
2. In paragraph 3, omit "a company" from paragraph 601FD(1)(c) of the Act, as modified by the Instrument, and substitute "one or more companies"; and
3. In paragraph 4, omit subsection 208(2A) of the Act, as notionally inserted into the Act by the Instrument, and substitute:

"(2A) Member approval is not required for the giving of a benefit and the benefit need not be given within 15 months if:

- (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme;
or
 - (ii) could endanger the scheme property; and
- (b) each of the interests in the scheme is either:
 - (i) a component part of a stapled security together with shares in one or more companies (the *stapled companies*); or
 - (ii) held other than as a component part of a stapled security by one of the stapled companies or one of its wholly owned entities; and
- (c) the benefit is given by:
 - (i) the responsible entity of the scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity;
and
- (d) the benefit is given:
 - (i) to a stapled company, or to any wholly owned entity of a stapled company; or

- (ii) as a result of a benefit given to one or more of the persons described in paragraph (i) above, to a related party of the responsible entity of the scheme who holds stapled securities; or
 - (iii) to any wholly owned entity of the scheme."; and
4. In paragraph 5, omit section 601PD, as notionally inserted into the Act by the Instrument, and substitute:
- "601PD For the purposes of this Chapter, *stapled security* means two or more financial products including at least one interest in a registered scheme which, under the terms on which each of the products are to be traded, must be transferred together."; and
5. In Schedule B, omit "." and substitute:
- "and shares in Macquarie Media International Limited, a body corporate incorporated under the Companies Act 1981 of Bermuda.".

Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 601QA(1)(a), 911A(2)(l), 992B(1)(b) and
1020F(1)(a) — Exemption

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person referred to in Schedule A from section 601ED of the Act in the case referred to in Schedule B.
2. Under paragraphs 911A(2)(l) and 1020F(1)(a) of the Act, ASIC exempts the person referred to in Schedule B from:
 - (a) section 1017F of the Act; and
 - (b) the requirement to hold an Australian financial services licence for the provision of financial services by that person in relation to dealing in interests in a managed investment scheme of the kind and offered on the basis referred to in Schedule B.
3. Under paragraph 992B(1)(b) of the Act, ASIC exempts an interest in the managed investment scheme referred to in Schedule B from section 992A of the Act:
 - (a) where the interest is being offered by a person referred to in Schedule A – in the case referred to in Schedule B; and
 - (b) where the interest is being offered for sale (other than by a person referred to in Schedule A) – in the case where paragraphs (e), (f) and (i) of Schedule B appear to be complied with.

SCHEDULE B – SCHEME EXEMPTED

Operating the managed investment scheme (the *scheme*) that involves an owner (*investor*) of real property (strata unit), described in the letter of Susan Henson dated 10 January 2006 to ASIC in relation to Cairns Beach Resort, and making their strata unit available for use by a person (*operator*) as part of a serviced resort complex known as "Cairns Beach Resort" located at 129-135 Oleander Street, Holloways Beach, Cairns, Queensland, and comprising of all or any of Lots 1 to 74 registered with the Cairns Beach Resort Community Titles Scheme on Building Units Plan 26951 as currently registered with the Queensland Registrar of Titles, where all of the following apply:

- (a) each unit can be lawfully used as a residence;

- (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:
 - (i) by a person other than the operator or an associate of the operator; and
 - (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is a financial services licensee;
- (e) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (f) the sale of the unit is not and was not conditional on participation in the scheme and there is no obligation on any person to ensure that other owners of Units agree to participate in the scheme;
- (g) if a FFE Fund has been established for an investor, the operator takes reasonable steps to ensure that:
 - (i) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and
 - (ii) the balance of the Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first;
- (h) no payment is liable to be made by an investor to participate in the scheme other than:
 - (i) payment of money to buy the strata unit;
 - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
 - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case

may be), by the operator during the period to which the payments relate; and

- (B) where a FFE Fund has been established for the investor — no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
- (iii) where a FFE Fund has been established for the investor — one or more payments into the Fund where:
 - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
 - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
 - (i) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme.
 - (j) each investor who is a member of the scheme has been given a Product Disclosure Statement (PDS).
 - (k) the operator has provided ASIC the notices and Product Disclosure Statement referred to in subparagraphs (j) before they are sent to members; and
 - (l) the serviced apartment or unit complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in Schedule C.

SCHEDULE C – PROCEDURES FOR TRANSFERRING MANAGEMENT RIGHTS

1. Transfer of management rights

- (a) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme.
- (b) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice.

- (c) A transfer referred to in paragraphs (a) or (b) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in paragraph 2(b) unless the body corporate has consented to the transfer.

2. *Consent of body corporate to new care-taking arrangements*

- (a) If an operator receives a notice under paragraph 1(b) of this Schedule, the operator must advise all body corporate members of the name of the person to whom the transfer is to be made.
- (b) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in paragraph 1(b) of this Schedule if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions.
- (c) If a majority of body corporate members make a decision referred to in paragraph 2(b) of this Schedule, a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with paragraph 1(b) of this Schedule.
- (d) This paragraph 2 does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under paragraph 1(b) or 2(c) of this Schedule before that notice is given to the operator.

3. *Price payable on transfer*

The price scheme members specify in a notice under paragraph 1(b) of this Schedule must be one of the following:

- (a) the average of 2 valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute Inc. (or another relevant independent professional body approved by ASIC); or
- (b) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or
- (c) the highest bona fide amount tendered (excluding any tender by the operator or its associates) for the management rights following reasonable efforts to market the property for at least 60 days.

4. *Voting*

- (a) In determining if there is a majority of scheme members or body corporate members, the operator and its associates and any person nominated as a replacement operator and associates of that person must not be counted.
- (b) For scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have 1 vote.
- (c) For body corporate members, a majority is based on their entitlement to vote at body corporate meetings.
- (d) A scheme member or a body corporate member makes a decision by signing a document that sets out the decision.

5. *Costs*

- (a) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in paragraph 1(a) of this Schedule for the purposes of determining a price to be specified in a notice under paragraph 1(b) of this Schedule.
- (b) If a member incurs any reasonable valuation, auction or marketing costs under paragraph 5(a) of this Schedule that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator.

6. *Assistance*

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings.

7. *Definitions*

In this Schedule:

scheme members means investors in the scheme excluding the operator and its associates;

management rights means all real or personal property (including contractual rights) held by the operator or any of its associates that facilitates the operation of the scheme; and

transfer in relation to management rights means to assign or transfer the management rights or to cause another person to become the holder of those rights or rights substantially the same as those rights.

FFE Fund means a fund established for an investor consisting of money paid by the investor and any interest accrued on that money, to be used from time to time in accordance with the written agreement referred to in paragraph (l) of Schedule B for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit made available by the investor for use as part of the scheme; and

offer is to be interpreted in accordance with subsection 1010C(2) of the Act.

Product Disclosure Statement has the same meaning given under section 761A of the Act.

Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the "Act") the Australian Securities and Investments Commission ("ASIC") declares that Chapter 5C applies to the person in Schedule A in the case set out in Schedule B as if section 601FL of the Act were modified or varied by:

1. omitting from subsection (1) all the text after the word "it" and substituting:

"must either:

- (a) call a members' meeting to explain its reason for wanting to retire and to enable the members to vote on a resolution (which must be an extraordinary resolution if the scheme is not listed) to choose a company to be the new responsible entity; or
- (b) propose a related body corporate to be the new responsible entity in accordance with subsection (1A)."

2. inserting after subsection (1) the following subsection:

"(1A) The requirements for proposing a related body corporate to be the new responsible entity are as follows:

- (a) The responsible entity must give members notice of a proposal to choose a company (the *proposed responsible entity*), which is a subsidiary of the responsible entity's holding company, to be the scheme's new responsible entity; and
- (b) The notice to members must:
 - (i) set out:
 - (A) the responsible entity's reasons for wanting to retire; and
 - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity; and
 - (ii) state prominently that if:
 - (A) members who together hold at least 5% of the total value of the interests held by members; or
 - (B) 100 members,

who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and

- (iii) be accompanied by a form which can be ticked to ask for a vote; and
 - (iv) state prominently a reply paid address of the responsible entity to which the form may be sent; and
- (c) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible; and
- (d) If there is a postal vote:
- (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent; and
 - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
 - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
 - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted; and
- (e) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed."

3. inserting after subsection (2), the following subsections:






