Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 911A(2)(l) and 1020F(1)(a) — Variation

Pursuant to paragraphs 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the Act), the Australian Securities and Investments Commission (ASIC) varies ASIC Instrument [04/1480] dated 25 November 2004, as varied by ASIC Instrument [05/0579] dated 31 May 2005:

- (a) Omit "28 February 2006" and substitute "30 June 2006"; and
- (b) In the preamble, omit "CreditLink Services Limited ACN 087 822 464 (CreditLink)" and substitute "Indue Ltd ACN 087 822 464 (Indue)"; and
- (c) Where the word "CreditLink" otherwise appears, omit it and substitute "Indue"; and
- (d) In the first sentence of Schedule A omit "either or both of"; and
- (e) In Schedule A, omit all of paragraph (a); and
- (f) In Schedule A, omit "(b)" and substitute "(a)"; and
- (g) In paragraph (a) of Schedule B, omit "inform E Com and".

Commencement

This instrument takes effect on gazettal.
