Australian Securities and Investments Commission Corporations Act 2001 – Subsections 655A(1) and 741(1) – Declaration

1. Under subsection 655A(1) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 6 of the Act applies to the persons referred to in Schedule A in the case set out in Schedule C as if section 615 were modified or varied by, after "expenses." inserting on a new line:

"In this section, a *foreign holder* of a company's securities means a holder of the securities with a registered address in a place outside Australia or New Zealand.".

- 2. Under subsection 741(1) of the Act, ASIC declares that Chapter 6D of the Act applies to the person referred to in Schedule B in the case set out in Schedule C as if section 9A were modified or varied as follows:
 - (a) in paragraph (9A)(1)(b) omit "either:", substitute "one of the following is satisfied:"; and
 - (b) at the end of subparagraph 9A(1)(b)(ii) omit "class;", substitute "class; or;"; and
 - (c) after subparagraph 9A(1)(b)(ii) insert:
 - "(iii) if the conditions in subsection (3A) are met–such an offer is made to every person with a registered address in Australia or New Zealand who holds securities in that class;"; and
 - (d) after subsection 9A(3) insert:
 - "(3A) The conditions in this subsection are met if, under the terms of the offer:
 - (a) the body must appoint a nominee for foreign holders of the body's securities who is approved by ASIC; and
 - (b) the body must transfer to the nominee:
 - (i) the securities that would otherwise be issued to the foreign holders who accept the offer; or
 - (iii) the right to acquire those securities; and
 - (c) the nominee must sell the securities, or those rights, and distribute to each of those foreign holders their proportion of the proceeds of the sale net of expenses.

- (3B) Under subsection (3A), a *foreign holder* of a body's securities means a holder of the securities with a registered address in a place outside Australia or New Zealand.".
- 3. Under subsection 741(1) of the Act, ASIC declares that Chapter 6D of the Act applies to the person referred to in Schedule B in the case specified in Schedule C as if section 708AA were modified or varied as follows:
 - (a) in paragraph (2)(f) omit "within the 24 hour period before the offer is made.", substitute "prior to the commencement of trading in that class of securities on the day that is at least 6 business days before the date on which holders of the relevant securities are entitled to participate in the rights issue."; and
 - (b) in paragraph (10)(a) omit "the notice given under subsection (2)", substitute "a notice given under subsection (2) or (12)"; and
 - (c) in subsection (11) omit "the notice under subsection (2)", substitute "a notice given under subsection (2) or (12)"; and
 - (d) omit paragraph (11)(a), substitute:
 - (a) does not comply with paragraph (2)(f) or (12) (as the case may be)"; and
 - (e) after subsection (11) insert:
 - (12) If, at any time, in the period between the notice being given under subsection (2) and the last issue of securities being made under the rights issue, the body becomes aware of:
 - (a) any information that would be excluded information that would need to be included in the notice if the notice had been given at that time and has not been included in the notice; or
 - (b) a material change to:
 - (i) the potential effect the issue of the relevant securities will have on the control of the body; or
 - (ii) the consequences of that effect,

the body must promptly give the relevant market operator a notice that sets out details of the information or material change.".

Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 601QA(1)(b) — Declaration

Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 5C applies to the person specified in Schedule A in its capacity as the responsible entity of the registered schemes specified in Schedule B in the case set out in Schedule C as if section 601FL of the Act were modified or varied as follows:

1. omit from subsection (1) all the text after the word "it" and substitute:

"must either:

 - (i) set out:
 - (A) the responsible entity's reasons for wanting to retire; and
 - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity; and
 - (C) information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur; and
 - (ii) state prominently that if:
 - (A) members who together hold at least 5% of the total value of the interests held by members; or
 - (B) 100 members;

who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and

- (iii) be accompanied by a form which can be ticked to ask for a vote; and
- (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.
- (d) If there is a postal vote:
 - (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent;
 - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
 - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
 - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
- (e) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed."; and
- 3. insert after subsection (2), the following subsections:
 - "(2A) If a postal vote is arranged under paragraph (1A)(c) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.
 - (2B) If:
 - (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and

- (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and
- (c) the entity has consented in writing to becoming the scheme's responsible entity,

then:

- (d) as soon as practicable and in any event within 90 business days after the end of the period in which a member may ask for such a vote, the current responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and
- (e) the notice must be accompanied by a certificate from the current responsible entity that it reasonably considers that the appointment of the proposed responsible entity would be in the best interests of members with a summary of the responsible entity's reasons as to why this is the case; and
- (f) unless ASIC reasonably believes that the appointment of the proposed responsible entity would not be in the best interests of members, ASIC must comply with the notice as soon as practicable after the notice and summary are lodged."
