Australian Securities and Investments Commission Corporations Act 2001 – Subsection 741(1) – Declaration and Exemption

- (b) the person will not disclose the copy of, or information obtained from, the Register to any other person except a person identified in the undertaking by name and address and except solely for the purposes specified in paragraph (a).

 - (iii) an entity in which every interest is jointly held by the scheme or the stapled scheme.
 - (2B) For the purposes of this section:
 - (a) An entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
 - (b) A reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of

the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries."; and

5. after section 601PC, insert:

"601PD For the purposes of sections 601FC, 601FD and 601LC:

stapled security means two or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.".
