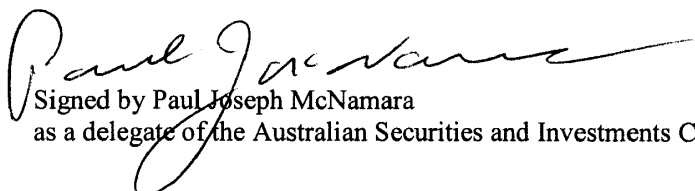

"916EA Licensees acting under authority other than binder

 - (1) Despite section 916D, a financial services licensee (the **authorised licensee**) may be the authorised representative of another financial services licensee who is an insurer, if the authorised licensee acts under a written agreement (**written agreement**) which authorises the authorised licensee to deal in, and provide general advice in relation to, risk insurance products on behalf of the insurer.
 - (2) For all purposes connected with contracts that are risk insurance products, or with claims against the insurer, in respect of which the authorised licensee acts under the written agreement:
 - (a) the authorised licensee is taken to act on behalf of the insurer and not the insured; and
 - (b) if the insured in fact relied in good faith on the conduct of the authorised licensee, the authorised licensee is taken to act on behalf of the insurer regardless of the fact that the authorised licensee did not act within the scope of the authorisation.
 - (3) This section does not apply where the licence of the authorised licensee covers the provision of any financial services in relation to the risk insurance products."

 - (iv) the providing entity is taken to act on behalf of the authorising licensee and not the client; and
 - (v) the authorising licensee is responsible, as between the authorising licensee and the client for the conduct of the providing entity; and".

Revocation

Under paragraphs 283GA(1)(a), 601QA(1)(a), 741(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument [06/0322] dated 28 April 2006 and signed by Rachel Howitt.

Exemption

1. Under paragraphs 741(1)(a) and 1020F(1)(a), ASIC exempts the Issuer from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the Issuer makes:
 - (i) a Share Performance Right Offer;
 - (ii) offers to arrange for the issue of financial products under a Share Performance Right Offer;
 - (iii) issues a financial product under a Share Performance Right Offer,that does not involve a contribution plan, on the conditions set out in the Schedule.
2. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of a Share Performance Right Offer covered by paragraph 1 of this instrument from Part 7.9 where:
 - (a) a recommendation is made that a person to whom a Share Performance Right Offer has been made, acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
3. Under paragraph 911A(2)(l), ASIC exempts the Issuer and any related body corporate of the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with a Share Performance Right Offer covered by paragraph 1 of this instrument where the Share Performance Right Offer Document includes a statement to the effect that any advice given by the Issuer or any related body corporate of the Issuer in connection with a Share Performance Right Offer, is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
4. Under paragraph 911A(2)(l), ASIC exempts:
 - (a) the Issuer; and
 - (b) a related body corporate of the Issuer,from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (c) the provision of a custodial or depositary service in connection with a Share Performance Right Offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and

- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
 - (e) dealing in a financial product in connection with a Share Performance Right Offer covered by paragraph 1 of this instrument, where any acquisition by purchase or disposal of the product (by the Issuer or a related body corporate) occurs either:
 - (i) through a person who holds an Australian financial services license authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraphs 741(1)(a) and 992B(1)(a), ASIC exempts the Issuer from sections 736, 992A and 992AA in relation to a Share Performance Right Offer covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
