Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 601QA(1)(b) — Declaration

Under paragraph 601QA(1)(b) of the Corporations Act 2001 (the Act) the Australian Securities and Investments Commission declares that Chapter 5C applies to the person specified in Schedule A in the case set out in Schedule B until 30 January 2009 as if section 601FL of the Act were modified or varied as follows:

- 1. omit subsection (1) and substitute:
 - "(1) If the responsible entity of a registered scheme wants to retire, it must either:
 - (a) call a members' meeting to explain its reason for wanting to retire and to enable the members to vote on a resolution (which must be an extraordinary resolution if the scheme is not listed) to choose a company to be the new responsible entity; or
 - (b) propose a company (the *proposed responsible entity*) to be the new responsible entity in accordance with subsection (1A).
 - (1A) The responsible entity can retire and the proposed responsible entity can become the new responsible entity if all of the following requirements are met:
 - (a) the proposed responsible entity must provide its consent in writing to become the scheme's responsible entity;
 - (b) the responsible entity must provide the member with:
 - (i) notice of a proposal to choose the proposed responsible entity to be the scheme's new responsible entity; and
 - (ii) sufficient information to explain its reason for wanting to retire and to enable the member to decide whether to consent to the appointment of the proposed responsible entity as the new responsible entity;
 - (c) the member must consent in writing to the retirement of the responsible entity and choose the proposed responsible entity to be the new responsible entity;

- (d) as soon as practicable and in any event within 2 business days after the member has given its written consent, the responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and
- (e) ASIC must comply with the notice when it is lodged.".
- 2. In subsection (2), omit "If" and substitute "Where subsection (1A) does not apply, if".
