Australian Securities and Investments Commission Corporations Act 2001 – Subsection 741(1) Exemption

Pursuant to subsection 741(1) of the Corporations Act 2001 (the **Act**) the Australian Securities and Investments commission (**ASIC**) hereby exempts the person referred to in Schedule A from Parts 6D.2 and 6D.3 (except section 736) and Part 7.9 of the Act in the case referred to in Schedule B on the conditions set out in Schedule C and for so long as those conditions are met.

SCHEDULE A - PERSONS EXEMPTED

UNITAB Limited ACN 085 691 738 (the Issuer)

SCHEDULE B - CASE EXEMPTED

This exemption applies to an offer of securities for issue which is an offer for issue of fully paid ordinary shares in the Issuer for no monetary consideration and which meets the further requirements set out in Schedule C.

SCHEDULE C - CONDITIONS

An offer or issue to which this exemption applies must, insofar as it constitutes, includes or may result in the issue of shares, meet the following requirements.

- 1. The shares the subject of the offer must be ordinary shares in the Issuer which have been quoted on the ASX throughout the 12 month period immediately preceding the offer without suspension during that period exceeding in total 2 trading days.
- 2. The offer must be made pursuant to an employee share scheme extended only to persons (offerees) who at the time of the offer are full time, part time and casual employees of the Issuer or its associated bodies corporate for a continuous period of twelve months prior to the issue.
- 3. The employee share scheme must not involve:
 - (a) a contribution plan; or
 - (b) any offer, issue or sale being made through a trust.
- The employee share scheme must provide as follows:
 - the offer must be in writing (the offer document) and the offer document must include
 or be accompanied by a copy, or a summary, of the rules of the employee share
 scheme pursuant to which the offer is made;
 - (b) if the offer document includes or is accompanied by a summary (rather than a copy) of the rules of the employee share scheme, the offer document must include an undertaking that during the period or periods during which the offeree may acquire the shares offered or subject to the offer period, the Issuer will, within a reasonable period of the offeree so requesting, provide the offeree without charge with a copy of the rules of the employee share scheme;
 - (c) the offer document must specify in respect of the shares offered:
 - (i) the acquisition price in Australian dollars of the shares;
 - (ii) or where the acquisition price of the shares is determinable at some future time by reference to a formula, the Australian dollar or Australian dollar equivalent of the acquisition price where that formula applied as at the date of the offer;

- (d) the offer document must include an undertaking and an explanation of the way in which the Issuer will, during the offer period, within a reasonable period of the offeree so requesting, make available to the offeree the following information:
 - (i) the current market price of shares in the same class as the shares offered; and
 - (ii) where paragraph (c)(ii) applies, the information referred to in that paragraph as updated to that date; and
- (e) if the Issuer or any associated body corporate of it offers the offeree a loan or other financial assistance for the purpose of acquiring the shares offered, the offer document must disclose the conditions, obligations and risks associated with such loan or financial assistance.
- 5. In the case of an offer of shares for issue, the number of shares the subject of the offer or to be received on exercise of an option when aggregated with:
 - (a) the number of shares in the same class which would be issued under each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme extended only to employees or directors of the Issuer and of associated bodies corporate of the Issuer, to be accepted or exercised (as the case may be); and
 - (b) the number of shares in the same class issued during the previous five (5) years pursuant to the employee share scheme or any other employee share scheme extended only to employees or directors of the Issuer and of associated bodies corporate of the Issuer:

but disregarding any offer made, or option acquired or shares issued by way of or as a result of:

- (a) an offer to a person situated at the time of receipt of the offer outside Australia; or
- (b) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as it stood prior to the commencement of Schedule 1 to the Corporate Law Economic Reform program Act 1999; or
- (c) an offer that did not need disclosure to investors because of section 708 of the Act; or
- (d) an offer made to an employee under a prospectus lodged with ASIC; or
- (e) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (f) an offer made under a disclosure statement or Product Disclosure Statement,

must not exceed 5% of the total number of the Issuer issued shares in that class at the time of the offer.

SCHEDULE D - CONDITIONS

- 6. the Issuer upon making the offer under the employee share plan, provide ASIC with a copy of the offer document and accompanying document(s) not later than 7 days after the provision of that material to the relevant offerees; and
- The Issuer will comply with any undertaking required to be made in the offer document by reason of this instrument.

Interpretation

For the purpose of this instrument:

- A. The offer of the employee share scheme is to be extended to persons who at the time of the offer are employees of the Issuer and its associated bodies corporate being full time employees, part-time employees and casual employees of the Issuer and its associated bodies corporate for a continuous period of twelve (12) months prior to the issue.
- B. A body corporate is an associated body corporate of the Issuer if:
 - I. the body corporate is a related body corporate of the Issuer; or
 - II. the body corporate has voting power in the Issuer of not less than 20%; or
 - III. the Issuer has voting power in the body corporate of not less than 20%; (applying the definition of "voting power" contained in section 610 of the Act)
- C. The Australian dollar equivalent of a price shall be calculated by reference to the relevant exchange rate published by an Australian bank on the previous business day.
- D. An employee share scheme shall not be regarded as extended to a person other than an employee or director of the Issuer or an associated body corporate of the Issuer merely because such an employee or director may renounce an offer of share made to them under the scheme in favour of a nominee.
- E. The current market price of a share shall be taken as the price published by the principal exchange on which the share is quoted as the final price for the previous day on which the share was traded on the stock market of that exchange.

SUBSECTION 741(1)

EXEMPTION AND DECLARATION

Pursuant to subsection 741(1) of the Corporations Act 2001 (the "Act"), the Australian Securities and Investments Commission ("ASIC") exempts the persons specified in Schedule A in the case specified in Schedule B from all of the provisions of Divisions 3, 4 and 5 of Part 6D.2 of the Act (other than section 718) and from paragraphs 728(1)(b) and 728(1)(c), 728(3)(b), 730(1)(b) and 730(1)(c) and sections 734 and 735 of the Act.

And further pursuant to subsection 741(1) of the Act ASIC declares that Chapter 6D of the Act applies in relation to the persons specified in Schedule A in the case specified in Schedule B as if section 718 were modified or varied by omitting that section and substituting the following:

"The issuer must lodge the following documents with ASIC not later than 7 days after the making of the offer for issue of options to acquire, by way of issue, shares in the issuer:

- a copy of the notice or disclosure document issued in relation to the options (which copy may leave blank offeree particulars including entitlement particulars); and
- (ii) a statement disclosing the number and percentage of persons to whom offers are being made whose addresses are places within this jurisdiction."

SCHEDULE A

Infratil Limited, a company incorporated in New Zealand, the ordinary shares of which have been quoted on the New Zealand Exchange throughout the 36 month period preceding the offer (the "Issuer") and an associate of the issuer.

SCHEDULE B

An offer for issue of options to acquire, by way of issue, shares in the issuer (the "options") and any issue of shares in the issuer upon the exercise of the options:

- (a) which offer is made pro rata to each holder of shares of the same class as those shares to be issued upon exercise of the options (whether on a renounceable or non-renounceable basis):
- (b) in respect of which the terms and conditions of each offer made to an offeree whose address, as shown in the register of members, is a place within this jurisdiction (an "Australian shareholder") are not less favourable than those extended to other offerees;
- (c) in respect of which the aggregate exercise price of the options offered to Australian shareholders is not more than 10% of the aggregate exercise price of all of the options offered to offerees:
- (d) being an offer of options to acquire, by way of Issue, shares in the issuer which will be in the same class as shares which at the time of the offer are quoted on the New Zealand Exchange and trading in which is not suspended;
- (e) in respect of which each Australian shareholder is given the same access as other offerees to written information (or where applicable an English translation of such information) pertaining to the offer; and
- (f) which complies with all legislative requirements in New Zealand and the operating rules of the New Zealand Exchange.

INTERPRETATION

For the purposes of this instrument:

An offer for issue of options made by the issuer to its shareholders shall be regarded as pro rata notwithstanding that:

- (a) fractional entitlements are rounded up or down;
- (b) a shareholder whose pro rata entitlement is less than a marketable parcel is offered a marketable parcel of the minimum possible size; or
- (c) an offer is not made to a shareholder (not being an Australian shareholder) whose address as shown in the register of members is a place outside New Zealand.

The relevant ordinary shares shall be taken to have been quoted on the New Zealand Exchange throughout the 36 month period preceding the offer if and only if:

- (a) the shares were first quoted on that market (irrespective of whether it was then known by another name) not less than 36 months prior to that offer; and
- (b) during that 36 month period those shares have been suspended from trading on that market for an aggregate period of not more than 5 trading days.

Shares shall not be taken to be in different classes merely because of a temporary difference in the dividend or distribution rights attaching to the shares.

 - (i) each document is given to the client at the same time; and
 - (ii) each document refers to each other document.

If there are or may be different versions of a document of the kind referred to in paragraph (b), the reference required by subparagraph (b)(ii) does not have to identify any particular one of those versions and may instead identify the document generically.";

(e) omit the definitions of "new disclosure financial products", "new product disclosure provisions", "old Corporations Act" and "operator", substitute:

""operator" means a holder of a financial services licence that includes a condition requiring the holder to comply with the requirements of this instrument, who contracts with a client for the provision of the IDPS or a function that forms part of the IDPS.";

- (f) in the definition of "regular savings plan":
 - (i) omit paragraphs (a) to (c), substitute:
 - "(a) the client instructs the operator to acquire specified accessible financial products by way of periodic payments of a specified amount and at specified intervals (each such acquisition is referred to below as a "regular savings acquisition");
 - (b) the client acknowledges that under the regular savings plan a regular savings acquisition of an accessible financial product may occur without the client having been given a current Product Disclosure Statement or Supplementary Product Disclosure Statement (each a "missing document") in relation to the accessible financial product;
 - (c) the operator agrees to give to the client any missing document relating to an accessible financial product (unless this would not be required under this instrument if the acquisition were not under a regular savings plan) that may be acquired under the regular savings plan as soon as reasonably practicable and in any event by the fifth business day after the issue of the document; and"; and
 - (ii) omit paragraph (f) and all the following text, substitute:
 - "(f) has been given advice quarterly in writing,

to the effect that the client may not have the current Product Disclosure Statement for an accessible financial product at the time a regular savings acquisition of the accessible financial product is made.";
