**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a),  
1020F(1)(a) and 1020F(1)(b) – Exemptions**

1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the Issuer from Parts 6D.2 and 6D.3 (except section 736) and Part 7.9 where the Issuer:
    - (a) makes an eligible offer; or
    - (b) offers to arrange for the issue of financial products under an eligible offer; or
    - (c) issues a financial product under an eligible offer;on the conditions set out in the Schedule and for so long as the conditions are met.
  2. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 where:
    - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made, acquire the financial product as a retail client; and
    - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
  3. Under paragraph 911A(2)(l), ASIC exempts the Issuer and any related body corporate of the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document includes a statement to the effect that any advice given by the Issuer or any related body corporate of the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
  4. Under paragraph 911A(2)(l), ASIC exempts:
    - (a) the Issuer; and
    - (b) any related body corporate of the Issuer,from the requirement to hold an Australian financial services licence for the provision of the following financial services:
    - (c) the provision of a custodial or depositary service in connection with an
-

eligible offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and

- (d) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (c); and
  - (e) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument, where any acquisition by purchase or disposal of the product (by the Issuer or a related body corporate) occurs either:
    - (i) through a person who holds an Australian financial services license authorising the holder to deal in financial products; or
    - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraphs 741(1)(a) and 992B(1)(a), ASIC exempts the Issuer from sections 736, 992A and 992AA in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

#### Schedule

The following conditions apply:

1. An independent expert retained by the Issuer has advised the Issuer that the exchange ratios will result in the fair value, using standard valuation techniques, of the Replacement Options being approximately equal to the fair value of the Eligible Options that are exchanged (based on valuation assumptions made when the eligible offer commences);
  2. the Issuer must:
    - (a) include the offer in an offer document; and
    - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
    - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
  3. the Issuer must comply (or cause a related body corporate which has a registered office in this jurisdiction to comply) with any undertaking required to be made in the offer document by reason of this instrument;
-

3. the Issuer must take reasonable steps to ensure that the number of Shares to be issued on the exercise of an Option when aggregated with:
- (a) the number of Shares in the same class which would be issued were each outstanding offer with respect to Options under an employee share scheme to be accepted or exercised; and
  - (b) the number of Shares in the same class issued by the Issuer during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the Issuer,
- but disregarding any offer made, or option or right acquired or share issued by way of or as a result of:
- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
  - (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
  - (e) an offer that did not need disclosure to investors because of section 708; or
  - (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
  - (g) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

### Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act.
  2. an employee incentive scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee.
  3. ***Australian dollar equivalent*** in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates.
  4. ***current market price*** means in relation to a Share, the price published by NASDAQ Global Select Market on which the Share is quoted as the final price for the previous day on which the Share was traded on NASDAQ Global Select Market.
-

5. **eligible employee** means a person who is at the time of an offer, a full or part-time employee or director of the Issuer or of a related body corporate of the Issuer.
  6. **Eligible Option** means an option issued prior to the offer of a Replacement Option for which an eligible offer is to be made.
  7. **eligible offer** means an offer of a Replacement Option under an employee incentive scheme extended only to eligible employees.
  8. **employee incentive scheme** means a scheme under which Options may be acquired by, or for the benefit of an eligible employee on the terms and conditions of any of the following plans:
    - a. 2005 Long-Term Equity Incentive Plan;
    - b. Amended and Restated Key Employee Stock Option Plan – 1994; or
    - c. 1991 Company-Wide Stock Option Plan.
  9. **exchange ratio** means the number of Eligible Options to be exchanged for each Replacement Option, expressed as a ratio.
  10. **expert** has the meaning given by section 9.
  11. **financial product advice** has the meaning given by section 766B.
  12. **general advice** has the meaning given by section 766B.
  13. **Issuer** means Starbucks Corporation, a body corporate incorporated under the law of Washington.
  14. **offer** has a meaning affected by sections 700, 702 and 1010C.
  15. **offer document** means a document setting out an offer of a Replacement Option under an employee incentive scheme that:
    - (a) includes or is accompanied by a copy, or a summary, of the rules of the employee incentive scheme; and
    - (b) if a summary (rather than a copy) of the rules of the employee incentive scheme is given - includes an undertaking that during the period (the **offer period**) during which an eligible employee may acquire the financial products offered under the employee incentive scheme, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the employee incentive scheme; and
    - (c) specifies in respect of the Shares that may be acquired on exercise of an Option:
-

- (i) the acquisition price (if any) in Australian dollars; or
  - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
  - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which, the Issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
- (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of Shares that will be acquired by the eligible employee when the Option offered to the eligible employee is exercised;
  - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date;
- (e) describes the offer to exchange Eligible Options for Replacement Options;
- (f) states that the exchange ratios were designed to result in a fair value of the Replacement Options that is approximately equal to the fair value of the Eligible Options that are exchanged and sets out an explanation as to why the Issuer considers this to be true.
14. **Option** means:
- (a) an option to acquire, by way of issue or transfer a Share in accordance with the terms and conditions of grant (as defined in the rules of the employee incentive scheme); or
  - (b) where the option referred to in paragraph (a) has been exercised but the Share to which the option relates has not been issued or transferred to the eligible employee, an equitable interest in a Share,
- where:
- (c) each option is offered for no more than the value, if any, of the forfeiture or release of rights under an Eligible Option; and
  - (d) the Share to which the option relates is in the same class as fully-paid common stock in the Issuer that have been quoted on the NASDAQ Global Select Market throughout a 12 month period without suspension for more than a total of 2 trading days during that period immediately before the option can be exercised under the offer
- and includes an Eligible Option and a Replacement Option.
15. **related body corporate** has the meaning given by section 50.
-

16. **Replacement Option** means an option to replace an Eligible Option, in consideration for the forfeiture or release of rights under that Eligible Option.
17. **Share** means a fully-paid share of common stock in the Issuer.

**Australian Securities and Investments Commission  
Corporations Act 2001 – Subsection 601QA(1) – Exemption and Declaration**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)* the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from paragraph 601FC(1)(d) of the Act in relation to allowing a member of a NMF Fund to withdraw in accordance with section 601KEA of the Act as notionally inserted by this instrument.
2. Under paragraph 601QA(1)(b) of the Act ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if Part 5C.6 of the Act were modified or varied as follows:

(a) after subsection 601KA(3), insert:

“(3AA) Subsection (3) does not apply to withdrawal in accordance with section 601KEA.”

(b) after subsection 601KE, insert:

**“601KEA Hardship Withdrawals**

*Power to allow withdrawal in case of member hardship*

(1) The responsible entity of a registered scheme may allow a member to withdraw from the scheme in accordance with a provision of the scheme’s constitution that provides for the member to have a right to withdraw when the responsible entity is satisfied that the member has experienced hardship or is likely to experience hardship or, where the member is an operator, a person who has asked the operator (whether directly or through another one or more operators) to exercise a right to withdraw has experienced hardship or is likely to experience hardship if the operator is not allowed to withdraw (a *hardship withdrawal*).

(1A) In this section an *operator* means a person who is a member of the scheme in its capacity as responsible entity or custodian of a registered scheme, a life company, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the *Superannuation Industry (Supervision) Act 1993*, trustee of a self-managed superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* or provider or acquirer in relation to a custodial arrangement as defined in section 1012IA.

(2) The responsible entity may only allow one hardship withdrawal because of the hardship of a person, and must not allow a hardship withdrawal unless the responsible entity is satisfied that:

- (a) following that withdrawal the scheme property would include sufficient liquid assets for the day to day operation of the scheme; and
- (b) satisfying the hardship withdrawal request would not breach the person's hardship withdrawal cap; and
- (c) any amount paid on withdrawal to an operator will be paid to the person who asked the operator to make a hardship withdrawal request after deduction of any fees and charges payable to the operator.

Note: In making any payment to a person on whose behalf a request for hardship withdrawal has been made, an operator must comply with any obligations under the terms of the relevant trust or arrangement under which it acts and other applicable laws. For example the responsible entity of a registered scheme must comply with Part 5C.6 as modified by any relief applicable to that scheme and the trustee of a superannuation entity or self managed superannuation fund must comply with requirements under the Superannuation Industry (Supervision) Act 1993.

(3) For the purposes of this section the *hardship withdrawal cap* for a person is the lesser of:

- (a) the specific amount the subject of a hardship withdrawal request in respect of hardship of the person; and
- (b) \$20,000 plus 50% of the balance of the person's interest in the scheme, however held.

(4) If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship withdrawal the responsible entity must comply with subsections (5) to (7).

*Exercise of discretion must be reasonable*

(5) The responsible entity or its nominee must act reasonably in exercising a discretion covered by subsection (4).

Note: The responsible entity is also subject to its general duties under section 601FC including the duty to act in the best interests of the members of the scheme.

*Documentation of exercise of discretion*

(6) The responsible entity must ensure that the records which it keeps under section 988A document how and why a decision to permit or refuse a hardship withdrawal was made.

*Access to and retention of documents*

(7) The responsible entity must retain the documents covered by subsection (6) for 7 years after they cease to be current."



1	Severe Financial Hardship	The amount requested is needed to enable the member to meet reasonable and immediate living expenses for themselves or their dependants.
2	Compassionate Grounds	<p>The amount requested is needed by the member (or a member's dependant):</p> <ul style="list-style-type: none"> <li>(a) to help pay for medical costs (and transport costs) required to treat a life-threatening illness or injury, to alleviate acute or chronic pain, or to alleviate an acute or chronic mental disturbance where 2 registered medical practitioners (at least one of whom must be a specialist) have provided certified statements confirming the medical condition to this effect;</li> <li>(b) to fund specific modifications (to a principal place or residence or vehicle) that are necessary to accommodate special needs arising from a severe disability;</li> <li>(c) to assist with funeral and other expenses related to the death of the former member or a former dependant of the member;</li> <li>(d) to enable the member to provide care for a person who is dying from a terminal illness, including home care;</li> <li>(e) to prevent a member's mortgagee (lender) from selling the member's principal place of residence; or</li> <li>(f) to meet expenses in other cases consistent with grounds mentioned in (a) – (e),</li> </ul> <p>where the member does not otherwise have the financial capacity to meet the expense.</p>
3.	Permanent Incapacity	Where a member has ceased gainful employment by reason of mental or physical ill-health and the responsible entity is satisfied that the member is unlikely ever again to engage in gainful employment of the type for which the member is reasonably qualified by education, training or experience.

Corporations Act 2001 – Paragraph 741 – Exemption**

Under paragraph 741(1) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts GWA International Limited ACN 055 964 380 (*Issuer*), from Parts 6D.2 and 6D.3 of the Act (other than sections 736 and 738), in the case specified in Schedule A

**Schedule A**

A written offer for the issue of shares in the Issuer where the following requirements are met at the time that the offer is made:

- (a) The shares are in a class quoted on the financial market operated by ASX Limited ACN 008 624 691 (*class*) and trading in the class is not suspended.
- (b) None of the following provisions of the Act have been contravened in relation to the Issuer in the previous 12 months:
  - (i) a provision of Chapter 2M;
  - (ii) section 674 or 675;
  - (iii) section 724; and
  - (iv) section 728.
- (c) The offer is made pursuant to an arrangement under which:
  - (i) an offer is made to each registered holder of shares in the class, and whose address (as recorded in the register of members) is in a place in which it is lawful and practical for the Issuer to offer and issue shares to that person, in the reasonable opinion of the Issuer;
  - (ii) each offer is made on the same terms and conditions and on a non-renounceable basis;
  - (iii) the issue price is less than the market price during a specified period in the 30 days prior to either the date of the offer or the date of the issue;
  - (iv) no registered holder may be issued ordinary shares with an application price totalling more than \$10,000 in any consecutive 12 month period; and
  - (v) a registered holder must provide the Issuer on application for the ordinary shares with a certification to the effect that the aggregate of the application price for:
    - (A) the shares the subject of the application; and

- (B) any other shares in the class applied for by the holder under the arrangement or any similar arrangement in the 12 months prior to the application,
- does not exceed \$10,000.
- (d) The written offer document contains the following information:
- (i) the method used to calculate the issue price and the time when this price will be determined;
  - (ii) a statement describing the relationship between the issue price and the market price; and
  - (iii) disclosure of the risk that the market price may change between the date of the offer and the date when the shares are issued to an applicant under the arrangement, and the effect this would have on the price or value of the shares which the applicant would receive.
- (e) Before the offer is made, the Issuer gives ASX Limited ACN 008 624 691 (**ASX Limited**) a notice that:
- (i) states that the Issuer will be issuing the shares without disclosure to investors under Part 6D.2 of the Act; and
  - (ii) states that the notice is being given in accordance with this exemption; and
  - (iii) states that, as at the date of the notice, the Issuer has complied with:
    - (A) the provisions of Chapter 2M of the Act as they apply to the Issuer; and
    - (B) section 674 of the Act; and
  - (iv) sets out any information that is excluded information as at the date of the notice (in accordance with the requirements of subsections 708A(5) and (6) of the Act as if the notice were a notice under paragraph 708A(5)(e) of the Act).
- (f) If, at any time in the period (**relevant period**) between the date the notice was given under paragraph (e) and the last issue of securities made under the offer, the Issuer becomes aware of:
- (i) any information that would be excluded information that would need to be included in the notice if the notice had been given at that time and that has not been included in the notice or otherwise provided to ASX Limited; or
  - (ii) a material change to:

- (A) the potential effect the issue of the relevant securities will have on the Issuer; or
- (B) the consequences of that effect,

the Issuer must, as soon as is practicable but in any event before the end of the relevant period, give ASX Limited a notice that sets out details of the information or material change.

### Interpretation

For the purposes of this instrument:

1. **registered holder** means, subject to paragraphs 2 and 3 below, a person recorded in the register of members of the Issuer;
2. if 2 or more persons are recorded in the register of members as jointly holding ordinary shares or partially protected shares, they are taken to be a single registered holder and a certification by any of them for the purposes of paragraph (c)(v) of this Schedule is taken to be a certification by all of them;
3. if a trustee or nominee is expressly noted on the register of members as holding shares on account of another person (**beneficiary**):
  - (a) the beneficiary is taken to be the registered holder in regard to those ordinary shares; and
  - (b) any application for the issue of shares or certification for the purposes of paragraph (c)(v) of this Schedule by, and any issue of shares to, the trustee or nominee, is taken to be an application or certification by, or an issue to, the beneficiary.
4. references to the Issuer offering shares include the Issuer inviting applications for the issue of the shares.

  - (a) paragraph 949A(2)(c) of the Act; and
  - (b) Division 2 of Part 7.7 of the Act, in the case specified in Schedule B.
3. Under paragraph 1020F(1)(a) of the Act, ASIC exempts the persons specified in Schedule A from complying with Division 5A of Part 7.9 of the Act in the case specified in Schedule C.

2. Under paragraph 601QA(1)(b) of the Act ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if Part 5C.6 of the Act were modified or varied as follows:

(a) after subsection 601KA(3), insert:

“(3AA) Subsection (3) does not apply to withdrawal in accordance with section 601KEA.”

(b) after subsection 601KE, insert:

**“601KEA Hardship Withdrawals**

*Power to allow withdrawal in case of member hardship*


