1. Under paragraph 911A(2)(l) of the *Corporations Act 2001* (Act), the Australian Securities and Investments Commission (ASIC) exempts Hillcrest Litigation Services Limited ACN 060 094 742 (Hillcrest) from the requirement to hold an Australian financial services licence for dealing in and giving financial product advice in relation to a litigation funding agreement on the conditions set out in the Schedule, for so long as those conditions are met.
2. Under paragraph 992B(1)(a) of the Act, ASIC exempts Hillcrest from section 992A of the Act in relation to an offer to issue a litigation funding agreement made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer, on the conditions set out in the Schedule, for so long as those conditions are met.
3. Under paragraph 1020F(1)(a) of the Act, ASIC exempts Hillcrest from Part 7.9 of the Act in connection with a recommendation to acquire, or an offer or issue of, or making an offer to arrange the issue of, a litigation funding agreement on the conditions set out in the Schedule, for so long as those conditions are met.

Schedule

1. Hillcrest ensures that a litigation funding agreement is given personally to each individual retail client or to each director of a corporate retail client before they enter into the agreement, where the written agreement includes the following disclosures:
 - a. Information about any significant benefits which will or may accrue to a client as a result of entering into a litigation funding agreement, the circumstances in which and times at which those benefits will be provided and the way in which those benefits will be provided;
 - b. Information about any risks involved in entering into a litigation funding agreement;

 - d. if the litigation funding agreement will generate a return to the client - information about any commission, or other similar payments, that will or may impact on the amount of such return;

- e. information about any other significant characteristics or features of the litigation funding agreement or of the rights, terms, conditions and obligations under the agreement; and
 - f. information about the dispute resolution system that covers complaints made by clients and how that system can be accessed.
2. Hillcrest establishes and maintains an internal dispute resolution system that complies with the Australian Standard on Complaints Handling AS4269-1995 that covers complaints made by retail clients against the person in connection with a litigation funding agreement.



Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the persons referred to in Schedule A from the requirement to hold an Australian financial services licence (*AFSL*) for dealing in and providing financial product advice in relation to a financial product referred to in Schedule B in the case referred to in Schedule C.

Under paragraph 926A(2)(c) of the Act, ASIC declares that Part 7.6 of the Act applies in relation to the financial product in Schedule B in the case referred to in Schedule D as if the provisions of the Part were modified or varied by adding after paragraph 911A(2)(j):

- "(ja) the service is dealing in a financial product or providing financial product advice in relation to a unit of an interest in a registered managed investment scheme;"

Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies to the persons referred to in Schedule A in relation to the financial product referred to in Schedule B in the case referred to in Schedule C as if section 761E were modified or varied by adding the following after subsection (4):

- "(4A) In Part 7.9, the responsible entity of the registered scheme is taken to be the *issuer*, in relation to interests in interests in the registered scheme. For the avoidance of doubt, in Part 7.9 no other person is the issuer of the financial product.";

Under paragraph 1020F(1)(a) of the Act, ASIC exempts Stockland Funds Management Limited ACN 078 081 722 as responsible entity of the Stockland Direct Office Trust No.2 ARSN 115 017 466 (the *Trust*) from subparagraph 1012B(3)(a)(iii) of the Act in the case referred to in Schedule E.

The issue by SFML as responsible entity of the Trust of an interest in the Trust to holders of Instalment Receipts where:

transaction costs means, in relation to the acquisition of an interest in the scheme or a withdrawal request, the amount that is included in the price at which the interest is acquired or has been deducted from the amount that would otherwise be paid in meeting the request that is reasonably attributable to the expenses associated with the acquisition or disposal of scheme assets merely because the interest has been acquired or the withdrawal request is met."



Declaration**

Pursuant to subsection 655A(1) of the Corporations Act 2001 (Cth) ("**Act**"), the Australian Securities and Investments Commission ("**ASIC**") hereby declares that Chapters 6 and 6C of the Act apply to the person referred to in Schedule A in the case referred to in Schedule B as if section 609 were modified or varied by inserting after subsection 609(2) the following subsections:

"(2A) For the purposes of subsection (2B):

CREST means the system for paperless settlement of trades and holdings of uncertificated securities administered by CRESTCo Limited in the United Kingdom; and

depository interest means an uncertificated interest in a security.

(2B) Subsection (2) applies to a person (the *trustee*) who would otherwise have a relevant interest in securities because the trustee holds the securities as the trustee of a trust established pursuant to a deed poll (the *deed poll*) under which depository interests are issued for the purpose of satisfying rights or obligations of the holder of depository interests despite:

- (a) the trustee having any of the following discretions under the terms of the deed poll which give it the power to dispose of, or control the exercise of a power to dispose of the underlying securities to which the depository interests relate:
 - (i) discretions where depository interests are owned directly or beneficially by any person in circumstances where in the opinion of the trustee the trustee or its custodian might suffer any liability to taxation or pecuniary, fiscal or material regulatory disadvantage which it might not otherwise have suffered; or






