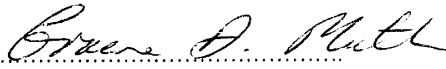

**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 911A(2)(l) — Exemption**

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts R G Mutual Limited ACN 078 766 542 (the *Company*) from the requirement to hold an Australian financial services licence for dealing in general insurance products (the *relevant financial service*) in the case specified in Schedule A on the conditions specified in Schedule B and for so long as those conditions are met.

Schedule A

Where the Company provides the relevant financial service only to entities in the J & P Richardson Group, which are members of the Company (the *members*), and all of the following apply:

- (a) Mr Joe Harry Richardson and Mrs Patricia Edith Richardson have voting power of at least 50% in aggregate in the Company and each of the members; and
- (b) the relevant financial services are provided to the members as wholesale clients; and
- (c) the relevant financial services must not constitute a significant part of the business of the members; and
- (d) no other entity aside from Mr Joe Harry Richardson and/or Mrs Patricia Edith Richardson has control over the Company and the members.

Schedule B

On each occasion prior to providing the relevant financial services to the members, the Company must notify the members that it is exempt from the requirement to hold, and does not hold, an Australian financial services licence.

Interpretation

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraphs 655A(1)(a) and 673(1)(b) – Exemptions**

Under paragraphs 655A(1)(a) and 673(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the persons mentioned in Schedule A (collectively, the *Brokers*) in the case mentioned in Schedule B, to the extent and on the conditions set out below.

First exemption

The Brokers are exempt from section 606 of the Act in relation to the acquisitions mentioned in Schedule B, and the Associates are exempt from section 606 in relation to any voting power conferred on them by interests held by the Broker pursuant to such acquisitions, on the following conditions:

- (a) The Brokers dispose of their interest in any of the Shares acquired in reliance on this exemption within 14 days after acquisition;
- (b) The Brokers do not sell a Share to a person if they know or believe that person would contravene section 606 by acquiring the Share;
- (c) The Brokers do not exercise any voting rights attaching to the Shares at any time while holding the Shares, without ASIC's consent;
- (d) The Brokers do not at any time have more than 3% of the Shares on issue in reliance on this exemption;
- (e) The Brokers use their best endeavours to obtain as wide a placement of the Shares as practicable;
- (f) The Brokers gives ASIC on or about 31 January 2008:
 - (i) a list, in chronological order, of each acquisition made in reliance on, and disposal effected to comply with this exemption up to and including 24 January 2008, and in relation to each such acquisition or disposal:
 - (A) the date, time and method of acquisition or disposal;
 - (B) the name of the person (if known) from whom the interests were acquired or to whom the interests were disposed of;
 - (C) the number of interests and percentage of the total issued interests acquired or disposed of; and
 - (D) the number of interests and percentage of the total issued interests in which the Brokers had a relevant interest immediately before and after the acquisition or disposal; and
 - (ii) a written report setting out any other matters which, in the view of the Brokers, may be of relevance to ASIC in understanding how this exemption

has, to the date of the report, assisted the Brokers in facilitating the acquisition and disposal of the Shares by their institutional clients.

Second exemption

The Brokers and the Associates are exempt from Chapter 6C (only in respect of any voting power conferred on them by interests held by the Brokers in relation to Shares acquired under to this exemption), in relation to:

- the acquisitions mentioned in Schedule B; and
- any Share which is sold before 9.30 am on the third business day after its acquisition (a *Sold Share*).

This exemption is given on condition that, if at 9:30 am on the third business day after any acquisition the Broker is entitled to more than 5 per cent of all the Shares, the Broker then complies with Chapter 6C in relation to that entitlement.

For the purposes of the conditions, treat the Broker as no longer being entitled to a Sold Share, if the Broker has agreed to sell the Share under a contract, which is subject to no conditions which would not be implied into an open contract entered into on the financial market operated by ASX Limited, other than a condition postponing settlement until completion of the acquisition mentioned in Schedule B.

**Australian Securities and Investments Commission
Corporations Act 2001 - Subsection 741(1) – Exemption & Declaration**

1. Under paragraph 741(1)(a) of the *Corporations Act 2001* (“the Act”) the Australian Securities and Investments Commission (“ASIC”) hereby exempts the person specified in Schedule A, in the case referred to in Schedule B, from compliance with Parts 6D.2 and 6D.3 of the Act.
2. Under paragraph 741(1)(b) of the Act, ASIC hereby declares that Chapter 6D of the Act applies to the persons specified in Schedule C in the case referred to in Schedule D, as if section 707 were modified or varied by omitting subsections 707(3), (4), (5) and (6) and substituting:

“(5) An offer of a body's securities for sale within 12 months after their sale by a person who controlled the body at the time of the sale needs disclosure to investors under this Part if:

- (a) at the time of the sale by the controller either:
 - (i) the securities were not quoted; or
 - (ii) although the securities were quoted, they were not offered for sale in the ordinary course of trading on a relevant financial market on which they were quoted; and
- (b) the controller sold the securities without disclosure to investors under this Part; and
- (c) the controller sold the securities with the purpose of the person to whom they were sold:
 - (i) selling or transferring the securities; or
 - (ii) granting, issuing or transferring interests in, or options or warrants over the securities;

and section 708 does not say otherwise.

- (6) Unless the contrary is proved, a person who controls a body is taken to sell securities with the purpose referred to in paragraph (5)(c) if any of the securities are subsequently sold, or offered for sale, within 12 months after their sale by the controller.”

Exemption

1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the "Act") the Australian Securities and Investments Commission ("ASIC") exempts the persons specified in Schedule A from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the persons:
 - (a) make an eligible offer;
 - (b) offer to arrange for the issue of financial products under an eligible offer;
 - (c) issue a financial product under an eligible offer,
 - (d) issue a financial product on the vesting of a Performance Right that was issued under an eligible offer,
on the conditions set out in Schedule B and for so long as the conditions are met; and

2. Under paragraph 1020F(1)(b) ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably be aware, that any of the conditions set out in the Schedule have not been met; and

3. Under paragraph 911A(2)(l) ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of the exemption in paragraph 1 (other than because the person made a recommendation to acquire financial products) from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in that exemption (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice; and

4. Under paragraph 911A(2)(l) ASIC exempts a person specified in Schedule A from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (a) the provision of a custodial or depository service in connection with an eligible offer covered by the exemption in paragraph 1 where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and

- (b) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (a); and
- (c) dealing in a financial product in connection with an eligible offer covered by the exemption in paragraph 1 where any acquisition by purchase or disposal of the product (by a person specified in Schedule A) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place; and

5. Under paragraphs 741(1)(a) and 992B(1)(a) ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of exemptions in paragraph 1 from sections 736, 992A and 992AA in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

6. on behalf of the Issuer, Manager and Custodian, Rexel Australia must accept notices, correspondence and service of process at a registered office or principal place of business in Australia; and
 7. Rexel Australia must notify ASIC within 7 days if listing of the shares of the Issuer on any foreign securities exchange is suspended; and

 - (a) the shares are in the same class as shares which have been quoted on the financial market operated by Euronext Paris between the date of listing and immediately before the offer without suspension for more than a total of 2 trading days during that period;
 - (b) the offer is made under an employee share scheme extended only to eligible employees;
9. *financial product advice* has the meaning given by section 766B of the Act;
10. *general advice* has the meaning given by section 766B of the Act;
11. *Issuer* means Rexel SA, a company registered in France;

12. *offer* has a meaning affected by sections 700, 702 and 1010C of the Act;
13. *offer document* means a document setting out an offer under the Plan that:
- (a) includes or is accompanied by a copy, or a summary, of the Rules under which the offer is made; and
 - (b) if a summary (rather than a copy) of the Rules is given — includes an undertaking that during the period (the “offer period”) during which an eligible employee may acquire the financial products offered under the scheme, the Issuer (or, in the case of an issuer which does not have a registered office in this jurisdiction, an associated body corporate of the Issuer which does so have a registered office) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules; and
 - (c) specifies in respect of the shares, or the shares that that may be acquired where a Performance Right has vested:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the Issuer (or in the case that the issuer does not have a registered office in this jurisdiction, an associated body corporate of the issuer which does so have a registered office) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee; and
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares in the same class as those offered or that will be acquired by the eligible employee when the Performance Right offered to the eligible employee vests; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
 - (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the issuer or a Rexel Australian Subsidiary for the purpose of acquiring financial products under the plan;

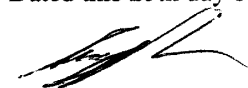

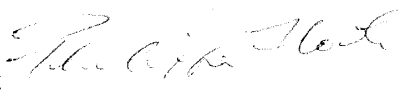
