# Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(b) - Declarations

- 1. Under paragraph 601QA(1)(b) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) declares that Chapter 5C of the Act applies to Investec Wentworth Property Limited ACN 071 514 246(IWPL) in its capacity as the responsible entity of Investec Wentworth Property Opportunity Fund No.1 ARSN 116 870 770 (IWPOFI) and Investec Wentworth Specialised Property Trust ARSN 114 933 050 (IWSPT) in the case set out in Schedule A as if Chapter 5C were modified or varied as follows:
  - (a) omit paragraph 601FC(1)(c) and substitute:
    - "(c) act in the best interests of the members (having regard to their interests as holders of interests in the scheme and their interests as holders of interests in another scheme, where the interests are components of a stapled security) and, if there is a conflict between the interests of the members and its own interests, give priority to the interests of the members; and";
  - (b) omit paragraph 601FD(1)(c) and substitute:
    - "(c) act in the best interests of the members (having regard to their interests as holders of interests in the scheme and their interests as holders of interests in another scheme, where the interests and shares are components of a stapled security) and, if there is a conflict between the interests of the members and the interests of the responsible entity, give priority to the interests of the members; and";
  - (c) section 601LC were modified or varied by adding after notional subsection 208(2) of the Act as included in that section:
    - "(2A) Member approval is not required for the giving of a benefit and the benefit need not be given within 15 months if:
      - (a) the benefit either:
        - (i) is given out of the scheme property of a registered scheme (the *relevant scheme*); or
        - (ii) could endanger the scheme property; and
      - (b) all of the interests in the scheme together with all the interests in another scheme are component parts of stapled securities; and

- (c) the benefit is given by:
  - (i) the responsible entity of the relevant scheme; or
  - (ii) an entity that the responsible entity controls; or
  - (iii) an agent of, or person engaged by, the responsible entity; and
- (d) the benefit is given to the scheme referred to in paragraph (b), or a wholly owned entity of the schemes, or any entity wholly owned, whether directly or indirectly, jointly by the scheme and the other scheme or either of them.
- (2B) For the purposes of this section:
  - an entity is wholly owned by another entity if all of the interests in the first-mentioned entity are held by or by a nominee for, or form part of the trust property of the second-mentioned entity or a wholly owned entity of it;
  - (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries; and
  - (c) an interest is a component part of a stapled security if:
    - (i) the interest and an interest in another scheme must, under the terms on which each is traded or to be traded, only be transferred together; and
    - (ii) there are no financial products in the same class as those financial products which may be transferred separately.";

- (d) after section 601PC insert:
  - "601PD For the purposes of sections 601FC and 601FD, stapled security means two or more financial products including at least one interest in a registered scheme where:
    - under the terms on which each of the products are to be traded, they must be transferred together; and
    - (b) there are no financial products in the same class as those financial products which may be transferred separately."; and
- (e) after subsection 601GAA(9) as notionally inserted into Chapter 5C by ASIC Class Order [CO 05/26] insert:
  - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
    - (a) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the scheme constitution;
    - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
    - (c) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.".
- 2. Under paragraph 601QA(1)(b) of the Act, the ASIC declares that Chapter 5C of the Act applies to IWPL in its capacity as the responsible entity of IWPOF1 in the case set out in Schedule B as if paragraph 601GC(1)(a) of the Act were modified or varied by deleting "special resolution of the members of the scheme" and substituting "each and every member of the scheme providing their written consent to the modification, or repeal and replacement".

# Australian Securities and Investments Commission Corporations Act 2001 - Subsection 741(1) - Exemption & Declaration

- 1. Under paragraph 741(1)(a) of the Corporations Act 2001 ("the Act") the Australian Securities and Investments Commission ("ASIC") hereby exempts the person specified in Schedule A, in the case referred to in Schedule B, from compliance with Parts 6D.2 and 6D.3 of the Act.
- 2. Under paragraph 741(1)(b) of the Act, ASIC hereby declares that Chapter 6D of the Act applies to the persons specified in Schedule C in the case referred to in Schedule D, as if section 707 were modified or varied by omitting subsections 707(3), (4), (5) and (6) and substituting:
  - "(5) An offer of a body's securities for sale within 12 months after their sale by a person who controlled the body at the time of the sale needs disclosure to investors under this Part if:
    - (a) at the time of the sale by the controller either:
      - (i) the securities were not quoted; or
      - (ii) although the securities were quoted, they were not offered for sale in the ordinary course of trading on a relevant financial market on which they were quoted; and
    - (b) the controller sold the securities without disclosure to investors under this Part; and
    - (c) the controller sold the securities with the purpose of the person to whom they were sold:
      - (i) selling or transferring the securities; or
      - (ii) granting, issuing or transferring interests in, or options or warrants over the securities;

and section 708 does not say otherwise.

(6) Unless the contrary is proved, a person who controls a body is taken to sell securities with the purpose referred to in paragraph (5)(c) if any of the securities are subsequently sold, or offered for sale, within 12 months after their sale by the controller."

# Australian Securities and Investments Commission Corporations Act 2001 (Cth) — Paragraphs 741(1)(a), 911A(2)(l), and 1020F(1)(a) — Exemptions

# First Exemption: disclosure relief for offers of shares and units of shares

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the persons referred to in Schedule A from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the person:
  - (a) makes an eligible offer;
  - (b) offers to arrange for the issue of financial products under an eligible offer;
  - (c) issues a financial product under an eligible offer,

that does not involve a contribution plan, on the conditions set out in Schedule B and for so long as the conditions are met.

#### Second Exemption: licensing and hawking relief

- 2. Under paragraph 911A(2)(l) ASIC exempts the persons referred to in Schedule A who are exempt from Part 6D.2 or Part 7.9 because of the First Exemption from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in the First Exemption (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 3. Under paragraph 911A(2)(1) ASIC exempts:
  - the persons referred to in Schedule A who are exempt from Part 6D.2 or Part 7.9 because of the First Exemption; and
  - (b) any associate of those persons,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

(c) the provision of a custodial or depositary service in connection with an eligible offer covered by the First Exemption where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and

- (d) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by the First Exemption where any acquisition by purchase or disposal of the product (by the issuer or an associate) occurs either:
  - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products or a dealers licence issued under the old Corporations Act authorising the holder to deal in securities; or
  - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 4. Under paragraph 741(1)(a) ASIC exempts the persons referred to in Schedule A who are exempt from Part 6D.2 because of the First Exemption from section 736 in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
