**Australian Securities and Investments Commission

Under paragraphs 655A(1)(b) and 673(1)(b) of the *Corporations Act 2001* ("Act"), the Australian Securities and Investments Commission ("ASIC") declares that Chapters 6 and 6C of the Act apply to the person referred to in Schedule A in the case set out in Schedule B as if section 609 were modified or varied by inserting after subsection 609(2) the following subsections:

"(2A) For the purposes of subsection (2B):

*CREST* means the system for paperless settlement of trades and holdings of uncertificated securities administered by CRESTCo Limited in the United Kingdom; and

*depository interest* means an uncertificated interest in a security.

  - (ii) discretions where the depository interests are owned directly or beneficially by, or otherwise for the benefit of, any person in breach of any law or requirement of any jurisdiction or governmental authority or so as to result in ownership of any underlying securities exceeding any limit under or otherwise infringing any law or constitutive documents; or
  - (iii) discretions where the depository interests are owned directly or beneficially by, or otherwise for the benefit of, any person who fails to furnish to the trustee such proof as to matters of fact (including identity) as the trustee may deem necessary or appropriate under applicable laws and regulations; or
  - (iv) discretions where the holder of the depository interest ceases at any time to be, or is suspended in whole or part as, a member of CREST; or

- (vi) discretions where the depository interests are held by a person who has failed to duly and punctually perform any obligation to the trustee or its custodian under the deed poll or any other relevant agreement or instrument to which the person is a party in relation to depository interests, if the trustee determines that it is appropriate,

where:

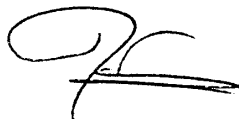
- (b) the trustee holds the securities on trust for the benefit of the holder of the depository interests; and
- (c) if the terms of any of the discretions referred to in paragraph (a) require the trustee to form an opinion or determine that an action is necessary or appropriate, the trustee acts reasonably in forming that opinion or making that determination; and
- (d) if the trustee exercises any of the discretions referred to in paragraph (a), it does so:
  - (i) only for the purposes of satisfying its obligations as trustee of the depository interests; and
  - (ii) on ordinary commercial terms or in an ordinary commercial manner as the case requires; and
- (e) the trustee does not dispose of any securities to its associates as a result of the exercise by the trustee of any of the discretions in paragraph (a); and
- (f) the shares underlying the depository interests are issued and admitted to trading status in accordance with the operating rules of the Alternative Investment Market of the London Stock Exchange plc."

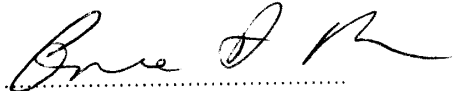

**Corporations Act 2001 — Paragraph 911A(2)(l) — Exemption**

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts Northwater Capital Management, Inc., a company incorporated in Canada (*Northwater*) from the requirement to hold an Australian financial services licence for the provision of the financial services set out in Schedule A in the case referred to in Schedule B.

**Schedule A**

The provision of any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:

- (a) providing financial product advice;
- (b) dealing in a financial product;
- (c) making a market for a financial product; or
- (d) providing a custodial or depository service;

in respect of any of the following financial products:

- (e) derivatives;
- (f) foreign exchange contracts;
- (g) securities;
- (h) debentures, stocks or bonds issued by a government; or
- (i) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act;

**Schedule B**

Where all of the following apply:

1. Northwater is

(a) a registered broker dealer that is a member of the Securities Investor Protection Corporation established under the Securities Investor Protection Act of 1970 of the US and that:

- (i) is a member of the NYSE and the NYSE is the body's examining authority; or
- (ii) is a member of NASD and NASD is the body's examining authority; or

- (b) a registered broker dealer that is an OTC derivatives dealer within the meaning of Rule 3b-12 promulgated under the Exchange Act who is affiliated within the meaning of that Rule with a registered broker dealer who is a member of the NYSE or NASD; or
    - (c) a registered investment adviser;
  - 2. Northwater:
    - (a) is registered under division 2 of Part 5B.2 of the Act; or
    - (b) has not failed for more than the last 10 business days to have an Agent;
  - 3. Northwater's primary business is the provision of financial services;
  - 4. neither Northwater nor its Agent has been notified by ASIC that Houlihan is excluded from relying on this instrument;
  - 5. if Northwater becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule C:
    - (a) 15 business days have not passed since Northwater became so aware or should reasonably have become so aware without Northwater providing full particulars of the failure to ASIC (to the extent that Northwater knows those particulars or would have known them if it had taken reasonable enquiries); and
    - (b) 30 business days have not passed from ASIC receiving those particulars from Northwater without ASIC notifying Northwater that it may continue to rely on this instrument;
  - 6. Northwater has not notified ASIC that it will not rely on this instrument; and
  - 7. Northwater has provided ASIC with:
    - (a) evidence that paragraph 1 of this Schedule is satisfied that ASIC has stated in writing is adequate;
    - (b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument;
    - (c) a deed of Northwater for the benefit of and enforceable by ASIC and other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that Northwater may have ceased to rely, or never have relied, on this instrument, which deed provides that:
      - (i) the deed is irrevocable except with the prior written consent of ASIC;
-

- (ii) Northwater submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
  - (iii) Northwater covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
  - (iv) If Northwater is not registered under Division 2 of Part 5B.2 of the Act, service of process on Northwater in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceeding relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
  - (v) Northwater covenants that, on written request of either the SEC or ASIC, it will give or vary any written consent and take all other practicable steps to enable and assist the SEC to disclose to ASIC and ASIC to disclose to the SEC any information or document that the SEC or ASIC has that related to Northwater; and
- (d) written consents to the disclosure by the SEC to ASIC and ASIC to the SEC of any information or document that the SEC or ASIC has that related to Northwater. The consents must be in such form (if any) as ASIC specifies in writing;
8. the financial services provided in reliance of this instrument are provided on behalf of Northwater by persons who also provide financial services of the same kind on behalf of Northwater to institutional investors in the US.

#### Schedule C

1. Northwater must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the US regulatory requirements if the financial service were provided in the US in like circumstances.
2. Northwater must:
  - (a) notify ASIC, as soon as practicable and in such form if any as ASIC may from time to time specify in writing, of the details of:

- (i) each significant change to, including the termination of, the registration as a registered broker dealer or a registered investment adviser applying to Northwater relevant to the financial services Northwater provides or intends to provide in this jurisdiction; and
  - (ii) each significant particular exemption or other relief which Northwater obtains from the US regulatory requirements relevant to the financial services Northwater provides or intends to provide in this jurisdiction; and
- (b) notify ASIC by 31 March and 30 September of each year in such form if any as ASIC may from time to time specify in writing:
- (i) either:

*custodial or depository service* has the meaning given by section 766E of the Act;

*derivative* has the meaning given by section 761D of the Act;

*examining authority*, in relation to a body, means a self-regulatory organisation to which the body belongs which has not been relieved of responsibility relating to Northwater under section 17(d)(1)(A) of the Exchange Act in any respect;

*Exchange Act* means the Securities and Exchange Act of 1934 of the US;

*financial product advice* has the meaning given by section 766B of the Act;

*financial services law* has the meaning given by section 761A of the Act;

*foreign exchange contract* has the meaning given by section 761A of the Act;

*making a market* has the meaning given by section 766D of the Act;

*NASD* means the National Association of Securities Dealers;

*notice and notified* mean, respectively, written notice and notified in writing;

*NYSE* means the New York Stock Exchange;

*overseas regulatory authority* means a foreign regulatory authority (other than the SEC) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

*registered broker dealer* means a broker or dealer registered under section 15(b) of the Exchange Act;

*registered investment adviser* means a body corporate registered under section 203(c) of the Investment Advisers Act of 1940 of the US;

- (e) the operator must ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust by the operator for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (f) if an FFE Fund has been established for an investor, the operator must ensure that:
  - (i) the money comprising the FFE Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and
  - (ii) the balance of the FFE Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first;
- (g) no payment is liable to be made by an investor to participate in the scheme other than:
  - (i) payment of money to buy the strata unit;
  - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
    - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case

may be), by the operator during the period to which the payments relate; and

- (B) where an FFE Fund has been established for the investor — no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the FFE Fund has first been expended; and
- (iii) where an FFE Fund has been established for the investor — one or more payments into the Fund where:
  - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
  - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
- (h) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme; and
- (i) the serviced apartment complex is operated in accordance with a written agreement entered into or to be entered into between an operator and each investor which agreement includes the provisions set out in Schedule C.

#### SCHEDULE C — PROCEDURES FOR TRANSFERRING MANAGEMENT RIGHTS

1. *Transfer of management rights*
    - (a) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme.
    - (b) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice.

2. *Consent of body corporate to new care-taking arrangements*
- (a) If an operator receives a notice under paragraph 1(b) of this Schedule, the operator must advise all body corporate members of the name of the person to whom the transfer is to be made.
  - (b) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in paragraph 1(b) of this Schedule if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions.
  - (c) If a majority of body corporate members make a decision referred to in paragraph 2(b) of this Schedule, a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with paragraph 1(b) of this Schedule.
  - (d) This paragraph 2 does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under paragraph 1(b) or 2(c) of this Schedule before that notice is given to the operator.

3. *Price payable on transfer*

The price scheme members specify in a notice under paragraph 1(b) of this Schedule must be one of the following:

6. *Assistance*

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings.

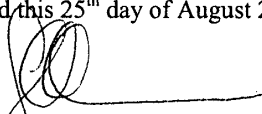
