**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 669(1)(b) – Declaration**

Under paragraph 669(1)(b) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission declares that Chapter 6A of the Act as affected by ASIC Instrument 09-00218 dated 20 March 2009 applies to the person specified in Schedule A, in relation to the securities referred to in Schedule B as if:

1. Division 3 of Part 6A.1 were modified or varied by adding after section 663A:
“663AA Bidder must offer to buy out holders of convertible securities—Further obligation
 - (1) This section applies if:
 - (a) section 663A does not apply to securities that are convertible into bid class securities because a notice has been given under section 664C in relation to the convertible securities; and
 - (b) the expert’s report given under paragraph 664C(2)(b) in effect states, in the expert’s opinion, that the terms proposed in the notice given under section 664C do not give fair value for all of the convertible securities.
 - (2) The bidder must offer to buy out the holders of securities that are convertible into bid class securities in accordance with sections 663B and 663C as if paragraph 663B(2)(a) required the bidder to dispatch notices and reports under paragraph 663B(1)(c) by 29 May 2009.
 - (3) The bidder must not acquire any of the securities at a lower price than that specified in the notice given under section 664C, whether as a result of an offer under subsection (2) or otherwise.
 - (4) Subsection 664D(3) does not apply:
 - (a) during the period from the day after the commencement of this section until the time that buy-out offers are made in accordance with subsection (2); and
 - (b) in relation to an offer made in accordance with subsection (2) or any payment made under a contract of the kind referred to in subsection 663C(2) that relates to the offer.”; and
2. Division 1 of Part 6A.2 of the Act were modified or varied by adding after section 664G:
“664H Proposed acquisition of securities that are convertible into ordinary shares in Sydney Gas Ltd
 - (1) This section applies in relation to the proposed acquisition under section 664A by AGL Energy Limited ACN 115 061 375 (the **90% holder**) of securities convertible into ordinary shares in Sydney Gas Ltd ACN 003 324 310, in relation to which a notice under section 664C was lodged with ASIC on 31 March 2009.

- (a) given everyone to whom the notice was sent under section 664C, a notice that the proposed acquisition will not occur; and

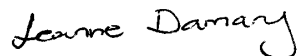

 - (1) Despite section 916D, a financial services licensee (the *authorised licensee*) may be the authorised representative of another financial services licensee who is an insurer, if the authorised licensee acts under a written agreement (*written agreement*) which authorises the authorised licensee to deal in, and provide general advice in relation to, risk insurance products on behalf of the insurer.
 - (2) For all purposes connected with contracts that are risk insurance products, or with claims against the insurer, in respect of which the authorised licensee acts under the written agreement:
 - (a) the authorised licensee is taken to act on behalf of the insurer and not the insured; and
 - (b) if the insured in fact relied in good faith on the conduct of the authorised licensee, the authorised licensee is taken to act on behalf of the insurer regardless of the

fact that the authorised licensee did not act within the scope of the authorisation.

- (3) This section does not apply where the licence of the authorised licensee covers the provision of any financial services in relation to the risk insurance products.”.
2. Under paragraph 951B(1)(c) of the Act, ASIC declares that Part 7.7 of the Act applies to the persons specified in Schedule B in the case set out in Schedule C as if the following provisions were omitted, modified or varied:
- (a) in section 940A omit “section 916E”, substitute “sections 916E or 916EA.”; and
- (b) after subparagraph 942C(2)(j)(iii) insert:
- “(iv) the providing entity is taken to act on behalf of the authorising licensee and not the client for any general advice given by the providing entity in relation to risk insurance products that are within the scope of the binder; and
- (v) the authorising licensee is responsible, as between the authorising licensee and the client, for any general advice given by the providing entity in relation to risk insurance products that are within the scope of the binder; and”;
- (c) after paragraph 942C(2)(j) insert:
- “(ja) if the providing entity is an authorised licensee acting under a written agreement under section 916EA in providing any of the authorised services—a statement that:
- (i) identifies the services provided under the written agreement; and
- (ii) states that they are provided under the written agreement; and
- (iii) explains the significance of the services being provided under the written agreement; and
- (iv) the providing entity is taken to act on behalf of the authorising licensee and not the client; and
- (v) the authorising licensee is responsible, as between the authorising licensee and the client for the conduct of the providing entity; and”.

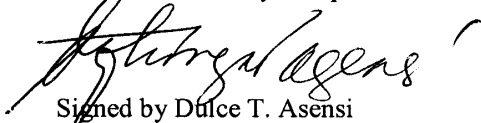

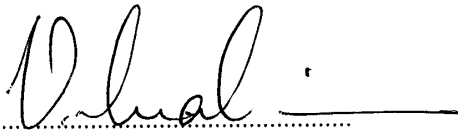
