**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 741(1)(b) — Declaration**

Under paragraph 741(1)(b) of the *Corporations Act 2001 (Act)* the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 6D applies to the person specified in Schedule A, in the case specified in Schedule B, as if the following subsections were inserted immediately after subsection 708(21):

"708(22) An offer of a body's securities, made under Part 2 of the *Securities Act 1978* of New Zealand, to employees of the body where:

- (a) no person concerned in the management of the body:
 - (i) is disqualified from managing corporations for the purposes of Part 2D.6; or
 - (ii) is disqualified from being concerned in the management of the body under the law of New Zealand; or
 - (iii) is subject to a banning order under section 920A; or
 - (iv) is subject to a court order under paragraph 921A(2)(a); and

 - (b) at least 14 days before the day on which the offer is first made in this jurisdiction, the body lodges with ASIC:
 - (i) a notice of the body's intention to make the offer; and
 - (ii) the documents and information specified in paragraph (d); and

 - (c) before the offer is first made in this jurisdiction and after a document or information under paragraph 708(22)(b)(ii) is lodged with ASIC:
 - (i) a change is made to an offer document, or any other document, required by the law of New Zealand in relation to the offer; or
 - (ii) a change is made to the statement referred to in paragraph (d) that is included with the offer document in this jurisdiction; or
 - (iii) a supplementary or replacement offer document is required by the law of New Zealand; or
 - (iv) a change is made to the constitution; or
 - (v) the authority (*home regulator*) in New Zealand whose functions under the law of New Zealand include functions equivalent to any of those of ASIC under the Act begins enforcement action, or
-

- exercises a power it has under law, in relation to the offeror or offer; or
- (vi) the address for service of the body changes in this jurisdiction; or
 - (vii) the home regulator makes, changes or revokes an exemption that applies exclusively to the offer or the offeror under the law of New Zealand; or
 - (viii) the home regulator makes, changes or revokes an exemption that applies, but not exclusively, to the offer or the offeror under the law of New Zealand;

the body must lodge with ASIC within 7 days of the event in (i)-(vii) occurring and within 14 days of the event in (viii) occurring:

- (ix) if paragraph (i), (ii) or (iv) applies – a copy of the document as changed; or
- (x) if paragraph (iii) applies – a copy of the supplementary or replacement document; or
- (xi) if paragraph (vi) applies—the changed address for service; or
- (xii) if paragraph (v) applies – written notice of the details of the action taken or power exercised; or
- (xiii) if paragraph (vii) or (viii) applies – written notice of the details of the exemption, change or revocation.

(d) For the purposes of subparagraph 708(22)(b)(ii), the documents and information required to be lodged are:

- (i) any offer document required by the law of New Zealand in relation to the offer; and
- (ii) a statement containing words to the effect that the offer is regulated under New Zealand securities laws, that the standard securities law requirements of this jurisdiction that apply to offers in this jurisdiction do not generally apply to the offer and that if the offerees are uncertain about whether the offer is appropriate for him/her, he/she should seek the advice of an appropriately qualified financial advisor; and
- (iii) the constitution of the body; and
- (iv) details of any exemption from the securities law of the New Zealand that applies, but not exclusively, to the offer or to the body in relation to the offer; and
- (v) an address for service for the body in this jurisdiction; and

- (vi) a copy of any exemption from the securities law of New Zealand that applies exclusively to the offer or to the body."

Australian Securities and Investment Commission
Corporations Act 2001 - Paragraphs 655A(1)(b) and 673(1)(b) - Declarations

Under paragraphs 655A(1)(b) and 673(1)(b) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) declares that Chapters 6 and 6C of the Act apply to the persons referred to in Schedule A in the case referred to in Schedule B as if section 609 of the Act were modified or varied by inserting after subsection 609(6) the following subsections:

 - (iii) discretions to make application to a court for discretions or assent to or oppose any application which is made relating to eligible units or to which the trustee becomes a party by virtue of it being a party to the trust deed;
 - (iv) discretion, for administrative purposes, to aggregate all the securities which relate to a single holder of eligible units;
 - (v) discretions as to the appointment of officers or engagement of agents, delegates, sub-contractors or experts to discharge all or any of the trustee's duties under the trust deed;
 - (vi) discretions in relation to the appointment of custodians or sub-custodians to procure safe custody of the class of securities; or
- (b) the holder of the eligible unit not having a presently enforceable or unconditional right of the kind referred to in subsection 608(8);

where both of the following apply:

- (c) the trustee holds the securities on trust for the benefit of:

 - (ii) the person who is owed the outstanding instalment amount plus interest on that amount (*instalment creditor*);
- (d) if the trustee is entitled to exercise any discretions under the deed establishing the trust, it does so on ordinary commercial terms or in an ordinary commercial manner as the case requires.
- (6B) A person does not have a relevant interest in the class of securities merely because the person is the instalment creditor in respect of those securities where those securities are held on trust under the terms of issue of the eligible units, pursuant to which the instalment creditor has no power to control the voting or disposal of the security (other than to enforce the terms of the trust or where the holder of the eligible unit defaults) unless and until the eligible unit is cancelled.
- (6C) A person who issues eligible units does not have a relevant interest in securities that are held on trust under the terms of the eligible units merely because:
- (a) the person has the power to dispose of, or control the exercise of a power to dispose of, the securities where that power or control results from the terms of the trust deed or the right to enforce the terms of the trust deed; or
 - (b) the person has the following discretions under the terms of the trust deed relating to the units:
 - (i) discretions in relation to a takeover bid for, or an arrangement or compromise under Part 5.1, affecting the securities but not in relation to voting or disposal of a class of securities;
 - (ii) discretions in relation to bonus issues, rights issues, returns of capital, security splits, security consolidations or other reconstructions of capital affecting the class of securities.
- (6D) If a person has a relevant interest in a security because subsections (6B) or (6C) ceases to apply, the person is taken to acquire a relevant interest in the security at that time, by a transaction in relation to that security."





1. Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument [05/0994] dated 26 September 2005.
2. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if Chapter 5C were modified or varied as follows:
 - (a) omit paragraph 601FC(1)(c) and substitute:

“(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes, where interests in each of the schemes are components of a stapled security), and, if there is a conflict between the members’ interests and its own interests, give priority to the members’ interests; and”;
 - (b) omit paragraph 601FD(1)(c) and substitute:

“(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes, where interests in each of the schemes are components of a stapled security) and, if there is a conflict between the members’ interests and its own interests, give priority to the members’ interests”;
 - (c) after subsection 601GAA(9) as notionally inserted into Chapter 5C by ASIC Class Order [CO 05/26], insert:

“(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:

 - (a) the constitution makes provision for the issue price of stapled securities;
 - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
 - (c) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the scheme constitution;

- (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.”; and
- (d) insert after subsection 208(2) of the Act as notionally inserted by section 601LC:
- “(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
- (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme (the *scheme*); or
 - (ii) could endanger the scheme property; and
 - (b) all of the interests in the scheme and all of the interests in one or more other registered schemes (the *other schemes*) are components of stapled securities; and
 - (c) the benefit is given by:
 - (i) the responsible entity of the scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity; and
 - (d) the benefit is given to:
 - (i) an entity wholly owned, whether directly or indirectly, by the scheme; or
 - (ii) the other schemes or an entity wholly owned, whether directly or indirectly, by the other schemes; or
 - (iii) an entity wholly owned, whether directly or indirectly, jointly by the scheme and one or more of the other schemes.
- (2B) For the purposes of this section:
- (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned

entity being a trust), the second-mentioned entity or a wholly owned entity of it; and

- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.”; and

- (e) insert after section 601PC:

“601PD For the purposes of sections 601FC, 601FD and 601LC:

stapled security means two or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.”.



Declaration of Unacceptable Circumstances**

In the matter of PROGRAMMED MAINTENANCE SERVICES LIMITED 02

WHEREAS

1. On 24 April 2008 Spotless Investment Holdings Pty Ltd, a wholly owned subsidiary of Spotless Group Limited, (**Spotless**) despatched offers for all the shares in Programmed Maintenance Services Limited (**Programmed**).
2. On 16 April 2008, Programmed lodged an Investor Presentation with ASX. The Presentation included "Takeover Premium Comparison" charts on page 5. The charts purported to show the following bars:
 - (a) average takeover premia for completed takeovers "based on final offer premia of completed takeovers announced between 1 April 2006 and 1 April 2008 of Australian listed companies in which the offer consideration was greater than A\$200 million and less than A\$2,000 million ..."
 - (b) median takeover premia for completed takeovers (as above)
 - (c) what Spotless is offering, using the 3 alternatives in its consideration. This relies on the Programmed price as a 6-month and 12-month Volume Weighted Average Price for the period ending 26 March 2008, and the Spotless price at its closing on 2 April 2008, being the date of lodgement of the bidder's statement.
3. On 22 April 2008, Programmed sent a letter to shareholders and lodged a copy with ASX. The letter included in an accompanying leaflet:
 - (a) an extract from an article in The Business Spectator on 16 April 2008 by Stephen Bartholomeusz that: "*The directors are probably right when they say in today's vigorous rejection of the bid, that the Spotless offer, which includes a range of mix and match options involving both cash and shares, undervalues Programmed*"
 - (b) An extract from an article on 28 March 2008 in the Australian Financial Review by Michael Smith that: "*As the Spotless share price sank another 8 per cent following the \$556 million tilt yesterday, it could be argued Programmed is better positioned to play the role of suitor*"(the **Circumstances**).
4. It appears to the Panel that the Circumstances are unacceptable having regard to:
 - (a) the effect that the Panel is satisfied that the Circumstances have had, are having, will have or are likely to have on:
 - (i) the control or potential control of Programmed; or
 - (ii) the acquisition or proposed acquisition by Spotless of a substantial interest in Programmed; or

- (b) the purposes of Chapter 6 set out in section 602 of the Act.
5. The Panel considers that it is not against the public interest to make a declaration of unacceptable circumstances in relation to the Circumstances and the affairs of Programmed.






