**Australian Securities and Investments Commission**  
**Corporations Act 2001 — Paragraph 911A(2)(l) and Subsections 926A(2)**  
**and 951B(1) — Variation**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 911A(2)(l) and subsections 926A(2) and 951B(1) of the *Corporations Act 2001*.

**Title**

2. This instrument is ASIC Class Order [CO 08/276].



**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraphs 741(1)(a), 741(1)(b) and 911A(2)(l) –  
Exemptions and Declaration**

1. Under paragraph 741(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from compliance with Parts 6D.2 and 6D.3 (except section 736) of the Act for the offer of ordinary shares in BHP Billiton Limited and BHP Billiton Limited Interim Shares for issue as consideration under the UK Offer and the US Share Offer in the case specified in Schedule B and on the condition set out in Schedule C.
  2. Under paragraph 741(1)(b) of the Act, ASIC declares that Chapter 6D of the Act applies to the persons specified in Schedule D in the case specified in Schedule E as if section 707 were modified or varied by omitting subsections (3) and (4) and substituting:
    - "(3) An offer of a body's securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:
      - (a) without disclosure to investors under this Part; and
      - (b) with the purpose of the person to whom they were issued:
        - (i) selling or transferring them; or
        - (ii) granting, issuing or transferring :
          - (A) options or warrants over them; or
          - (B) interests (other than interests of a kind known as American Depositary Shares) in them;
- and section 708 or 708A does not say otherwise.
- (4) Unless the contrary is proved, a body is taken to issue securities with the purpose referred to in paragraph 3(b) if any of the securities are subsequently sold, or offered for sale, within 12 months after their issue.
  - (4A) Despite subsection (4), a body will not be taken to have the purpose referred to in paragraph 3(b) merely because the body makes available, or causes to be made available, a facility under which a person who has accepted an offer under a takeover governed by the applicable requirements of the United Kingdom or the laws and regulations that apply in the United States of America, can elect in certain circumstances for the ordinary shares in the bidder they would otherwise receive as consideration under the offer (or would otherwise obtain an equitable interest in through securities (known as American Depositary Shares) issued as consideration under the offer) to be sold by a nominee (chosen by the bidder and approved

in writing by ASIC) who is appointed to sell such shares and distribute to each person entitled their proportion of the proceeds of the sale, net of any expenses that are not borne by the bidder.

- (4B) Despite subsection (4), a body will not be taken to have the purpose referred to in paragraph 3(b) merely because, under a takeover governed by the applicable requirements of the United Kingdom, ordinary shares in the bidder that would otherwise be issued to a holder of ordinary shares in the target whose address, as shown in the register of members, is a place outside the place in which the target was incorporated, are sold by a nominee (chosen by the bidder and approved in writing by ASIC) who is appointed to sell such shares and distribute to each person entitled their proportion of the proceeds of the sale, net of any expenses that are not borne by the bidder."

3. Under paragraph 911A(2)(l) of the Act, ASIC exempts the person specified in Schedule A in the case referred to in Schedule B on the condition set out in Schedule C from the requirement to hold an Australian financial services licence for the provision of general advice that is contained in the UK Offer Document or the US Offer Document.

**BHP Billiton Plc ADSs** means equitable interests (known as American Depository Shares) in ordinary shares in BHP Billiton Plc.

**general advice** has the meaning given in section 766B of the Act.

**offer** has a meaning affected by sections 700(2) and 702 of the Act.

**Rio Tinto Plc** means Rio Tinto plc, registered number 00719885, incorporated under the Companies Act of the United Kingdom.

**Rio Tinto Plc ADSs** means equitable interests (known as American Depository Shares) in ordinary shares in Rio Tinto Plc.

**UK Offer** means the takeover offer by the Bidder for all the ordinary shares in Rio Tinto Plc, governed by the rules set out in the City Code on Takeovers and Mergers of the United Kingdom, in consideration for which holders of ordinary shares in Rio Tinto Plc will be offered ordinary shares in the Bidder and BHP Billiton Limited Interim Shares.

**UK Offer Document** means the document and all ancillary and supplementary documents that are given to holders of ordinary shares in Rio Tinto Plc (other than US holders of ordinary shares in Rio Tinto Plc) in connection with the UK Offer in accordance with the rules set out in the City Code on Takeovers and Mergers of the United Kingdom.

**US ADS Offer** means the offer by the Bidder for all the Rio Tinto Plc ADSs, wherever the holders are located, governed by all laws and regulations that apply in the United States of America, in consideration for which holders of Rio Tinto Plc ADSs will be offered BHP Billiton Limited ADSs and BHP Billiton Limited Interim Shares.

**US holders of ordinary shares in Rio Tinto Plc** means holders of ordinary shares in Rio Tinto Plc having an address as shown in the register of members in the United States of America or persons who the Bidder reasonably believes to be resident in the United States of America or to hold on behalf of a person resident in the United States of America.

**US Offer** means the takeover offer governed by all laws and regulations that apply in the United States of America consisting of the US Share Offer and the US ADS Offer.

**US Offer Document** means the document and all ancillary and supplementary documents that are given to US holders of ordinary shares in Rio Tinto Plc and holders of Rio Tinto Plc ADSs, wherever located, in connection with the US Offer and in accordance with all laws and regulations that apply in the United States of America.


