Australian Securities and Investments Commission Corporations Act 2001 – Subsection 601CK(7) and Paragraph 992B(1)(a) – Declaration and Exemption

- Under subsection 601CK(7) of the Corporations Act 2001 (the Act), the
 Australian Securities and Investments Commission (ASIC) declares that section
 601CK of the Act does not apply to State Street Bank and Trust Company ARBN
 062 819 630 (SSBT) in respect of a financial year ending on or after 31 December
 2006 in the case specified in the Schedule
- 2. Under paragraph 992B(1)(a) of the Act, ASIC exempts SSBT from section 989B of the Act in respect of a financial year ending on or after 31 December 2006 in the case specified in the Schedule.

Schedule

Where:

- 1. SSBT lodges with ASIC:
 - (a) for the financial year ended 31 December 2006 (2006 financial year), on or before 5pm Sydney time 9 October 2007; and
 - (b) for financial years after the 2006 financial year at least once every calendar year and at intervals of not more than 15 months:
 - (i) a copy of the:
 - (A) balance sheet; and
 - (B) profit and loss statement; and
 - (C) cash flow statement

made at the end of the relevant financial year by the holding company of SSBT, State Street Corporation (STT), in such a form and containing such particulars and including copies of such documents as STT is required to prepare under the Securities Exchange Act of 1934 of the United States of America, together with a statement in writing verifying that the copies are true copies of the documents so required and a copy of the document setting out the opinion of STT's external auditors in relation to those documents; and

- (ii) a copy of the:
 - (A) balance sheet; and
 - (B) profit and loss statement; and
 - (C) statement of changes in equity (collectively the SSBT financial statements)

contained in the Consolidated Reports of Condition and Income for A Bank with Domestic and Foreign Offices ("FFIEC 031") lodged for SSBT with the Federal Financial Institutions Examination Council (US) ("FFIEC") for the relevant financial year; and

(c) a statement by an executive officer of SSBT:

- certifying that the information in the SSBT financial statements is a true copy of the SSBT financial statements in the last original FFIEC 031 lodged for SSBT; and
- (ii) certifying that at the time at which the FFIEC 031 was lodged, the Chief Financial Officer (or equivalent) of SSBT had certified that it had been prepared in conformance with the instructions issued by the relevant U.S. Federal regulatory authority and was true to the best of his or her knowledge and belief; and
- (iii) explaining the effect of this ASIC relief; and
- 2. STT is the ultimate holding company of SSBT; and
- 3. STT is a company listed on the financial market operated by NYSE Euronext; and
- 4. SSBT is a foreign authorised deposit taking institution within the meaning of the Banking Act (Commonwealth) 1959; and
- 5. SSBT is subject to US federal and state banking laws and to supervision and examination by the Board of Governors of the Federal Reserve System, the Federal Reserve Bank of Boston, the Massachusetts Commissioner of Banks an the Federal Deposit Insurance Corporation.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 741(1)(a), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) — Exemptions

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the issuer from Parts 6D.2 and 6D.3 (except section 736) and Part 7.9 where the issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer,

that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.

- 2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
- 3. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Schedule

The following conditions apply:

- 1. the issuer must:
 - (a) include the eligible offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the eligible offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and

- 2. the issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
- 3. the Company must take reasonable steps to ensure that the number of shares (including as a component of stapled securities) the subject of the eligible offer when aggregated with:
 - (a) the number of shares in the same class which would be issued were:
 - (i) each outstanding offer with respect to stapled securities made under the Plan was accepted; and
 - (ii) each outstanding offer with respect to shares, units of shares and options to acquire unissued shares under any other employee share scheme to be accepted or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years under the Plan and any other employee share scheme extended only to eligible employees,

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Company as at the time of the offer.

Interpretation

In this instrument:

- 1. Except where otherwise stated, references to provisions are to provisions of the Act.
- 2. The Plan or any other employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may

renounce an offer of financial products made to them under the scheme in favour of their nominee.

- 3. associated body corporate of the issuer means:
 - (a) a body corporate that is a related body corporate of the issuer; or
 - (b) a body corporate that has voting power in the issuer of not less than 20%; or
 - (c) a body corporate in which the issuer has voting power of not less than 20%.
- 4. Company means Cromwell Corporation Limited ACN 001 056 980.
- 5. contribution plan means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for shares offered for issue or sale under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:
 - (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document; and
 - (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the issuer in trust for the employee in an account of an Australian ADI which is established and kept by the issuer only for the purpose of depositing contribution monies and other money paid by employees for the shares on offer under the employee share scheme; and
 - (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest, must be repaid to that employee.
- 6. current market price means in relation to a stapled security, the price published by the operator of the principal financial market on which the stapled security is quoted as the final price for the previous day on which the stapled security was traded on that financial market.
- 7. *eligible employee* means a person who is, at the time of the offer under the Plan, a full or part-time employee or director of the Company or of an associated body corporate of Cromwell.
- 8. eligible offer means an offer under the Plan for the sale or issue of fully-paid stapled securities in the same class as stapled securities which have been quoted on the financial market operated by ASX Limited ACN 008 624 691 throughout the eight (8) month period immediately before the offer without suspension for more than a total of 2 trading days during that period.

- issuer means the Company and Cromwell Property Securities Limited ACN 079 147 809 as responsible entity for the Cromwell Diversified Property Trust ARSN 102 982 598.
- 10. offer has a meaning affected by sections 700, 702 and 1010C.
- 11. offer document means a document setting out the offer under the Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan under which the offer is made; and
 - (b) if a summary (rather than a copy) of the rules of the Plan is given includes an undertaking that during the period (the offer period) during which an eligible employee may acquire the financial products offered, the issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
 - (c) specifies in respect of the stapled securities:
 - (i) the acquisition price in Australian dollars; or
 - (ii) where the acquisition price is to be worked out in the future under a formula, the acquisition price in Australian dollars were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price of stapled securities in the same class as those stapled securities which are offered, subject to the options or to which the units relate; and
 - (ii) where subparagraph (c)(ii) applies, the information referred to in that paragraph as updated to that date; and
 - (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the issuer or any associated body corporate for the purpose of acquiring financial products under the Plan.
- 12. Plan means the Cromwell Group Tax Exempt Stapled Security Plan where:
 - (a) the Plan is extended only to eligible employees; and
 - (b) the terms of the Plan are substantially in the terms set out in the draft Plan rules provided to ASIC on 24 September 2007.
- 13. *stapled security* means an ordinary share in Cromwell Corporation Limited ACN 001 056 980 and an interest in the Cromwell Diversified Property Trust ARSN 102 982 598 which, under the terms on which each is to be traded, must be transferred together.

14. unit in relation to a share means a legal or equitable right or interest in the share.

- (c) no exemption under section 111AS or 111AT covered the body or the Subsidiary, or any person as director or auditor of the body or the Subsidiary, at any time in that 3 months; and
- (d) no order under section 340 or 341 covered the Subsidiary, or any person as director or auditor of the Subsidiary, at any time in that 3 months; and"
- (b) paragraph 708A(6)(d) of the Act was modified by omitting the word "has" and replacing it with the words "and the Subsidiary (as appropriate) have" and replacing the words "apply to the body" with

 - "(3) An offer of a body's securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:

 - (b) with the purpose of the person to whom they were issued:
