Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 1020F(1)(a) – Exemption

Under paragraph 1020F(1)(a) of the *Corporations Act* 2001 (*Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the persons specified in Schedule A from Division 2, 3, 4 and 5 of Part 7.9 of the Act in the case set out in Schedule B.

Schedule A

AMP Haumi Management Limited (*AMP*) a company incorporated in New Zealand in its capacity as manager of the AMP NZ Office Trust (*Trust*).

E.L. & C. Baillieu Stockbroking Ltd ACN 006 519 393.

Schedule B

Where:

- 1. AMP makes an offer for issue of interests in the Trust:
 - (a) which is made pro rata to each holder of interests of the same class as those the subject of the offer (whether on a renounceable or non-renouceable basis);
 - (b) in respect of which the terms and conditions of each offer made to a holder whose address, as shown in the register of holders, is a place within this jurisdiction (an *Australian holder*) are not less favourable than those extended to other holders;
 - (c) in respect of which the aggregate offer price of the interests offered to Australian holders is not more than 10% of the aggregate offer price of all of the interests offered to holders;
 - (d) being an offer of interests in the same class as interests which have been quoted on the New Zealand Stock Exchange (*NZSX*) throughout the 36 month period proceeding the offer and trading in which is not suspended;
 - (e) in respect of which each Australian holder is given the same access as other holders to written information (or where applicable an English translation of such information) pertaining to the offer; and
 - (f) which complies with all legislative requirements in New Zealand and the operating rules of the NZSX; and

- 2. AMP has not failed to lodge the following documents with ASIC before the day on which an offer is first made in this jurisdiction:
 - (a) a copy of the notice or disclosure document issued in relation to the interests (which copy may leave blank offeree particulars including entitlement particulars); and
 - (b) a statement disclosing the number and percentage of holders to whom offers are to be made whose addresses are places within the jurisdiction; and
- 3. The Trust is a unit trust.

Interpretation

For the purposes of this instrument:

- 1. an offer for issue of interests to holders shall be regarded as pro rata notwithstanding that:
 - (a) fractional entitlements are rounded up or down;
 - (b) a holder whose pro rata entitlement is less than a marketable parcel is offered a marketable parcel of the minimum possible size;
 - (c) an offer is not made to a holder (not being an Australian holder) whose address as shown in the register of holders is a place outside New Zealand (*overseas holder*); or
 - (d) under the offer the renounceable rights to which the overseas holder would otherwise have been entitled are issued instead to another holder for the purposes of, and on terms that the holder will sell those rights and account to the overseas holder for the proceeds of that sale;
- 2. interests shall be taken to have been quoted on the NZSX throughout the 36 month period preceding an offer if and only if:
 - (a) the interests were first quoted on that market not less than 36 months prior to that offer; and
 - (b) during that 36 month period those interests have been suspended from trading on that market for an aggregate period of not more than 5 trading days;
- 3. interests shall not be taken to be in different classes merely because of a temporary difference in the distribution rights attaching to the interests;

- 4. *unit trust* has a meaning effected by section 2 of the Unit Trusts Act 1960 of New Zealand and in relation to which a trust deed has been approved by the Registrar or District Registrar of Companies and an authenticated copy of the trust deed has been lodged with the District Registrar of Companies under sections 8 and 9 of that Act; and
- 5. offer has a meaning affected by subsection 1010C(2) of the Act.

Note: In this instrument, "this jurisdiction" means Australia: Act, ss 5 and 9 (definition of "this jurisdiction").

Australian Securities and Investments Commission Corporations Act 2001- Paragraphs 601QA(1)(b), 601QA(1)(a) and 1020F(1)(c)-Declarations and Exemptions

- Under paragraph 601QA(1)(b) of the Corporations Act 2001 (Act) the Australian Securities and Investments Commission (ASIC) declares that Chapter 5C of the Act applies to the persons specified in Schedule A in the case set out in Schedule B as if section 601GAA of the Act as notionally inserted into the Act by ASIC Class Order [CO 05/26] were modified or varied as follows:
 - (a) after subsection 601GAA(3), insert:
 - "(3A) An issue is taken to comply with subsection (3)(g) where the responsible entity:
 - (a) offers the interests in the scheme to some members earlier than to other members where:
 - (i) under the terms of the offer no member can be issued interests in the scheme under the offer before a time at which every member could accept the offer and be issued interests in the scheme under the offer; and
 - (ii) all members have a reasonable time, having regard to whether they are a retail client or not, to decide whether or not to accept the offer."
- 2. Under paragraph 601QA(1)(a) of the Act, ASIC exempts the persons specified in Schedule A in the case set out in Schedule B from paragraph 601FC(1)(d) of the Act to the extent that it would prevent the persons from making an offer permitted by subsection 601GAA(3) of the Act as notionally inserted into the Act by ASIC Class Order [CO 05/26] because offers of interests in the registered scheme are made to some members earlier than offers of interests to other members or are able to be accepted by some members at an earlier date than other members.
- 3. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies in relation to the persons specified in Schedule A in the case set out in Schedule C as if subsection 1017E(2) of the Act were modified or varied as follows:
 - (a) at the beginning of paragraph (b) insert "subject to paragraph (ba),"; and
 - (b) after paragraph (b) insert:
 - "(ba) any money may be paid into the account, provided that:
 - (i) money paid to acquire financial products that must, under the terms on which the financial products are to be traded, be transferred together; and

- (ii) any other money to which this section applies; and
- (iii) interest on the amount from time to time standing to the credit of the account;

is identified and held in accordance with all other provisions of this section; and".

- 4. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies in relation to the persons specified in Schedule A in the case in Schedule B as if section 1019A of the Act were modified or varied as follows:
 - (a) in subsection (1), omit the words "Subject to subsection (2)," and substitute the words "Subject to subsections (2) and (2A)"; and
 - (b) after subsection (2) insert a new subsection (2A) as follows:
 - "(2A) This Division does not apply to the issue of interests in a registered scheme under a rights issue in circumstances where section 1012DAA applies."

Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 911A(2)(1) — Exemption

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person referred to in Schedule A from the requirement to hold an Australian financial services licence in the case referred to in Schedule B.

Schedule A

BNP Paribas Asset Management U.K. Limited (the *body*) where all of the following apply:

- (a) the body has a current Part IV Permission; and
- (aa) the body is a body corporate incorporated in the United Kingdom; and
- (b) the body:
 - (i) is registered under Division 2 of Part 5B.2 of the Act; or
 - (ii) has not failed for more than the last 10 business days to have an Agent; and
- (c) the body's primary business is the provision of financial services; and
- (d) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument; and
- (e) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule C:
 - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (f) the body has not notified ASIC that it will not rely on this instrument.

Schedule B

Where:

- 1. the body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:
 - (a) providing financial product advice;
 - (b) dealing in a financial product;

- 2. the body has provided ASIC with:
 - (a) a copy of the Part IV Permission that the FSA has issued to it;
 - (b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument; and
 - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC; and
 - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and
 - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services; and

- (iv) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
- (v) the body covenants that, on written request of either the FSA or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the FSA to disclose to ASIC and ASIC to disclose to the FSA any information or document that the FSA or ASIC has that relates to the body; and
- (d) written consents to the disclosure by the FSA to ASIC and ASIC to the FSA of any information or document that the FSA or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule C

- 1. The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the UK regulatory requirements if the financial service were provided in the United Kingdom in like circumstances.
- 2. The body must:
 - (a) notify ASIC, as soon as practicable and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the Part IV Permission applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which the body obtains from the UK regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (aa) notify ASIC by 31 March and 30 September of each year in such form if any as ASIC may from time to time specify in writing:
 - (i) either:
 - (A) of the details of each significant change (a *notifiable regulatory change*) to the UK regulatory

requirements (including in the power or authority of the FSA to supervise, monitor or procure compliance by the body with the UK regulatory requirements with respect to the provision of the financial services) in the 6 months (the *notification period*) ending on the 15th day of the month by the end of which the notification is required that is relevant to the financial services the body provides or intends to provide in this jurisdiction and is not a change that ASIC has stated in writing is not required to be notified for the purpose of this instrument; or

- (B) where there have been no notifiable regulatory changes that there have been no notifiable regulatory changes; and
- (ii) either:
 - (A) of the details of each enforcement or disciplinary action (a *notifiable regulatory action*) taken by the FSA or any other overseas regulatory authority against the body during the notification period; or
 - (B) where there have been no notifiable regulatory actions that there have been no notifiable regulatory actions; and
- (b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
 - (i) the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
 - (ii) the body is regulated by the FSA under UK laws, which differ from Australian laws.

Interpretation

In this instrument:

ASIC Act means the Australian Securities and Investments Commission Act 2001 (Cth).

address, in relation to a company, means the address of the registered office of the company.

Agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of

this instrument, and who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in subsection 659B(1) of the Act.

custodial or depository service has the meaning given by section 766E of the Act.

derivative has the meaning given by section 761D of the Act.

eligible deposit product means any deposit-taking facility that is not a deposit product as defined in section 761A of the Act;

financial product advice has the meaning given by section 766B of the Act.

financial services law has the meaning given by section 761A of the Act.

foreign exchange contract has the meaning given by section 761A of the Act.

FSA means the Financial Services Authority of the United Kingdom;

FSM Act means the Financial Services and Markets Act 2000 of the United Kingdom;

making a market has the meaning given by section 766D of the Act.

notice and notified mean, respectively, written notice and notified in writing.

overseas regulatory authority means a foreign regulatory authority (other than the FSA) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body.

Part IV Permission means a permission given by the FSA under Part IV of the FSM Act;

securities has the meaning given by section 761A of the Act.

UK regulatory requirements means the rules that apply in relation to the financial services including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by the FSA; and

wholesale client has the meaning given in section 761G of the Act.

 - (i) an offer is made to each registered holder of shares in the class, and whose address (as recorded in the register of members) is in a place in which it is lawful and practical for the Issuer to offer and issue shares to that person, in the reasonable opinion of the Issuer;
