Australian Securities and Investments Commission Corporations Act 2001 – Subsection 741(1) – Exemption

Under subsection 741(1) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A, in the case referred to in Schedule B, from Parts 6D.2 and 6D.3 of the Act (other than sections 736 and 738).

Schedule A

Macarthur Coal Limited ACN 096 001 955 (Issuer)

Schedule B

A written offer on or about 23 June 2009 (*Offer*) for the issue of shares in the Issuer where the following requirements are met at the time that the Offer is made.

- (a) The shares will be in a class which:
 - (i) is quoted on the financial market operated by ASX;
 - (ii) was quoted at all times in the 3 months before the day on which the Offer is made;
 - (iii) was not suspended from trading on ASX for more than a total of 5 days during the shorter of the period during which the class of shares was quoted, and the period of 12 months preceding the day on which the Offer is made; and
 - (iv) is not suspended from trading.
- (b) None of the following provisions of the Act have been contravened in relation to the Issuer of the shares in the previous 12 months:
 - (i) a provision of Chapter 2M;
 - (ii) section 674 or 675;
 - (iii) section 724; and
 - (iv) section 728.

- (c) No exemption under section 111AS or 111AT of the Act covered the Issuer, or any person as director or auditor of the Issuer at any time in the 12 months preceding the day on which the Offer is made;
- (d) No order under section 340 or 341 of the Act covered the Issuer, or any person as director or auditor of the Issuer at any time in the 12 months preceding the day on which the Offer is made;
- (e) The Offer is made pursuant to an arrangement under which:
 - (i) an offer is made to each registered holder of shares in the class, and whose address (as recorded in the register of members) is in a place in which it is lawful and practical for the Issuer to offer and issue shares to that person, in the reasonable opinion of the Issuer;
 - (ii) each offer is made on the same terms and conditions and on a non-renounceable basis;
 - (iii) the issue price is less than the market price during a specified period in the 30 days prior to either the date of the offer or the date of the issue;
 - (iv) no registered holder may be issued with shares with an application price totalling more than \$15,000 in any consecutive 12 month period; and
 - (v) a registered holder must provide the Issuer on application for the shares with a certification to the effect that the aggregate of the application price for:
 - (A) the shares the subject of the application; and
 - (B) any other shares in the class applied for by the holder under the arrangement or any similar arrangement in the 12 months prior to the application,

does not exceed \$15,000.

- (f) The written offer document contains the following information:
 - (i) the method used to calculate the issue price and the time when this price will be determined;
 - (ii) a statement describing the relationship between the issue price and the market price; and
 - (iii) disclosure of the risk that the market price may change between the date of the offer and the date when the shares are issued to an applicant under the arrangement, and the effect this would have

on the price or value of the shares which the applicant would receive.

- (g) The Issuer gave ASX a notice not more than 30 days prior to the Offer that:
 - (i) relates to a separate offer of the Issuer's securities; and
 - (ii) complies with subsection 708A(6) of the Act.

Interpretation

For the purposes of this instrument:

- 1. ASX means ASX Limited ACN 008 624 691;
- 2. *registered holder* means, subject to paragraphs 3 and 4, a person recorded in the register of members of a company as a member of that company;
- 3. if 2 or more persons are recorded in the register of members as jointly holding shares in the company they are taken to be a single registered holder and a certification by any of them for the purposes of paragraph (e)(v) of Schedule B is taken to be a certification by all of them;
- 4. if a trustee or nominee is expressly noted on the register of members as holding shares on account of another person (a *beneficiary*):
 - a. the beneficiary is taken to be the registered holder in regard to those shares; and
 - b. any application for the issue of shares or certification for the purposes of paragraph (e)(v) of Schedule B by, and any issue of shares to, the trustee or nominee, is taken to be an application or certification by, or an issue to, the beneficiary; and
- 5. references to an issuer offering shares include the issuer inviting applications for the issue of the shares.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 741(1)(a) – Exemption

Australian Securities and Investments Commission Corporations Act 2001 (Cth) – Paragraph 911A(2)(I)

For the avoidance of doubt, under paragraph 911A(2)(1) of the *Corporations Act 2001* (Act), the Australian Securities and Investments Commission exempts a person (Accounting Firm) who is the holder of a general insurance product specified in Schedule A (Tax Audit Protection Policy) from subsection 911A(1) for any custodial or depository service provided to a Client of the Accounting Firm in the case set out in Schedule B.

Schedule A

A contract of insurance issued by Calliden Insurance Limited (Calliden), ACN 004 125 268, which provides cover for fees, charges or disbursements charged by the Accounting Firm or by a person engaged by the Accounting Firm for services provided in respect of any inquiry, investigation, review, examination or audit conducted by a statutory authority or agency in respect of documentation lodged by or on behalf of a Client.

Schedule B

Where the Accounting Firm:

- (a) does not hold an Australian financial services licence to provide a custodial or depository service in relation to the Tax Audit Protection Policy; and
- (b) has systems in place, and uses reasonable endeavours, to ensure that before a Client becomes covered by the Tax Audit Protection Policy:
 - (i) the Client is provided with details of any applicable dispute resolution system of the Accounting Firm and how that system may be accessed; and
 - (ii) the Client is informed of the name and contact details of Calliden and Calliden's relationship with the Accounting Firm; and
- (c) has systems in place, and uses reasonable endeavours, to ensure that the Accounting Firm's representatives do not provide any financial product advice to the Client in relation to any custodial or depository service provided to the Client, unless the Accounting Firm provides that service as an Australian financial services licensee or the representative of an Australian financial services licensee.

Interpretation

In this instrument:

Australian financial services licence has the meaning given in section 761A of the Act. *Client* means a person to whom the Accounting Firm has provided or intends to provide accounting or tax agent services.

custodial or depository service has the meaning given in section 766E of the Act. financial product advice has the meaning given in section 766B of the Act. general insurance product has the meaning given in section 761A of the Act.

Your attention is drawn to subsection 920C(2) of the Corporations Act 2001 which provides that a person must not engage in conduct which breaches a banning order that has been made against the person. Contravention of subsection 920C(2) is an offence.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(b), 655A(1)(b), 741(1)(a), 741(1)(b) and 1020F(1)(c) – Exemption and Declaration

- 1. Under paragraph 741(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from subsection 723(1) of the Act in the case specified in Schedule B.
- 2. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule C in the case specified in Schedule D as if Chapter 5C were modified or varied as follows:
 - (a) insert after subsection 208(2) of the Act as notionally inserted by section 601LC:
 - "(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
 - (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme (the *scheme*); or

 - (iii) an entity that is wholly owned, whether directly or indirectly, jointly by the scheme and the stapled company.
- (2B) For the purposes of this section:
 - (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and

- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries; and
- (c) an interest is a component of stapled security if:
 - (i) the interest and one or more other financial products must, under the terms on which each of the products are to be traded, only be transferred together; and
 - (ii) there are no financial products in the same class as those financial products which may be transferred separately."; and
- (b) omit paragraph 601FC(1)(c) and substitute:
 - "(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of shares in a company, where interests in the scheme are components of a stapled security) and, if there is a conflict between the members' interests and its own interests, give priority to the members' interests; and"; and
 - (c) omit paragraph 601FD(1)(c) and substitute:
 - "(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of shares in a company, where interests in the scheme are components of a stapled security) and, if there is a conflict between the members' interests and its own interests, give priority to the members' interests; and"; and
 - (d) omit paragraph 601FC(1)(e) and substitute:
 - "(e) not make use of information acquired through being the responsible entity in order to:
 - (i) gain an improper advantage for itself or another person; or
 - (ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and their interests as holders of shares in a company, where interests in the scheme are components of a stapled security); and"; and
 - (e) after subsection 601GAA(9) as notionally inserted into Chapter 5C of the Act by ASIC Class Order [CO 05/26], insert:
 - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:

- (a) the constitution makes provision for the issue price of stapled securities;
- (b) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the constitution;
- (c) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests; and
- (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution."; and
- (f) after section 601PC insert:

"601PC For the purposes of this Chapter:

stapled security means two or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.".

 - "(b) an offer of fully-paid shares in a body to 1 or more existing holders of shares in the body, under a plan for the reinvestment of at least one of the following:
 - (i) dividends in respect of shares in the body;
 - (ii) distributions in respect of interests in a registered managed investment scheme which, under the terms on which they may be traded, must only be transferred together with shares in the body.".
- 4. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies in relation to the person specified in Schedule C in the case specified in Schedule F as if subsection 1012D(3) were modified by:
 - (a) in paragraph 1012D(3)(b) omitting "either" and substituting "one or more of the following applies:"; and
 - (b) in subparagraph 1012D(3)(b)(i) omitting "or" (second occurring); and
 - (c) in subparagraph 1012D(3)(b)(ii) omitting "." and substituting ";"; and

- (d) after subparagraph 1012D(3)(ii) inserting:
 - "(iii) in a recommendation situation the advice that constitutes the relevant conduct relates to an offer of interests in a registered scheme, under a plan for the reinvestment or at least one of the following:
 - (A) distributions in respect of interests in the scheme;
 - (B) dividends in respect of shares in a body which, under the terms on which they may be traded, must only be transferred together with interests in the scheme;
 - (iv) in an issue situation the offer or issue that constitutes the relevant conduct is an offer or issue of interests in a registered scheme, under a plan for the reinvestment of at least one of the following:
 - (A) distributions in respect of interests in the scheme;
 - (B) dividends in respect of shares in a body which, under the terms on which they may be traded, must only be transferred together with interests in the scheme."
- 5. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies in relation to the persons specified in Schedule C in the case specified in Schedule G as if subsection 1017E(2) of the Act were modified or varied as follows:
 - (a) at the beginning of paragraph (b) insert "subject to paragraph (ba),"; and
 - (b) after paragraph (b) insert:
 - "(ba) any money may be paid into the account, provided that:
 - (i) money paid to acquire financial products that must, under the terms on which the financial products are to be traded, be transferred together; and
 - (ii) any other money to which this section applies; and
 - (iii) interest on the amount from time to time standing to the credit of the account;

is identified and held in accordance with all other provisions of this section; and".

6. Under paragraph 655A(1)(b) of the Act, ASIC declares that Chapter 6 of the Act applies to the person specified in Schedule E in the case specified in Schedule H as if item 7 of section 611 of the Act were modified or varied by inserting the following after paragraph (b):

"In this section, if at any time under the terms on which a security (the *first security*) is traded on a prescribed financial market it can only be transferred

together with one or more other securities or financial products (*second security*) and the holders of the first security approve the acquisition under this item 7, the acquisition of a relevant interest in the second security is taken to be approved by the holders of the second security."

- 7. Under paragraph 741(1)(b) of the Act, ASIC declares that Chapter 6D of the Act applies to the person specified in Schedule E in the case specified in Schedule I as if section 708A were modified or varied by deleting subsection 708A(13) as notionally inserted by ASIC Class Order [CO 04/671] and substituting the following new paragraph:
 - "(13) In this section, if at any time under the terms on which a security (the *first security*) is traded on a prescribed financial market it can only be transferred together with one or more other securities or financial products (the *second security*) (together the *stapled security*) then in relation to that time:
 - (a) the first security and the stapled security are taken to be in a class of quoted securities that is the same as any other class of quoted securities to which the second security belongs at any other time; and
 - (b) the first security and the stapled security is taken to be suspended from trading on the prescribed financial market on which it was quoted when trading in the class of second securities on that prescribed financial market is suspended."
- 8. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies to the person specified in Schedule C in the case specified in Schedule J as if section 1012DA were modified or varied by deleting subsection 1012DA(13) as notionally inserted by ASIC Class Order [CO 04/671] and substituting the following new paragraph:
 - "(13) In this section, if at any time under the terms on which a financial product (the *component product*) is traded on a prescribed financial market it can only be transferred together with one or more other securities or financial products (together the *stapled security*) then in relation to that time:
 - (a) the stapled security is taken to be in a class of quoted securities that is the same as any other class of quoted securities to which the component product belongs at any other time; and
 - (b) the stapled security is taken to be suspended from trading on the prescribed financial market on which it was quoted when trading in the class of the component product on that prescribed financial market is suspended."

Top Up Placement means an additional placement of Stapled Securities to Growthpoint to give Growthpoint a 60 % interest in the Stapled Securities following the completion of the Proposal.

Section 657A

Declaration of Unacceptable Circumstances

DataDot Technology Limited

CIRCUMSTANCES

- 1. DataDot Technology Limited (**DataDot**) undertook a 1:1 non-renounceable rights issue at 1 cent per share, as announced on 24 March 2009.
- The rights issue was underwritten by KTM Capital Pty Ltd (KTM). Mr Tod McGrouther and Mr Keith Kerridge are the directors of KTM. Mrs Vicki McGrouther and Keith Kerridge are the major shareholders of KTM.
- 3. KTM arranged for the rights issue to be sub-underwritten by TM Consulting Pty Ltd (TM Consulting) and Bannaby Investments Pty Ltd (Bannaby Investments). Tod McGrouther is the sole director of, and he and his wife the only shareholders in, TM Consulting. Keith Kerridge is the sole director and shareholder of Bannaby Investments.
- 4. It was agreed that the rights issue be sub-underwritten in equal proportions. However, it was subsequently agreed that the sub-underwriters' proportions be changed so that:
 - (a) 36,887,049 shares were issued to TM Consulting and
 - (b) 38,287,049 shares were issued to Bannaby Investments.
- 5. Following the sub-underwriting, TM Consulting had a relevant interest in 17.2% of DataDot and Bannaby Investments had a relevant interest in 19.7% of DataDot.
- The Panel considers that TM Consulting and Bannaby Investments are associates under section 12(2) of the Corporations Act in relation to the affairs of DataDot.
- 7. All reasonable steps to minimise the potential control impact of the rights issue on DataDot were not taken as:
 - (a) no facility for shareholders to take up shares in excess of their entitlement was included in the rights issue, even though requested subsequently by DataDot's chairman
 - (b) no inquiries were made of potential sub-underwriters at 1 cent per share other than TM Consulting and Bannaby Investments
 - (c) KTM did not inform DataDot of the sub-underwriters and
 - (d) insufficient disclosure was made in the letter of offer of the sub-underwriting and potential control impact of the rights issue (the **Rights Issue circumstances**).
- 8. In addition, in the letter of offer there was:
 - (a) insufficient disclosure of:
 - (i) the sub-underwriting
 - (ii) the potential voting power in DataDot that TM Consulting and Bannaby Investments may have obtained as a result of the sub-underwriting and

- (iii) DataDot's need of funds and
- (b) misleading disclosure in relation to the intentions of KTM, and the potential subscription by KTM (if shareholders did not take up all their entitlements), given that the rights issue had been fully sub-underwritten and relevant disclosure in relation to the sub-underwriters was not included (the Letter of Offer circumstances).
- 9. In addition, TM Consulting and Bannaby Investments each failed to comply with their substantial holding notice obligations by:
 - (a) failing to disclose that they were associates
 - (b) failing to disclose their voting power in DataDot and
 - (c) failing to attach their sub-underwriting agreements with KTM (the **Substantial Holding Notice circumstances**).
- 10. It appears to the Panel that each of the Rights Issue circumstances, Letter of Offer circumstances and Substantial Holding Notice circumstances are unacceptable:
 - (a) having regard to the effect that the Panel is satisfied the circumstances have had, are having, will have or are likely to have on:
 - (i) the control, or potential control, of DataDot or
 - (ii) the acquisition, or proposed acquisition, by TM Consulting and Bannaby Investments of a substantial interest in DataDot or
 - (b) having regard to the purposes of Chapter 6 set out in section 602 of the *Corporations Act* 2001 (Cth) or
 - (c) because they:
 - (i) constituted, constitute, will constitute or are likely to constitute a contravention of a provision of Chapter 6C of the *Corporations Act 2001* (Cth) or
 - (ii) gave or give rise to, or will or are likely to give rise to, a contravention of a provision of Chapter 6C of the *Corporations Act 2001* (Cth).
- 11. The Panel considers that it is not against the public interest to make a declaration of unacceptable circumstances in relation to the circumstances and the affairs of DataDot.
- 12. The Panel has had regard to the matters in section 657A(3).

DECLARATION

Under section 657A, the Panel declares that the circumstances constitute unacceptable circumstances in relation to the affairs of DataDot.

- 1. A declaration of unacceptable circumstances in relation to the affairs of DataDot Technology Limited (DataDot) on 17 June 2009.
- 2. Section 657D of the Corporations Act 2001 (Cth).

THE PANEL ORDERS

Divestment

 TM Consulting Pty Ltd (TM Consulting) and Bannaby Investments Pty Ltd (Bannaby Investments) divest shares they received as sub-underwriters of the DataDot rights issue announced on 24 March 2009 as set out in these orders.

Offer of shortfall

- 2. Within 10 business days of these orders DataDot must, on behalf of TM Consulting and Bannaby Investments, offer eligible DataDot shareholders the 75,174,098 shares obtained by TM Consulting and Bannaby Investments under the rights issue short fall on terms to the following effect:
 - (a) the price is the rights issue price of 1 cent per share
 - (b) the offer is open for 2 weeks from the date the last of the offers is dispatched
 - (c) shareholders who did not take up their full entitlement in the rights issue are offered as many shares as is necessary for them to take up what were their full original entitlements
 - (d) shareholders are invited to apply to buy any shares remaining after the acceptances in order 2(c) have been satisfied in full, provided that applications for remaining shares may be scaled back only if:
 - (i) the number of shares applied for exceeds the number remaining and
 - (ii) the applications are scaled back reasonably and fairly, having regard to the number of applicants, shares applied for and their shareholdings at the close of the rights issue. For avoidance of doubt:
 - (A) the Corporations Act limits apply to the acquisition of shortfall shares

- (B) TM Consulting and Bannaby Investments may participate in the shortfall on the basis that they are associates and
- (C) shareholders who accept for shares under order 2(c) are treated as if they had subscribed for those shares pursuant to the rights issue.
- (e) the money (in cheque or other form acceptable to DataDot) for the shares accepted or applied for (as the case may be) is to be sent to DataDot with the acceptance or application. The money is to be banked in a special purpose trust account no later than the end of the day of receipt.
- 3. Within 5 business days of the close of the offer, DataDot must:
 - (a) scale back the applications if necessary
 - (b) disclose in a market announcement the scale back and its detailed calculation methodology
 - (c) register the transfers of the shares and
 - (d) pay over the money, and account, to TM Consulting and Bannaby Investments for the shares sold.
- 4. TM Consulting and Bannaby Investments must provide proper transfers for the sale of their shares.
- 5. DataDot must pay half the reasonable costs of dispatching the offers and processing the acceptances, applications and refunds (if any).
- 6. TM Consulting and Bannaby Investments must pay, in aggregate, half the reasonable costs of dispatching the offers and processing the acceptances, applications and refunds (if any), but can decide between themselves the proportion each bears.
- 7. DataDot must issue any refund due to an applicant within 5 business days of transfers being completed.
- 8. The offer referred to in order 2 must be made in a letter of offer dispatched to eligible DataDot shareholders.

Disclosure

- 9. The letter of offer must include detailed disclosure on:
 - (a) the terms of the offer
 - (b) the decision of the Panel
 - (c) the intentions of each of TM Consulting and Bannaby Investments in relation to DataDot should they retain any of the shares received pursuant to the sub-underwriting
 - (d) the control effects on DataDot as a result of the current holdings of TM Consulting and Bannaby Investments recognising their association.
- A draft copy of the letter of offer must be provided to the Panel for approval prior to its dispatch to DataDot shareholders.
- 11. TM Consulting must correct its substantial holder notice dated 13 May 2009 as soon as practicable to:

- (a) specify that it and Bannaby Investments are associates in relation to their holdings in DataDot; and
- attach a copy of the sub-underwriting agreement between it and KTM Capital Pty Limited (KTM Capital).
- Bannaby Investments must correct its substantial holder notice dated 14 May 2009 as soon as practicable to:
 - specify that it and TM Consulting are associates in relation to their holdings in DataDot; and
 - attach a copy of the sub-underwriting agreement between it and KTM Capital.

Definition of eligible shareholders

In these orders, eligible DataDot shareholders are shareholders who were eligible to participate in the rights issue announced on 24 March 2009.

Shareholders meeting

The meeting that is to be scheduled pursuant to a request under section 249D of the Corporations Act announced on 26 May 2009 must not take place until at least 2 business days after the transfers of the shortfall shares have been registered.
