#### 1 Name of Notice

This Notice is the Corporations Act (GFI Brokers Limited) Exemption Notice 2007.

#### 2 Commencement

This Notice commences on the day it is notified in the Gazette.

#### 3 Definitions

In this Notice:

Act means the Corporations Act 2001.

Australian participant means a person in Australia who is a participant. Class Order [CO 03/1099] means Class Order [03/1099], titled 'UK FSA regulated financial service providers':

(a) issued by ASIC on 22 December 2003; and

- (b) notified in the Gazette on 23 December 2003; and
- (c) in force on the date of the gazettal of this exemption.

credit default swap has the meaning as an agreed market standard term as set out in the Australian Financial Markets Association's 'OTC Financial Product Conventions for Credit Derivatives'.

Note The Australian Financial Markets Association is also known as AFMA.

derivative has the meaning given by section 761A of the Act.

financial year means the financial year ending 31 December.

foreign exchange contract has the meaning given by section 761A of the

foreign participant means a participant who is not an Australian participant. *GFI* means GFI Brokers Limited.

GFI Market means the financial market operated by GFI, which consists of CreditMatch and ForexMatch trading platforms, as described in the application for the exemption set out in this Notice.

ISDA Master Agreement means a master agreement issued by the International Swaps and Derivatives Association, Inc.

participant has the meaning given by section 761A of the Act.

Part IV Permission means a permission issued by the UK FSA under Part IV of the Financial Services and Markets Act 2000 of the United Kingdom.

UK FSA means the Financial Services Authority in the United Kingdom.

#### 4 Exemption

For section 791C of the Act, and subject to the conditions mentioned in sections 5 to 14 of this Notice, the GFI market is exempt from the operation of Part 7.2 of the Act.

#### 5 Operation of GFI Market

- (1) GFI must operate the GFI Market in all essential details in the way set out in:
  - (a) the application for this exemption by GFI dated 20 April 2007; and
  - (b) letters from GFI dated 5 June 2007 and 16 July 2007.
- (2) GFI must, at all times, hold a current Part IV Permission that covers the provision of the financial services involved in the operation of the GFI Market.
- (3) GFI must, at all times, comply with Class Order [CO 03/1099].
- (4) GFI, or an associate of GFI, must not operate a clearing and settlement facility for the GFI Market.

#### Section 9

#### 6 Financial products that may be traded on the GFI Market

GFI must not trade in a financial product on the GFI Market other than the following:

- (a) foreign exchange contracts that are foreign exchange options entered into under the ISDA Master Agreement or another Master Agreement commonly used by counterparties for that purpose;
- (b) credit default swaps entered into under the ISDA Master Agreement or another Master Agreement commonly used by counterparties for that purpose.

#### 7 Participants who may trade on the GFI Market

- (1) GFI must not admit an Australian participant to, or allow an Australian participant to enter into a trade on, the GFI Market unless the Australian participant is a professional investor who is trading:
  - (a) on its own behalf; or
  - (b) on behalf of another professional investor.
- (2) GFI must not admit a foreign participant to, or allow a foreign participant to enter into a trade on, the GFI Market unless the foreign participant is a professional or institutional investor in the jurisdiction in which the participant trades, and trading:
  - (a) on its own behalf; or
  - (b) on behalf of another professional investor.

#### 8 Conflict of interest

GFI must establish and maintain adequate arrangements, with which ASIC must be satisfied, for the management of any conflict of interest that may arise in relation to activities undertaken by GFI in the operation of the GFI Market.

#### 9 Reporting of certain events involving an Australian participant

- (1) If GFI takes disciplinary action against an Australian participant of the GFI Market, GFI must, as soon as practicable, advise ASIC in writing of:
  - (a) the participant's name; and
  - (b) the reason for and nature of the action taken.
- (2) If GFI has information that would cause a person to believe or suspect, on reasonable grounds, that an Australian participant has committed, is committing, or is about to commit, a significant contravention of the Act or the GFI Market's operating rules, GFI must, as soon as practicable, advise ASIC in writing of:
  - (a) the Australian participant's name; and
  - (b) details of the contravention or impending contravention; and
  - (c) GFI's reason for that belief or suspicion.

#### Section 10

# 10 Reporting of certain events involving GFI or a director or secretary of GFI

- (1) If GFI becomes aware that GFI, or a director or secretary of GFI:
  - (a) is the subject of a declaration of contravention in relation to a provision of the Act; or
  - (b) has been convicted of an offence under the Act; or
  - (c) has been disqualified from managing a corporation; or
  - (d) has been banned or disqualified from providing financial services;
  - GFI must advise ASIC of the matter, in writing, within 14 days after GFI becomes aware of the matter.
- (2) If GFI ceases to operate any of the platforms of the GFI Market in Australia, GFI must notify ASIC of that matter, in writing, within 7 days.

#### 11 Annual report

- (1) Within three months of the end of GFI's financial year, GFI must submit a report to ASIC that sets out the extent to which GFI has complied with the conditions of the exemption during the financial year.
- (2) The report must include the following information:
  - (a) a description of the activities that GFI has undertaken in the financial year in relation to the operation of the GFI Market;
  - (b) the number, duration, cause and resolution of material system outages that prevented Australian participants from using the GFI Market;
  - (c) the names of Australian participants authorised to access the GFI Market at the beginning and end of the financial year respectively;
  - (d) the number of Australian participants authorised to access the GFI Market at the beginning and end of the financial year respectively;
  - (e) details of the volume of trading on the GFI Market by Australian participants;
  - (f) the number and nature of significant complaints made to GFI by Australian participants of the GFI Market, and the action taken by GFI in response to each complaint;
  - (g) details of any specific regulatory issues that GFI encountered during the year (including any change in regulatory status in its home jurisdiction), and the action taken to resolve the issue (inside or outside Australia);
  - (h) details of any significant conflict of interest identified by GFI in relation to its operation of the GFI Market, and how it was resolved.

# 12 Minister may require GFI to submit to an audit

(1) The Minister may, by notice in writing, require GFI to obtain an audit report on the annual report mentioned in section 11 and on any information or statement accompanying the report.

#### Section 14

- (2) The Minister may nominate:
  - (a) ASIC; or
  - (b) another person or body that is suitably qualified to undertake audits; to prepare the audit report.

#### 13 GFI to give assistance to ASIC

- (1) GFI must, if it receives a reasonable request to do so, give assistance to:
  - (a) ASIC; or
  - (b) a person authorised by ASIC; in relation to the performance of ASIC's functions regarding the operation of the GFI Market.
- (2) The assistance may include giving access to information, documents or books held by, or relating to, GFI.

### 14 GFI must enter into a written agreement with ASIC

GFI must enter into a written arrangement with ASIC for cooperation with ASIC in matters to which this Notice relates.



# Annexure A Corporations Act Section 657A Declaration of Unacceptable Circumstances

#### In the matter of CONSOLIDATED MINERALS LIMITED 03R

#### **WHEREAS**

#### Circumstances

- Consolidated Minerals Limited is a listed public company (Consolidated Minerals).
   It is the subject of an off market takeover bid (Pallinghurst Offer) by Pallinghurst Resources Australia Limited (Pallinghurst) and an off market takeover bid (Palmary Offer) by Palmary Enterprises (Australia) Pty Limited (Palmary).
- 2. On 12 October 2007 Pallinghurst lodged with ASX Limited its second supplementary bidder's statement in relation to the Pallinghurst Offer. This provided for an additional form of consideration of \$4.50 cash plus a Top-up Note, as an alternative to the existing \$4.50 cash offer consideration.
- 3. The Top-up Note would operate to pay electing shareholders an additional cash payment that would match an increase in the offer price for Consolidated Minerals shares under the Palmary Offer, subject to the conditions set out in Pallinghurst's second supplementary bidder's statement. The cash payment under the Top-up Note (if any) would be payable even if it was triggered after the Pallinghurst Offer had closed.

#### Circumstances are unacceptable

- 4. It appears to the Panel that the circumstances referred to above (Circumstances) are unacceptable having regard to:
  - (a) the effect that the Panel is satisfied that the Circumstances have had, are having, or are likely to have, on:
    - (i) the control or potential control of Consolidated Minerals; or
    - (ii) the acquisition or proposed acquisition by Pallinghurst or Palmary of a substantial interest in Consolidated Minerals; or
  - (b) the purposes of Chapter 6 of the Act as set out in section 602 of the Act.
- 5. The Panel considers that it is not against the public interest to make a declaration of unacceptable circumstances in relation to the Circumstances and the affairs of Consolidated Minerals.
- 6. The Panel has had regard to the matters in subsection 657A(3) of the Act, but has not had regard to whether the Circumstances constitute, will constitute or are likely to constitute or give rise to a contravention of Chapters 6, 6A, 6B or 6C of the Act.

# In the matter of CONSOLIDATED MINERALS LIMITED 03R

#### **PURSUANT TO:**

- A declaration of unacceptable circumstances (Declaration) in relation to the affairs of Consolidated Minerals Limited (Consolidated Minerals) made by the Takeovers Panel (Panel) on 10 November 2007 under section 657A of the Corporations Act 2001 (Cth) (Act); and
- 2. Section 657D of the Act;

#### THE PANEL ORDERS THAT

- 3. As soon as practicable after the date of this order, Pallinghurst Resources Australia Limited (Pallinghurst) withdraw from its off market takeover bid for Consolidated Minerals (Pallinghurst Offer) the alternative consideration of \$4.50 cash and one Top-up note by issuing a supplementary bidder's statement.
- 4. All Top-up notes issued by Pallinghurst pursuant to the Pallinghurst Offer be cancelled.
- 5. Each Consolidated Minerals shareholder who did both of the following:
  - (a) accepted the Pallinghurst Offer after the dispatch of Pallinghurst's second supplementary bidder's statement; and
  - (b) accepted the consideration alternative of \$4.50 and one Top-up note;

#### (Affected Consolidated Minerals Shareholder)

has a right to withdraw their acceptance, which is equivalent to the right conferred by section 650E of the Corporations Act (except that the period of notice in paragraph 650E(2)(a) of the Corporations Act shall be 10 business days after Pallinghurst sends the letter referred to in paragraph 6).

- Pallinghurst as soon as practicable send:
  - (a) a letter (in a form acceptable to the Panel) to each Affected Consolidated Minerals Shareholder informing them of their withdrawal rights and clearly setting out what the shareholder must do to exercise those withdrawal rights; and

- (b) a letter (in a form acceptable to the Panel) to each shareholder who accepted the Pallinghurst Offer before the dispatch of Pallinghurst's second supplementary bidder's statement and subsequently elected to receive the consideration alternative of \$4.50 and one Top-up note informing them of the effect of these orders on the alternative.
- 7. Pallinghurst may withdraw its statement of 12 October 2007 that it has declared the \$4.50 cash component of the Pallinghurst Offer final in the absence of a competing higher offer. If Pallinghurst chooses to withdraw its statement, it must do so by issuing a supplementary bidder's statement no later than 4.00 pm (Melbourne time) on the day after the date of these orders.
- 8. Pallinghurst may withdraw its statement of 12 October 2007 that there will be no further voluntary extension of the Pallinghurst Offer. If Pallinghurst chooses to withdraw its statement, it must do so by issuing a supplementary bidder's statement no later than 4.00 pm (Melbourne time) on the day after the date of these orders.
- 9. If Pallinghurst is required to issue a supplementary bidder's statement by paragraph 7 or 8 above, Pallinghurst must further extend its offer until the date at least 7 days after the day that it issues the supplementary bidder's statement.

and section 708 and 708A does not say otherwise.

- (4) Unless the contrary is proved, a body is taken to issue securities with the purpose referred to in paragraph (3)(b) if any of the securities are subsequently sold, or offered for sale, within 12 months after their issue.".
- 3. Under paragraph 911A(2)(l) of the Act, ASIC exempts the persons in Schedule A from the requirement to hold an Australian financial services licence for the provision or giving of financial product advice in the case in Schedule E.
