CORPORATIONS ACT 2001 REFERENCES

The Corporations Act 2001 came into force on 15 July 2001 replacing the Corporations Law. All references to the exercise of a power or the performance of a function under the Corporations legislation from 15/07/2001 should be to the 'Corporations Act 2001'.

Please note: Cash payment notices will not be published unless they are accompanied by a cheque or money order.

- (1) No facsimile or photocopy of a cheque will be accepted as proof of payment.
- (2) If payment has not been received by the close-off date, a late fee of 50% will be required for that notice to be included in the pending issue of the Gazette.

CLOSING TIMES

ALL NOTICES

LATE NOTICES

Late notices are accepted up to Wednesday, 4.00-p.m. in the week prior to publication and will incur a 50% surcharge on the normal fee in addition to the normal fee.
