What you need to know about suppression of business name details before you begin.

We have the power to suppress details from the public register if you lodge a request with us using this transaction. If we approve your request we may suppress some or all of the details you have requested to be suppressed.

We will not suppress:

- the business name or details relating to the registration dates and status of the registration of the business name, or
- · the address for the service of documents, therefore, the address for service should not be your residential address.

Certain types of information are already not made available on the public register, such as an individual's date or place of birth, their residential addresses (if identified to ASIC as a residential address), email addresses or mobile telephone numbers.

Before we will make a decision to suppress a detail on the business names register, we must be satisfied that it is not appropriate to disclose the detail. Therefore, in your request you must also tell us why the details should be suppressed. We will also consider if these details are already in the public domain, for instance, on the Australian Electoral Roll or Australian Business Register.
