**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this declaration under paragraph 655A(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 15-1223.

Commencement

3. This instrument commences on 23 December 2015.

Declaration

4. Chapter 6 of the Act applies to Ferrovial Services Australia Pty Limited ACN 609 542 556 (*Ferrovial*) as if Part 6.5 were modified or varied as follows:

- (a) in item 6 of the table in subsection 633(1) (as notionally modified by ASIC Class Order [CO 13/528], omit "item 2.", insert:

"item 2, or on terms that differ from the lodgement terms solely in accordance with a permitted variation".

- (b) in paragraph 633A(3) (as notionally inserted by ASIC Class Order [CO 13/528]):

- (i) after "subsection 633(1):" insert:

"lodgement terms mean the terms of the offer set out in the original bidder's statement and offer document (if any) lodged with ASIC under item 2 of the table in subsection 633(1).

permitted variation means a difference arising from a variation to the terms of an offer to:

- a) exclude the application of a defeating condition relating to regulatory action where such action is taken by ASIC or the Takeovers Panel; and
- b) include an additional defeating condition that the bidder receives all consents, approvals or clearances required under the applicable laws of New Zealand for the implementation of the offer and such consents, approvals

or clearances (as the case may be) have not been withdrawn, suspended, revoked or adversely amended before the close of the offer period."

Where this instrument applies

5. This instrument applies in relation to an off-market bid by Ferrovia for all of the fully paid ordinary shares of Broadspectrum Limited ACN 000 484 417 in respect of which a bidder's statement was lodged with ASIC on 7 December 2015 and a supplementary bidder's statement was lodged on or about the date of this instrument.

Australian Securities and Investments Commission
Corporations Act 2001 – Subsections 601QA(1), 741(1), 911A(2),
992B(1) and 1020F(1) – Exemptions

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsections 601QA(1), 741(1), 911A(2), 992B(1) and 1020F(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 15/1225.

Commencement

3. This instrument commences on gazettal.

Disclosure relief

4. Lynas Corporation Limited ACN 009 066 648 (*Lynas*), or an associated body corporate that makes an offer of an eligible product to an eligible participant under the EST does not have to comply with Part 6D.2, 6D.3 or Part 7.9 of the Act, provided the offer is made on or before the expiry day.
5. The trustee does not have to comply with Part 6D.2, 6D.3 or Part 7.9 of the Act in relation to the offer of a unit in the eligible product to an eligible participant under the EST.
6. A holder of an underlying eligible product that makes a sale offer of that product within 12 months after the issue of the product does not have to comply with Part 6D.2, 6D.3 or Part 7.9 of the Act in relation to the sale offer where the product was issued or otherwise granted:
 - (a) to an eligible participant under the EST; or
 - (b) to a trustee in connection with the EST.

Personal advice given by advisers

7. An eligible product offered under the EST is exempt from section 1012A of the Act to the extent that section requires a person to give a Product Disclosure Statement for an eligible product to an eligible participant.

Licensing, hawking and other incidental relief*General advice*

8. Lynas or an associated body corporate does not have to comply with subsection 911A(1) of the Act in relation to the provision of a financial service consisting of general advice in

connection with an offer under the EST.

Dealing

9. Lynas or an associated body corporate does not have to comply with subsection 911A(1) of the Act in relation to the provision of any of the following financial services in relation to an offer in connection with the EST:
- (a) issuing the eligible product;
 - (b) dealing in the eligible product where any acquisition by purchase or disposal of the eligible product by Lynas or an associated body corporate occurs either:
 - (i) through a financial services licensee; or
 - (ii) outside this jurisdiction and through a person which is licensed or otherwise authorised to deal in financial products of that kind in the relevant place.

Custodial or depository services

10. Lynas or an associated body corporate does not have to comply with subsection 911A(1) of the Act in relation to the provision of any of the following financial services in connection with the EST:
- (a) a custodial or depository service in relation to the eligible product where the body performs their duties in good faith and has sufficient resources to perform those duties;
 - (b) dealing in the eligible product in the course of providing a custodial or depository service covered by paragraph (a).

Hawking

11. Lynas or an associated body corporate does not have to comply with section 736 or 992A of the Act in relation to making an offer of an eligible product to an eligible participant in the course of, or because of, an unsolicited meeting or telephone call held or made in connection with the EST.

Advertising

12. Lynas or an associated body corporate does not have to comply with section 1018A of the Act in relation to an advertisement or publication that advertises, or publishes a statement that is reasonably likely to induce eligible participants to acquire, an eligible product under the EST.

Conditions

13. Lynas and any person relying on this instrument must comply with the conditions imposed by it as they apply to the person.

Disclosure

14. Lynas or an associated body corporate that makes an offer under the EST must ensure that an offer is made in, or is accompanied by:
- (a) an offer document; and
 - (b) a copy of the independent valuation.

5% issue limit

15. Lynas or an associated body corporate that makes an offer under the EST must, at the time of making the offer, have reasonable grounds to believe that the number of underlying eligible products in a class of underlying eligible products that form part of the issued capital of Lynas that have been or may be issued in any of the circumstances covered by the following paragraphs will not exceed 5% of the total number of underlying eligible products in that class on issue:
- (a) underlying eligible products that may be issued under the offer;
 - (b) underlying eligible products issued or that may be issued as a result of offers made at any time during the previous 3 year period under an employee incentive scheme or like scheme of Lynas or an associated body corporate (whether or not the other employee incentive schemes are covered by this instrument).

Trusts

16. Lynas or an associated body corporate that makes an offer of an eligible product under the EST in relation to which a trustee holds or will hold the eligible products must ensure:
- (a) the activities of the trustee of the trust in that capacity are limited to employee incentive schemes of Lynas or an associated body corporate of Lynas (whether or not the other employee incentive schemes are covered by this instrument);
 - (b) the trustee maintains written records on the administration of the trust including, in the case of eligible products being held for a specified eligible participant on an allocated basis, written records that identify the eligible products held on an allocated basis for the specified eligible participant;
 - (c) the trustee does not levy any fees or charges for administering the trust that are payable directly by any eligible participant or out of the assets of the trust, other than reasonable disbursements including brokerage and tax levied or incurred in connection with the Lynas Corporation Employee Share Trust;
 - (d) if the trustee is Lynas or an associated body corporate—the trustee does not, at its own discretion, exercise any voting rights attaching to any of the underlying eligible products that it holds on trust; and
 - (e) the trustee, either alone or together with one or more other trustees, does not hold more than 5% of the voting shares or voting interests in Lynas calculated by reference to all employee incentive schemes or like schemes of Lynas or an

associated body corporate.

Contribution plans

17. Lynas or an associated body corporate that makes an offer under the EST must ensure that the terms of the EST do not involve a contribution plan (other contributions than from a loan from Lynas or an associated body corporate to an eligible participant).

Loans

18. Lynas or an associated body corporate making an offer of an eligible product under the EST that involves a loan from Lynas or an associated body corporate to an eligible participant to acquire the product:

- (a) must ensure that under the terms of the loan:
- (i) no fees or interest is payable; and
 - (ii) either:
 - (A) the lender has no recourse against the participant in relation to the repayment of the loan; or
 - (B) the recourse of the lender against the participant in relation to the repayment of the loan is limited to forfeiture of the eligible products issued or transferred to, or held on behalf of, the participant in connection with the scheme.

ASIC power to request documents

19. Lynas or a person relying on this instrument must, if requested by ASIC and in accordance with the request, make available to ASIC the offer document and all other accompanying information or documents given to eligible participants in connection with an offer under the EST that is made in reliance on this instrument.

Interpretation

20. In this instrument:

- (a) *associated body corporate* means:
- (a) a body corporate that is a related body corporate of the body; or
 - (b) a body that has voting power in the body of not less than 20%; or
 - (c) a body corporate in which the body has voting power of not less than 20%;

casual employee, in relation to Lynas or an associated body corporate, means an individual who is, or might reasonably be expected to be, engaged to work the number of hours that are the pro-rata equivalent of 40% or more of a comparable full-time position with the body;

contractor, in relation to Lynas or an associated body corporate, means:

- (a) an individual with whom the body has entered into a contract for the provision of services under which the individual performs work for the body; or
- (b) a company with whom the body has entered into a contract for the provision of services under which an individual, who is a director of the company or their spouse, performs work for the body;

where the individual who performs the work under or in relation to the contract is, or might reasonably be expected to be, engaged to work the number of hours that are the pro-rata equivalent of 40% or more of a comparable full-time position with the body;

contribution, in relation to a contribution plan, does not include:

- (a) nominal monetary consideration; or
- (b) a monetary contribution as consideration for an issue, transfer or grant of an eligible product to the eligible participant without undue delay (including a monetary contribution made to exercise an eligible product or cause an eligible product to vest);

contribution plan means a plan under which an eligible participant may make monetary contributions to acquire eligible products, whether made before or after the acquisition, from one or more of the following:

- (a) gross (before-tax) wages or salary;
- (b) net (after-tax) wages or salary;
- (c) other monies;

eligible financial market means the financial market specified in column 1 of Table A;

eligible participant, in relation to Lynas or an associated body corporate, means a person specified in column 3 of Table A;

eligible product means a financial product of Lynas specified in column 2 of Table A;

employee incentive scheme means an arrangement under which offers of financial products of a body are made by the body or an associated body corporate of the body to persons that is designed to support interdependence between the body and those persons for their long-term mutual benefit;

EST means the Lynas Corporation Employee Share Trust which is comprised in documents being in substantially the same form as provided to ASIC on 3 July

2015 and 31 August 2015;

expiry day means the day that is three years after the date of this instrument;

financial product advice has the meaning given by section 766B of the Act;

general advice has the meaning given by section 766B of the Act;

independent valuation means an independent expert's report that contains:

- (a) an opinion on the value of the eligible products offered under the EST;
- (b) an explanation of the valuation methodologies used to reach the valuation conclusion; and
- (c) an explanation regarding the reasonable basis for the valuation conclusion;

nominal monetary consideration means monetary consideration of a token or trivial amount;

offer, in relation to an eligible product, has a meaning affected by sections 700, 702 and 1010C of the Act and includes:

- (a) an offer to issue the eligible product;
- (b) an issue or grant of the eligible product;
- (c) an offer to transfer the eligible product;
- (d) a transfer of the eligible product;
- (e) an offer to arrange for the issue or transfer of the eligible product;

but does not include an issue, grant or transfer of an underlying eligible product made by reason of the exercise or vesting of an overlying eligible product in circumstances where an offer to issue or transfer the overlying eligible product had been previously made;

offer document, in relation to an offer of eligible products under the EST, means a document which includes, or is accompanied by, the following information, statements and explanations worded and presented in a clear, concise and effective manner:

- (a) on the cover page of the offer document, in a box and in a minimum font size of 14 points—prominent statements to the following effect:
 - (i) the eligible products offered under this document may or may not have any value that is capable of being realised by the eligible participant;
 - (ii) whether the eligible products have any value that is capable of being realised by the eligible participant will depend on future events which

may or may not occur;

- (b) prominent statements to the effect that:
- (i) any advice given by Lynas in relation to eligible products offered under the EST does not take into account an eligible participant's objectives, financial situation and needs; and
 - (ii) eligible participants should consider obtaining their own financial product advice from a person who is licensed by ASIC to give such advice;
 - (iii) eligible participants may, at any time during the operation of the EST, make a request to be given, without charge, a copy of the most recent independent valuation;
- (c) either:
- (i) a copy of the terms of the EST; or
 - (ii) a summary of the terms of the EST together with a statement that, on request and at no charge and within a reasonable time, the body will provide an eligible participant with a copy of the terms of the EST;
- (d) either:
- (i) a copy of the trust deed under which the trustee will hold underlying eligible products in connection with the EST; or
 - (ii) a summary of the terms of the trust deed together with a statement that, on request and at no charge and within a reasonable time, Lynas will provide an eligible participant with a copy of the trust deed;
- (e) a copy of the terms of the loan;
- (f) the acquisition price of the eligible products in Australian dollars or, where the acquisition price is to be worked out in the future under a formula, an explanation of how an eligible participant could calculate the acquisition price of the eligible products in Australian dollars were that formula applied at the date of the offer; and
- (g) an explanation of how an eligible participant could, from time to time, ascertain the market price of the underlying eligible products in Australian dollars;

overlying eligible product means an eligible product specified in paragraph (b) or (c) in column 2 of Table A;

prospective participant, in relation to an offer of an eligible product under the EST, means a person to whom the offer is made but who can only accept the offer if an arrangement has been entered into that will result in the person becoming covered

by one of paragraphs (a) to (d) of column 3 of Table A;

related body corporate has the meaning given in section 50 of the Act;

trustee means either:

- (a) Lynas; or
- (b) an associated body corporate of Lynas; or
- (c) Smartequity EIS Pty Ltd AFSL number 477891,

that holds or will hold eligible products on trust for the following persons in connection with the EST:

- (d) eligible participants generally on an unallocated basis; or
- (e) one or more specified participants on an allocated basis;

underlying eligible product means an eligible product specified in paragraph (a) in column 2 of Table A;

- (b) an offer of eligible products to an eligible participant under the 2014/15 ESOP on terms that the eligible participant may renounce the offer in favour of a person covered by one of the following paragraphs is to be treated as an offer of eligible products to the eligible participant:
 - (i) an immediate family member of the eligible participant;
 - (ii) a company whose members comprise no persons other than the eligible participant or immediate family members of the participant;
 - (iii) a corporate trustee of a self-managed superannuation fund (within the meaning of the *Superannuation Industry (Supervision) Act 1993*) where the eligible participant is a director of the trustee;
- (c) for the avoidance of doubt, a document or other writing to be given in connection with this instrument may be given by electronic means (including, in the case of a document or other writing to be given by Lynas, by way of making it available on a website and notifying the intended recipient that it is available on the website).

Exemption

4. CM Holdings does not have to comply with subsection 715(2) of the Act.

Where this instrument applies

5. This instrument applies in relation to an offer of securities by CM Holdings under the OIS to employees of CMPL or a related body corporate of CMPL.

Conditions

6. CM Holdings can only rely on the exemption in paragraph 4 of this instrument if it complies with the following conditions:
 - (a) the OIS includes:
 - (i) an audited financial report of CMPL for the 12 month period ended 30 June 2015;
 - (ii) an unaudited pro-forma consolidated annual financial report of CM Holdings as at 30 June 2015, as if CM Holdings had indirectly acquired all the securities in CMPL on 1 July 2014;
 - (iii) a statement to the effect that CM Holdings has no operations of its own; and



 - (ii) the date of the latest supplementary disclosure document for the offer lodged with ASIC which:
 - (A) discloses that the securities are not admitted to quotation; and




