THE COURT NOTES THAT:

- A. The parties (and Australian Property Custodian Holdings Limited ACN 095 474 436 (receivers and managers appointed)(in liquidation)(controllers appointed)(APCHL)) have exchanged submissions in relation to the orders to be made on determination of the appeals as follows:

- By 4.00 pm on 5 September 2016, the Respondent (and APCHL, if any application is made in accordance with order 1(a) above) is to file and serve any further submissions as to the form of final orders to be made in disposition of the appeals.



- 3. By 4.00pm on 19 September 2016, the appellants are to file and serve any further submissions in reply to any submissions filed in accordance with orders 1 (b) and 2 above.
- 4. If any party wishes to be heard orally on the determination of any joinder application and the form of final orders, the party may request an oral hearing by 26 September 2016.
