  - (a) in section 708A:
    - (i) in paragraph (1)(a) omit "(12) or (12A),", substitute "(12), (12A) or (13),";
      - Note: ASIC Corporations (Non-Traditional Rights Issues) 2016/84 notionally inserted section 708A(12A) of the Act.
    - (ii) in paragraph (1A)(a) omit "(5)," and substitute "(5) or (13),"; and
    - (iii) after subsection (12A) insert:
      - "Sale offers of quoted securities: NZ foreign exempt listed body—case 5
      - (13) The sale offer of securities in a New Zealand foreign exempt listed body does not need disclosure to investors under this Part if:
        - the relevant securities are in a class of securities that were quoted securities at all times in the following period:
          - if this section applies because of subsection (1)— 3 months before the day on which the relevant securities were issued; or
          - (ii) if this section applies because of subsection (1A)—
             3 months before the day on which the relevant securities were sold by the controller; and

- (b) trading in that class of securities on a prescribed financial market on which they were quoted was not suspended for more than a total of 5 days during:
  - if this section applies because of subsection (1)—
     the shorter of the period during which the class of
     securities were quoted, and the period of 12 months
     before the day on which the relevant securities were
     issued; or
  - (ii) if this section applies because of subsection (1A) the shorter of the period during which the class of securities were quoted, and the period of 12 months before the day on which the relevant securities were sold by the controller; and
- (c) either:
  - (i) if this section applies because of subsection (1)—the body gives the relevant market operators for the body a notice that the body reasonably believes complies with clause 20 of Schedule 8 of the Financial Markets Conduct Regulations 2014 of New Zealand before the sale offer is made; or

- (b) listed on the financial market operated by ASX Limited as an exempt foreign listing.".

 The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 655A(1)(a) and 673(1)(a) of the Corporations Act 2001 (the Act).

#### Title

This instrument is ASIC Instrument 16-0850.

#### Commencement

This instrument commences on 5 September 2016.

#### Exemptions

- Under paragraph 655A(1)(a) of the Act ASIC exempts Paynes Find Gold Limited ACN 141 450 624 (Paynes Find) and European Lithium Limited Company Number 1629378 a company incorporated in the British Virgins Island (ELL), from section 606 of the Act.
- 5. Under paragraph 673(1)(a) of the Act ASIC exempts ELL from section 671B of the Act.

#### Where this instrument applies

- 6. Subject to paragraphs 7 and 8 of this instrument, this exemption applies where:
  - the members of Paynes Find approve at a general meeting (Meeting) the issue of up to 250,000,000 ordinary shares in Paynes Find (Consideration Shares) to the shareholders of ELL (or their nominees) (ELL Shareholders);
  - (b) after the Meeting:
    - the directors of ELL pass a resolution to declare a dividend to be satisfied in the form of a dividend in specie of a contractual right to receive a pro rata proportion of the Consideration Shares (Resolution); and
    - (ii) no later than 72 hours after ELL passes the Resolution, Paynes Find issues the Consideration Shares, at the direction of ELL, to:
      - A. those ELL Shareholders who have signed a restriction agreement preventing that ELL Shareholder from selling their Consideration Shares for the period of time mandated by the Australian Securities

Exchange (ASX) in accordance with Chapter 9 of the ASX Listing Rules (Restriction Agreement); and

- B. ELL, in relation to those Consideration Shares that would otherwise be issued to ELL Shareholders who have not signed a Restriction Agreement, to be held on trust by ELL for the benefit of the relevant ELL Shareholders until the expiration of the escrow period mandated by the ASX for the Consideration Shares in accordance with Chapter 9 of the ASX Listing Rules (Trust Arrangement); and
- (iii) the number of Consideration Shares to be held by ELL under the Trust Arrangement does not result in ELL having a voting power in Paynes Find of greater than 5%.
- This exemption does not apply unless Paynes Find has provided ASIC with a deed for the benefit of, and enforceable by, ASIC, which provides for terms substantially the same as those provided to ASIC on 23 August 2016.
- This exemption does not apply unless ELL has provided ASIC with a deed for the benefit
  of, and enforceable by, ASIC, which provides for terms substantially the same as those
  provided to ASIC on 23 August 2016.

#### Cessation

This exemption ceases to have effect if the actions contemplated in paragraph 6 of the instrument are not completed within 3 months of the date of this instrument.

(each, CNPR Entity) from Part 2M.3 of the Act.

#### Where this instrument applies

 This instrument applies where each CNPR Entity maintains adequate arrangements to answer, within a reasonable period of time and without charge, any reasonable questions asked by their members about the effect of this exemption on the CNPR Entity.

#### Where this instrument ceases to apply

- This instrument ceases to apply in respect of each CNPR Entity on the date that is the earlier of:
  - (a) 30 September 2018; or
  - (b) the date on which the relevant CNPR Entity enters into external administration; or
  - (c) in the case of CPT Manager Limited ACN 054 494 307 in its capacity as the responsible entity of CNPR Trust, the date on which CNPR Trust is deregistered or wound up.

#### Disclosure relief

Offers made under an employee incentive scheme

4. The Company or an associated body corporate does not have to comply with Part 7.9 of the Act in relation to the offer of an eligible product to an eligible participant under the Employee Incentive Scheme.

Personal advice given by advisers

5. An eligible product offered under the Employee Incentive Scheme is exempt from section 1012A of the Act to the extent that section requires a person to give a Product Disclosure Statement for an eligible product to an eligible participant, provided the person has no reason to believe the relevant Employee Incentive Scheme is not covered by this instrument.

#### Conditions

#### Disclosure

The Company and its associated bodies corporate must ensure that an offer of an
eligible product to an eligible participant under the Employee Incentive Scheme that
is covered by this instrument is made in, or is accompanied by, an offer document.

#### Nil consideration

 The Company or an associated body corporate must ensure that an offer an eligible product covered by this instrument is made for no monetary consideration.

#### Completion of transaction

8. The offer of an eligible product under the Employee Incentive Scheme to an eligible participant can only rely on this instrument upon the filing by the Company and Nokia with the French market authorities of the prospectus related to the buy-out offer followed by the squeeze-out where all of the fully paid shares in the Company are acquired by Nokia and the Company is removed from the official list of Euronext Paris.

#### ASIC power to request documents

 The Company or an associated body corporate must, if requested by ASIC and in accordance with the request, make available to ASIC the offer document and all other accompanying information or documents given to eligible participants in connection with the offer.

eligible product means a conditional right granted under the terms of the Option Unit Plan;

Employee Incentive Scheme means the arrangement under which eligible products are offered to eligible participants under the Option Unit Plan;

financial product advice has the meaning given by section 766B of the Act;

Nokia means Nokia Corporation a company organised and existing under the laws of Finland, registered in the Finnish Trade Register under number

0112038-9, with registered office at Karaportti 3, FI-02610 Espoo, Finland and listed on an eligible financial market;

offer, in relation to an eligible product, has a meaning affected by section 1010C of the Act and includes:

- (a) an offer to issue the eligible product; or
- (b) an issue or grant of the eligible product;

offer document, in relation to an offer of eligible products the Employee Incentive Scheme, means a document which includes, or is accompanied by, the following information, statements and explanations worded and presented in a clear, concise and effective manner:

- (a) prominent statements to the effect that:
  - any advice given by the Company in relation to eligible products offered under the Employee Incentive Scheme does not take into account an eligible participant's objectives, financial situation and needs; and
  - eligible participants should consider obtaining their own financial product advice from a person who is licensed by ASIC to give such advice;
- (b) either:
  - a copy of the terms of the Employee Incentive Scheme; or
  - (ii) a summary of the terms of the Employee Incentive Scheme together with a statement that, on request and at no charge and within a reasonable time, the Company will provide an eligible participant with a copy of the terms of the Employee Incentive Scheme;
- general information about the risks of acquiring and holding an eligible product being offered under the Employee Incentive Scheme;
- (d) the exercise price of the eligible product in Australian dollars or, where the exercise price is to be worked out in the future under a formula, an explanation of how an eligible participant could calculate the exercise price of the eligible product in Australian dollars were that formula applied at the date of the offer;
- an explanation of how an eligible participant could, from time to time, ascertain the exercise price of the eligible product in Australian dollars;

Option Unit Plan means the Alcatel Lucent S.A Option Unit Plan, which is in substantially the same form as provided to ASIC on 15 August 2016;

related body corporate has the meaning given in section 50 of the Act;

Stock Options means the options held by eligible participants offered under the Alcatel Lucent S.A Corporate Stock Subscription Options Plan, which is in substantially the same form as provided to ASIC on 15 August 2016;

- (b) an offer of eligible products to an eligible participant under the Employee Incentive Scheme on terms that the eligible participant may renounce the offer in favour of a person covered by one of the following sub-subparagraphs is to be treated as an offer of eligible products to the eligible participant:
  - (i) an immediate family member of the eligible participant;
  - a company whose members comprise no persons other than the eligible participant or immediate family members of the participant;
  - (iii) a corporate trustee of a self-managed superannuation fund (within the meaning of the Superannuation Industry (Supervision) Act 1993) where the eligible participant is a director of the trustee;
- (c) for the avoidance of doubt, an offer under the Employee Incentive Scheme is covered by an instrument to the extent that offers are made in reliance on the instrument;
- (d) for the avoidance of doubt, a document or other writing to be given in connection with this instrument may be given by electronic means (including, in the case of a document or other writing to be given by a person relying on this instrument, by way of making it available on a website and notifying the intended recipient that it is available on the website).
