Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 741(1)(a) – Exemption

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraph 741(1)(a) of the Corporations Act 2001 (the Act).

Title

This instrument is ASIC Instrument 16-1181.

Commencement

This instrument commences on 2 December 2016.

Exemption

4. The Company does not have to comply with subsection 734(2) of the Act.

Where the exemption applies

- Subject to paragraph 6, this instrument applies to the following information communicated by the Company to employees of the Company Group:
 - (a) changes to the internal administration of the Company Group;
 - (b) details of any employee share plan, employee option plan or similar employee incentive plan under which offers to employees of the Company Group will be made at or about the same time as the IPO;
 - (c) the timetable of the IPO, and any proposed updates to the timetable;
 - (d) information about impending announcements in relation to the IPO; and
 - details of the potential participation of employees in the issue of Shares as part of the IPO;

provided the information does not communicate any advantages, benefits or merits of the IPO.

Conditions

- This exemption shall remain effective, unless otherwise revoked, until the earlier
 of:
 - (a) the date on which the Company lodges the IPO Prospectus with ASIC; and
 - (b) 28 February 2017.

Interpretation

In this instrument:

Company means Click Energy Group Holdings Pty Ltd ACN 160 484 837 (to be converted into a public company).

Company Group means the Company and its wholly owned subsidiaries.

IPO means the initial public offering of Shares.

IPO Prospectus means the prospectus proposed to be lodged with ASIC by the Company and Click Energy SaleCo Limited (an entity to be incorporated) in relation to the IPO.

Shares means fully paid ordinary shares in the Company.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) – Exemptions

Enabling legislation

 The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 601QA(1)(a), 911A(2)(1) and 1020F(1)(a) of the Corporations Act 2001 (the Act).

Title

This instrument is ASIC Instrument 17-0003.

Commencement

This instrument commences on gazettal.

Exemptions

- Heron Resources Limited ACN 068 263 098 (the Company) does not have to comply with:
 - (a) section 601ED of the Act in relation to the Sale Facility;
 - (b) Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in the Sale Facility; and
 - (c) the requirements to hold an Australian financial services licence for the provision of the following financial services:
 - (i) dealing in an interest in the Sale Facility; and
 - the provision of general advice in relation to an interest in the Sale Facility.
- To avoid doubt, to the extent the Company invites a person to make an offer to sell an Ardea Share through the Sale Facility, the Company does not have to comply with Division 5A of Part 7.9 of the Act.

Where exemptions apply

- The exemptions in paragraphs 4 and 5 apply in relation to the Sale Facility only where that facility satisfies all of the following:
 - the financial products that may be sold through the Sale Facility are Ardea Shares that will be admitted to quotation on the licensed market operated by ASX;
 - (b) under the terms of the Sale Facility:

- the Ardea Shares of participating holders to be sold through the facility are pooled;
- (ii) a Broker sells the Ardea Shares either
 - (A) off-market at a price that is not less than \$0.20, being the price at which Ardea Shares are offered under the Public Offer; or
 - in the ordinary course of trading on the licensed market operated ASX:
- the Broker will use its reasonable endeavours to ensure that the price at which it sells Ardea Shares, either on-market or off-market, is consistent with an orderly market and ordinary commercial practice;
- (iv) the proceeds of the sale net of expenses (to the extent that they are not met by the Company) are distributed to participating holders; and
- each participating holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the Ardea Trading Commencement Date.

Exclusion from reliance

7. The Company is excluded from relying on subparagraph 4(c) of this instrument if it becomes aware of any matters that give it reason to believe that it has failed in a material aspect to comply with a condition of this instrument and does not give full particulars of the failure to ASIC in writing within 15 business days after becoming so aware.

Conditions for relief

- In order to rely on the exemptions in subparagraphs 4(a) or (b) or paragraph 5 of this
 instrument, the Company must give or send to each holder of Ardea Shares who has
 been invited or participate in the Sale Facility, a document which complies with
 paragraph 9, by:
 - giving the document to the holder personally; or
 - (b) sending the document:
 - by post to the address for the holder in the register of members or an alternative address (if any) nominated by the holder; or
 - (ii) to the fax number or electronic address (if any) nominated by the holder.
- The document must include the following information:
 - the period during which participating holders may elect to participate in the Sale Facility;

- the minimum and maximum number (if any) of Ardea Shares a participating holder can sell through the Sale Facility;
- any expenses relating to the sale of Ardea Shares that will be paid by the participating holders;
- (d) how the proceeds of sale of Ardea Shares sold through the Sale Facility will be allocated between participating holders;
- (e) a statement that the amount of money received by a participating holder for Ardea Shares that are sold through the Sale Facility may be more or less than the actual price that is received by the Broker;
- (f) any other significant characteristics or features of the Sale Facility or of the rights and obligations of persons who elect to participate in the Sale Facility including, without limitation:
 - the period during which the Sale Facility is open;
 - a description of the manner in which the sale of Ardea Shares by the Broker will be conducted; and
 - (iii) details of the minimum price at which Ardea Shares may be sold offmarket by the Broker under the Sale Facility;
- a statement that the market price of the Ardea Shares may be subject to change from time to time;
- (h) how to obtain up-to-date information on the market price of Ardea Shares;
- a statement that the price Ardea Shares sold through the Sale Facility may fluctuate over time; and
- any alternatives that the participating holder may have to participating in the Sale Facility.
- 10. In order to rely on the exemptions in subparagraphs 4(a) or (b) or paragraph 5 of this instrument, the Company must take reasonable steps to ensure the Sale Facility is not operated during any period where a Control Transaction has been publicly proposed and has not ended.

Ardea Share means fully paid ordinary shares in Ardea.

Ardea Trading Commencement Date means the date Ardea Shares commence trading on the ASX.

ASX means ASX Limited ACN 008 624 691.

Broker means a participant of a licensed market or approved foreign market with whom the Company or Ardea has entered arrangements for the operation of the Sale Facility.

Control Transaction means a transaction or proposed transaction that affects the control, or potential control, of Ardea.

Public Offer means the public offer of Ardea Shares made by Ardea Resources Limited under a prospectus dated 9 November 2016 ACN 614 289 342.

Sale Facility means a facility operated by the Company through which a participating holder can sell an Ardea Share in accordance with the terms set out in the document referred to in paragraph 9.
