Exemptions

5. Ashurst Perkins Coie Australia Services Pty Limited ACN 001 687 618 (*Trustee*), the trustee of the Travinto Services Trust (*Trust*) under a trust formed by deed dated 11 May 1979 as amended, does not have to comply with subsections 601ED(1) or 601ED(5) of the Act in relation to the Trust.
6. Subsection 911A(1) of the Act does not apply to an interest in the Trust in relation to a financial service that is the dealing in, or providing financial product advice in relation to, the interest by the Trustee or an Approved Holder authorised by the Trustee.

Commencement

3. This instrument commences on the day it is signed.

Exemption

4. ASIC exempts Redevco Value Add Investment Manager Limited, a limited company incorporated in the United Kingdom (company number 08599304) and registered with the Financial Conduct Authority of the United Kingdom (*UK*), under firm reference number 620307, (the *body*), from the requirement to hold an Australian financial services (*AFS*) licence upon the conditions referred to in Schedule A, in the case referred to in Schedule B.

Cessation

5. The exemption in paragraph 4 ceases to have effect on the earlier of:
