### NOTICE OF DECISION

At a hearing held pursuant to section 1294 of the Corporations Act 2001 ("the Act"), that commenced on 19 March 2021 and concluded on 5 May 2021, a Panel of the Companies Auditors Disciplinary Board ("Panel") decided that it was satisfied, on an application by the Australian Securities and Investments Commission that Graham William LITCHFIELD, a registered auditor, of Unit 9/40 Torquay Road, Pialba QLD, 4655, has failed to carry out or perform adequately and properly the duties of an auditor within the meaning of section 1292(1)(a)(i) of the Act. On 7 May 2021, the Panel decided to exercise its power under section 1292(1) of the Act by ordering that the registration of Mr Graham William Litchfield as an auditor be cancelled and provided the parties with a notice in writing setting out the Panel's decision and the reasons for it in accordance with section 1296(1)(a).

The Panel further ordered, pursuant to section 223 of the Australian Securities and Investments Commission Act 2001, that Mr Litchfield pay ASIC's costs on a party and party basis in the sum of \$821.58
