Signature	<p>Company: the form must be signed by a director or secretary.</p> <p>A body other than a company: the form must be signed by an agent of the corporation or entity, if the agent is a company, a director or secretary of the company who resides in Australia or an external territory.</p> <p>Registered scheme: the form must be signed by director or secretary of the responsible entity.</p>
Lodging period	<p>Lodgement required within 75 days after the end of the accounting period.</p>
Lodgement fee	<p>Nil if lodged within the prescribed lodging period.</p>
Late fees	<p>Late fees will apply if you lodge outside of the lodgement period.</p> <p>For information on fees refer to www.asic.gov.au/forms.</p> <p>A form is not considered lodged until it is received and accepted by ASIC as complying with s1274(8) of the <i>Corporations Act 2001</i>. A receipt will not be issued unless requested.</p>

The annexure must be signed by the same person(s) who signed the form.
