# Application for reservation of a name

This guide does not form part of the prescribed form. It is included by ASIC to assist you in completing and lodging the Form 410.

Signature	This form must be signed by the applicant or their agent. The agent is a person who has authority to sign the form on behalf of the applicant.		
Lodgement period	Reservation of name Extension of reservation	Nil Before the date the reservation expires.	
Lodging fee	A lodgement fee applies to this form.  For information on fees refer to www.asic.gov.au/forms.		
Documents to be lodged with this application	If the name includes a restricted word/phrase; then either an application for 'Ministerial consent' or a copy of the consent or approval, if consent has already been given, must be lodged with this form		
Reservation period and extension of reservation	A name is reserved for a period of <b>2 months</b> from the date of approval.  An application for an extension of name reservation for a period of up to <b>2 months</b> can be lodged before the reservation expiry date. Reasons for the extension must be provided in detail on the form or in an annexure. An application for extension will only be granted if valid reasons exist. If insufficient reasons are provided, the application will be rejected. Only exceptional circumstances would allow more than two extensions to be granted.

If it is proposed to register a name which is identical to a registered business name(s), we must be satisfied that the applicant is entitled to the use of the name under s147 or s601DC. The statement must be **dated and signed** by the applicant as being 'true and correct' as follows: 'I declare that the information given in this statement is true and correct'

If you have shown on the Form 410 that you are entitled to reserve a name which is identical to a business name, please note that you will need to restate the business name details on forms you finally lodge to use that name:

- Form 201 to register an Australian company
- Form 205 to notify a change of company name
- Form 409 to change the name of a foreign company or registered Australian body.

# How to provide additional information

### Annexures

If there is insufficient space in any section of the form, you may alternately submit annexures as part of this lodgement.

To make any annexure conform to the regulations, you must

- 1. use A4 size paper of white or light pastel colour with a margin of at least 10mm on all sides
- 2. show the company name and ACN or ARBN
- 3. number the pages consecutively
- 4. print or type in BLOCK letters in dark blue or black ink so that the document is clearly legible when photocopied
- 5. mark the annexure with an identifying letter or symbol eg a,b,c or 1,2,3 etc.
- 6. endorse the annexure with the words:
  - This annexure (mark) of (number) pages referred to in form (form number and title)
- 7. sign and date the annexure

The annexure must be signed by the same person(s) who signed the form.
