Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a), 1020F (1) (a) and 1020F(1)(b) – Exemptions

First Exemption: disclosure relief for offers not involving a contribution plan

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001 (Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the Issuer from Parts 6D.2, 6D.3 (except section 736) and Part 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer;
 - (b) offers to arrange for the issue of financial products under an eligible offer; or.
 - (c) issues a financial product under an eligible offer,
 - that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.
- 2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably be aware, that any of the conditions set out in the Schedule have not been met.

Second Exemption: licensing and hawking relief

- 3. Under paragraph 911A(2)(l) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in paragraph 1 (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that recipients of the offer should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 4. Under paragraph 911A(2)(1) of the Act, ASIC exempts:
 - (a) the Issuer; and
 - (b) any associate of the Issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by the exemption in paragraph 1 where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties;
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by the exemption in paragraph 1 where any acquisition by purchase or disposal of the product (by the Issuer or an associated body corporate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Schedule

The following conditions apply:

- the Issuer must ensure that the eligible offer is substantially on the terms set out in the draft terms of the Plan Rules provided to ASIC on 5 December 2011 by Gilbert & Tobin on behalf of the Issuer;
- 2. when making the offer the Issuer must:
 - (a) include that offer in an offer document;
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an eligible employee;

- 3. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument;
- 4. the Issuer must take reasonable steps to ensure that the number of shares to be issued on the vesting and, if exercise is required, the exercise of an Award when aggregated with:
 - (a) the number of shares in the same class which would be issued were:
 - (i) each outstanding offer with respect to shares, units of shares, and Awards to acquire unissued shares, under an employee share scheme (including the Plan) to be accepted, exercised (in the case of Options) or vested and, if exercise is required, exercised (in the case of Performance Rights and Share Appreciation Rights); and
 - (ii) the number of shares in the same class issued during the previous 5 years pursuant to the Plan or any other employee share scheme extended only to eligible employees of the Issuer,

but disregarding any offer made, or Award acquired or share issued by way of or as a result of:

- (b) an offer to a person situated at the time of receipt of the offer outside this jurisdiction;
- (c) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999;
- (d) an offer that did not need disclosure to investors because of section 708 of the Act;
- (e) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (f) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer; and

Interpretation

In this instrument:

- 1. except where otherwise stated, references to provisions are to provisions of the Act;
- 2. the shall not be regarded as extended to a person other than an eligible employee only because an eligible employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
- 3. associated body corporate of the Issuer means:
 - (a) a body corporate that is a related body corporate of the Issuer;
 - (b) a body corporate that has voting power in the Issuer of not less than 20%; or
 - (c) a body corporate in which the Issuer has voting power of not less than 20%;
- 4. ASX means the financial market operated by ASX Limited ACN 008 624 691;
- 5. Australian Dollar Equivalent in relation to price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
- 6. Award means an Option, Performance Right or Share Appreciation Right granted under the Plan;
- 7. contribution plan means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for shares offered for issue or sale under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:
 - (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document;
 - (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the Issuer in trust for the employee in an account of an Australian ADI which is established and kept by the Issuer only for the purpose of depositing contribution money and other money paid by employees for the shares on offer under the employee share scheme; and
 - (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest, must be repaid to that employee;

- current market price means in relation to a share, the price published by the operator
 of the principal financial market on which the share is quoted as the final price for
 previous day on which the share was traded on that financial market;
- 9. *eligible employee* means, in relation to the Issuer, a person who is at the time of an eligible offer under the Plan:
 - (a) a full or part-time employee of the Issuer or of an associated body corporate of the Issuer; or
 - (b) a director of the Issuer, or of an associated body corporate of the Issuer, who holds a salaried employment or office in the Issuer or in an associated body corporate;
- 10. eligible offer means an offer for the issue or sale of:
 - (a) fully-paid shares in the Issuer in the same class of shares that have been quoted on the financial market operated by the ASX or an approved foreign market throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period: or
 - (b) an Award, for the issue or transfer of shares referred to in paragraph (a) where the Award is offered for no more than nominal consideration; or
 - (c) units of fully-paid shares referred to in paragraph (a),

made under the Plan and extended only to eligible employees;

- 11. financial product advice has the meaning given by section 766B of the Act;
- 12. general advice has the meaning given by section 766B of the Act;
- 13. Issuer means Aurora Oil & Gas Limited ACN 008 787 988;
- 14. offer has a meaning affected by sections 700, 702 and 1010C of the Act;
- 15. offer document means a document setting out an offer under the Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the Rules; and
 - (b) if a summary (rather than a copy) of the Plan Rules is given includes an undertaking that during the period (the offer period) during which an eligible employee may acquire the Awards offered or exercise Awards offered under the Plan, or exercise or have vest Awards acquired under the Plan, the Issuer will, within a reasonable period of the eligible employee so requesting, provide the eligible employee without charge with a copy of the Plan Rules; and
 - (c) specifies in respect of the shares or shares subject to the Awards or unit of shares:

- (i) the acquisition price (if any) in Australian dollars;
- (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
- (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which the Issuer will, during the offer period and within a reasonable period of the eligible employee requesting, make available to the eligible employee:
 - (i) the current market price (or where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares in the same class as those shares that will be acquired by the eligible employee when the Awards offered to the eligible employee vests or is exercised; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph is updated to that date; and
- (e) discloses the conditions, obligations and risks associated with a loan or financial assistance offered by the Issuer or any associated body corporate of the Issuer for the purpose of acquiring any financial product under the Plan;
- 16. *Option* means an option for the issue or transfer of a share, where each Option is offered for no more than nominal consideration;
- 17. Performance Right means a right to subscribe for and/or acquire one Share or receive a cash payment in lieu of the Shares on the terms set out in the Plan, where no consideration is payable for the exercise of the right to subscribe for and/or acquire a Share;
- 18. *Plan* means an employee incentive scheme of the Issuer only to eligible employees that is known as at the date of this instrument as the Aurora Oil & Gas Limited Plan where:
 - (a) the scheme is extended only to eligible employees; and
 - (b) the terms of the scheme are substantially on the terms set out in the Plan Rules;
- 19. Plan Rules means the written terms of the Plan as at the date of this instrument that are substantially on the terms set out in the draft terms of the Aurora Oil & Gas Limited Plan Rules provided to ASIC on 5 December 2011 by Gilbert + Tobin on behalf of the Issuer;

- 20. Share means a fully-paid ordinary share in the Issuer in the same class as shares which have been quoted on the financial market operated by the ASX throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period;
- 21. Share Appreciation Right means a right to receive a future payment to be paid in cash and/or Shares that is calculated by reference to the performance of the market price of the Shares on the terms set out in the Plan;
- 22. Unit in relation to a share means a legal or equitable right or interest in the share.

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraph 655A(1)(a) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 12-1466.

Commencement

3. This instrument commences on 17 January 2012.

Exemption

4. Leighton Holdings Limited ACN 004 482 982 (*Leighton*) does not have to comply with subsections 606(1) and 606(2) of the Act.

Where this instrument applies

- 5. This instrument applies where:
 - (a) Leighton acquires a relevant interest in voting shares of Macmahon Holdings Limited ACN 007 634 406 (*Macmahon*) on or after the date of this instrument and no later than 22 March 2012 (*Acquisition*); and
 - (b) throughout the 6 months before the Acquisition, Leighton would have had a voting power in Macmahon of at least 19% if Macmahon had not issued securities as announced by Macmahon to ASX Limited ACN 008 624 691 pursuant to Appendix 3B notice dated 23 August 2011.
 - (c) as a result of the Acquisition, Leighton will not have voting power in Macmahon more than 3 percentage points higher than they had 6 months before the Acquisition.

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 911A(2)(1), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 12-1471.

Commencement

3. This instrument commences on gazettal.

Exemption

- 4. ASIC exempts NRW Holdings Limited ACN 118 300 217 (the issuer) from Part 7.9 of the Act where the issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer.
- 5. ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in this instrument have not been met.
- 6. ASIC exempts the issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 4 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the issuer in connection with the offer is general advice only, and that eligible employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 7. ASIC exempts the issuer from section 992A of the Act in relation to eligible offers covered by paragraph 4 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Where this instrument applies

8. This instrument applies on the conditions set out below and for so long as the conditions are met.

Conditions

- 9. The issuer must ensure that the eligible offer is substantially on the terms set out in the Rules of the Plan.
- 10. The issuer must:
 - (a) include the offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 11. the issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
- 12. the issuer must take reasonable steps to ensure that the number of shares to be issued on vesting of a Performance Right when aggregated with:

but disregarding any offer made, or option acquired, or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that did not need disclosure to investors because of section 708; or
- (e) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (f) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See section 5C of the Act and section 25 of the Acts Interpretation Act 1901.

Interpretation

7. Performance Right means:

- (a) an unsecured right to acquire, by way of issue or transfer, a share; or
- (b) where the right referred to in paragraph (a) has vested or has been exercised in accordance with the Rules of the Plan, but the share to which the right relates has not been issued or transferred to the eligible employee, an equitable interest in a share where each Performance Right is offered for nil consideration.
- 8. *Plan* means the terms and conditions of the employee share scheme, or like scheme, that is known at the date of this instrument as the NRW Holdings Limited Performance Rights Plan which is:
 - (a) extended only to eligible employees; and
 - (b) governed by the Rules of the Plan.
- Rules of the Plan means the written rules of the Plan as at the date of this instrument that
 are substantially the same as the rules set out in the pro forma offer document provided to
 ASIC as an attachment to the issuer's application dated 23 December 2011.
