**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraphs 655A(1)(b) and 673(1)(b) – Declaration**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under sections 655A(1) and 673(1) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument [11/1353].

**Commencement**

3. This instrument commences on 16 December 2011.

**Declaration**

4. Chapters 6 and 6C of the Act apply to Ebony Coal Limited ACN 149 240 657 (*Company*) as if:
  - (a) section 609 of the Act were modified or varied by inserting the following subsection after subsection 609(13), as notionally inserted by ASIC Class Order [CO 03/634] (*CO 03/634*):

"(14) A company does not have a relevant interest in its own securities merely because under an escrow agreement entered into by the company, the company applies restrictions on the disposal of the securities by the holder."; and
  - (b) Part 6C.1 of the Act were further modified or varied by inserting the following section after section 671BA, as notionally inserted by CO 03/634

**"671BB Escrow Agreements**

For the purposes of section 671B and the definition of *substantial holding* in section 9, a person has a relevant interest in securities if the person would have a relevant interest in the securities but for subsection 609(14)."

**Where this instrument applies**

5. This instrument applies to an acquisition of a relevant interest in securities of the Company (*Escrowed Securities*) arising as a result of the entry into one or more escrow agreements or deeds (each an *Escrow Agreement*) between the Company and any one or more of the persons named in Schedule A (*Security Holders*) in connection with the proposed admission of the Company's securities to the official list of the Australian Securities Exchange where each Escrow Agreement:

- (a) restricts disposal of, but not the exercise of voting rights attaching to, the Escrowed Securities;
- (b) terminates on the date specified for that Security Holder in Schedule A;
- (c) during any period where the disposal of the Escrowed Securities is not otherwise restricted by the listing rules of the Australian Securities Exchange, allows Security Holders to accept into a takeover bid where offers are made for all ordinary securities of the Company, provided that holders of at least half of the bid class securities that are not the subject of an Escrow Agreement with the Company restricting disposal of the securities (or other form of valid restriction) have accepted into the bid, and (in the case of an off-market takeover bid) requires that the restrictions under the Escrow Agreement continue to apply until the bid becomes unconditional;
- (d) during any period where the disposal of the Escrowed Securities is not otherwise restricted by the listing rules of the Australian Securities Exchange, allows the Escrowed Securities to be transferred or cancelled as part of a merger by way of scheme of arrangement under Part 5.1 of the Act;
- (e) is in substantially the same form provided to ASIC on 9 December 2011; and
- (f) does not, when taken together with each of the other Escrow Agreements, result in the Company having, but for subsection 609(14):
  - (i) a relevant interest in more than 27.8% of the issued voting shares in the Company; or
  - (ii) a relevant interest resulting from the Escrow Agreements in more than 22.1% of the issued voting shares in the Company;

from the date of the relevant Escrow Agreement until the termination of that Escrow Agreement.





**Enabling Legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 12-0222.

**Commencement**

3. This instrument commences on gazettal.

**Exemptions**

4.
  - (a) Abacus Group Holdings Limited ACN 080 604 619 (*AGHL*);
  - (b) Abacus Group Projects Limited ACN 104 066 104 (*AGPL*);
  - (c) Abacus Funds Management Limited ACN 007 415 590 (*AFML*) in its capacity as the responsible entity of Abacus Trust ARSN 096 572 128 (*AT*) and Abacus Income Trust ARSN 104 934 287 (*AIT*);
  - (d) Abacus Storage Operations Limited ACN 112 457 075 (*ASOL*);
  - (e) Abacus Storage Funds Management Limited ACN 109 324 834 (*ASFML*) in its capacity as the responsible entity of Abacus Storage Property Trust ARSN 111 629 559 (*ASPT*); and
  - (f) LINWAR Securities Pty Limited ACN 103 183 606 (*Linwar*); and
  - (g) ANZ Securities (Nominee) Pty Ltd ACN 008 550 329 (*ANZ*)do not have to comply with:
  - (h) section 601ED of the Act in relation to the Sale Facility;
  - (i) Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in the Sale Facility; and
  - (j) the requirement to hold an Australian financial services license for the provision of the following financial services:

- (i) dealing in an interest in a Sale Facility; and
  - (ii) the provision of general advice in relation to an interest in the Sale Facility.
5. To avoid doubt, to the extent that AGHL, AGPL, AFML, ASOL, ASFML, Linwar or ANZ invite a holder of ABP Stapled Securities or ASF Stapled Securities to make an offer to sell ABP Stapled Securities or ASF Stapled Securities through the Sale Facility, AGHL, AGPL, AFML, ASOL, ASFML, Linwar and ANZ do not have to comply with Division 5A of Part 7.9 of the Act.

**Where this instrument applies**

6. The exemptions in paragraphs 4 and 5 apply in relation to the Sale Facility where the facility satisfies all of the following:
- (a) the New Stapled Securities that may be sold through the Sale Facility are admitted to quotation on ASX;
  - (b) under the terms of the Sale Facility:
    - (i) the New Stapled Securities (the *relevant financial products*) of participating holders to be sold through the Sale Facility are pooled; and
    - (ii) Linwar or ANZ sell the relevant financial products in the ordinary course of trading on ASX or through a bookbuild; and
    - (iii) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by AGHL, AGPL, AFML, ASOL, ASFML, Linwar or ANZ) are distributed to participating holders; and
    - (iv) each participating holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the final date for receiving elections to participate in the Sale Facility.

**Conditions**

7. In order to rely on the exemptions in subparagraphs 4(h) or (i) or paragraph 5, AGHL, AGPL, AFML, ASOL and ASFML must:
- (a) give or send to each holder of ABP Stapled Securities and each holder of ASF Stapled Securities a document which complies with paragraph 8, by:
    - (i) giving the document to the holder personally; or
    - (ii) sending the document:

- (A) by post to the address for the holder in the register of members or an alternative address (if any) nominated by the holder; or
- (B) to the fax number or electronic address (if any) nominated by the holder.

## 8. The document:

- (a) must contain the following statements and information:
    - (i) a statement that the Sale Facility is open until the expiry date set out in the document, which cannot be more than 12 months after the date of the document; and
    - (ii) information about the minimum and maximum number (if any) of ABP Stapled Securities or ASF Stapled Securities a participating holder can sell through the Sale Facility; and
    - (iii) a statement that the market price of New Stapled Securities is subject to change from time to time; and
    - (iv) information about how to obtain up-to-date information on the market price of New Stapled Securities; and
    - (v) information about any expenses relating to the sale of New Stapled Securities that will be paid by the participating holders; and
    - (vi) information about how the proceeds of sale for New Stapled Securities sold through the Sale Facility will be allocated between participating holders; and
    - (vii) a statement that the amount of money received by a participating holder for New Stapled Securities that are sold through the Sale Facility may be more or less than the actual price received by Linwar or ANZ for those New Stapled Securities; and

10. AGHL, AGPL, AFML, ASOL, ASFML, Linwar and ANZ are excluded from relying on paragraph 4(j) of this instrument if any of them become aware of matters that give any of them reason to believe that any of them have failed in a material respect to comply with a condition of this instrument and do not give full particulars of the failure to ASIC within 15 business days of becoming so aware.

**Interpretation**

11. In this instrument:

**Abacus Property Group** means AGHL, AGPL, AFML in its capacity as the responsible entity of AT and AIT, ASOL and ASFML in its capacity as the responsible entity of ASPT.

**ASX** means the financial market operated by ASX Limited ACN 008 624 691.

**ABP Stapled Securities** means a share in AGHL, an interest in AT, a share in AGPL and an interest in AIT which, under the terms on which each is to be traded, must be transferred together.

**ASF Stapled Securities** means a share in ASOL and an interest in ASPT which, under the terms on which each is to be traded, must be transferred together.

**bookbuild** means a process, run by Linwar or ANZ, in which certain professional or sophisticated investors indicate the price or range of prices and the quantity of New Stapled Securities they would be willing to acquire.

**control transaction** means a transaction or a proposed transaction that affects the control, or potential control, of Abacus Property Group, excluding the Stapling Transaction.

**Explanatory Memorandum** means the notices of meeting, the prospectus and the Product Disclosure Statement dated 13 January 2012 in respect of the Stapling Transaction.

**facility** has a meaning affected by section 762C of the Act.

**holder** has the meaning given by section 761A of the Act.

***New Stapled Securities*** means a share in AGHL, an interest in AT, a share in AGPL, an interest in AIT, a share in Restructured ASOL and an interest in Restructured ASPT which, under the terms on which each is to be traded, must be transferred together.

***participating holder*** means a person who:

- (a) holds ABP Stapled Securities; or
- (b) holds ASF Stapled Securities,

and has elected to, or is required to participate in the Sale Facility.

***register of members*** means the register of members required to be set up and maintained under section 169 of the Act.

***Restructured ASOL*** means ASOL after the split and subsequent consolidation of each existing share in ASOL.

***Restructured ASPT*** means ASPT after the split and subsequent consolidation of each existing interest in ASPT.

***Sale Facility*** means a facility described in the Explanatory Memorandum through which a participating holder transfers its ABP Stapled Securities or ASF Stapled Securities to Linwar or ANZ and, following implementation of the Stapling Transaction, Linwar or ANZ sells the New Stapled Securities the participating holder would otherwise have been entitled to.

***Stapling Transaction*** means the proposed arrangement by which shares in each of AGHL, AGPL, ASOL are to be stapled to interests in AT, AIT and ASPT.

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 12-0235.

**Commencement**

3. This instrument commences on 28 February 2012.

**Declaration**

4. Chapter 5C of the Act applies to Abacus Funds Management Limited ACN 007 415 590 in its capacity as the responsible entity of Abacus Trust ARSN 096 572 128 (*AT*) and Abacus Income Trust ARSN 104 934 287 (*AIT*) and Abacus Storage Funds Management Limited ACN 109 324 834 in its capacity as the responsible entity of Abacus Storage Property Trust ARSN 111 629 559 (*ASPT*) as if the following provisions of that Chapter were modified or varied as follows:
  - (a) omit paragraph 601FC(1)(c) and substitute:
    - “(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and shares in other companies, where interests in each of the schemes and shares in each of the companies are components of a stapled security) and, if there is a conflict between the members’ interests and its own interests, give priority to the members’ interests; and”;
  - (b) omit paragraph 601FC(1)(e) and substitute:
    - “(e) not make use of information acquired through being the responsible entity in order to:
      - (i) gain an improper advantage for itself or another person; or
      - (ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and

- (c) omit paragraph 601FD(1)(c), 601FD(1)(d) and 601FD(1)(e) and substitute:

“(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and shares in other companies, where interests in each of the schemes and shares in each of the companies are components of a stapled security) and, if there is a conflict between the members’ interests and the interests of the responsible entity, give priority to the members’ interests; and

(d) not make use of information acquired through being an officer of the responsible entity in order to:

(i) gain an improper advantage for the officer or another person; or

(ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and shares in other companies, where interests in each of the schemes and shares in each of the companies are components of a stapled security); and

(e) not make improper use of their position as an officer to gain, directly or indirectly, an advantage for themselves or for any other person or to cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and shares in other companies, where interests in each of the schemes and shares in each of the companies are components of a stapled security); and”; and

- (d) omit paragraphs 601FE(1)(a) and 601FE(1)(b) and substitute:

“(a) make use of information acquired through being an employee of the responsible entity in order to:

(i) gain an improper advantage for the employee or another person; or

(ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and shares in other

- companies, where interests in each of the schemes and shares in each of the companies are components of a stapled security);  
or
- (b) make improper use of their position as an employee to gain, directly or indirectly, an advantage for themselves or for any other person or to cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes and shares in other companies, where interests in each of the schemes and shares in each of the companies are components of a stapled security).”; and
- (e) in subsection 601GAA(1) as notionally inserted into Chapter 5C by ASIC Class Order [CO 05/26], after "(8)" insert "and (9A)"; and
- (f) after subsection 601GAA(9) as notionally inserted into Chapter 5C by ASIC Class Order [CO 05/26], insert:
- “(9A) the responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
- (a) the constitution makes provision for the issue price of the stapled securities;
- (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
- (c) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the scheme constitution; and
- (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.”; and
- (g) insert after subsection 208(2) of the Act as notionally inserted by section 601LC:
- “(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
- (a) the benefit either:
- (i) is given out of the scheme property of a registered scheme; or

- (ii) could endanger the scheme property; and
- (b) all of the interests in the scheme, together with all of the interests in other schemes and all of the shares in other companies (each a *stapled entity*), are components of stapled securities; and



## LUDOWICI LIMITED

## CIRCUMSTANCES

1. Ludowici Limited (Ludowici) is an ASX-listed company (ASX code: LDW).
2. On or about 23 January 2012, FLSmidth & Co. A/S (FLS) entered into a "Process Agreement" with Ludowici, such that it made an indicative non-binding proposal to acquire by scheme of arrangement all the shares in Ludowici at \$7.20 per share, less any dividends paid by Ludowici before completion. (acquisition proposal)
3. On 23 January 2012 Ludowici announced the acquisition proposal to ASX.
4. On or about 23 January 2012, following an interview with the chief executive officer of FLS, an article was published on *Reuters*, titled "*FLSmidth says A\$7.20 per share Ludowici bid final*". The article stated, among other things, that FLS's "*chief executive said the Danish engineering group's A\$7.20 per share bid to acquire Australia-listed company Ludowici ... was final and would not be raised.*" In the body of the article it said "*He answered with a 'no' when asked if he would consider raising the bid*". (Reuters article)
5. FLS became aware of the Reuters article on or about 23 January 2012.
6. On 31 January 2012, *The Australian* newspaper published an article referring to the Reuters article.
7. On or about 31 January 2012, FLS issued a press release stating "*Certain Australian media today comment on [FLS's] ability to raise the indicated offer price of AUD 7.20 per share, if it should wish to do so, under Australian takeover regulation. ... If [FLS] decides to make a binding offer, it does not currently intend to make or increase any such offer at a price above AUD 7.20 per share, but reserves the right to do so.*" (correction)
8. On or about 31 January 2012, *Reuters* published a further article titled "*UPDATE 1- FLSmidth won't rule out higher Ludowici bid.*"
9. By FLS not issuing the correction until on or about 31 January 2012, the acquisition of control over Ludowici shares did not take place in an efficient, competitive and informed market between the publication of the Reuters article and the issue of the correction.

10. It appears to the Panel that the circumstances are unacceptable having regard to the purposes of Chapter 6 set out in section 602 of the *Corporations Act 2001* (Cth) (Act).
11. The Panel considers that it is not against the public interest to make a declaration of unacceptable circumstances. It has had regard to the matters in section 657A(3) of the Act.

**DECLARATION**

The Panel declares that the circumstances constitute unacceptable circumstances in relation to the affairs of Ludowici.

The Panel made a declaration of unacceptable circumstances on 28 February 2012.

**THE PANEL ORDERS**

1. Within 15 business days from the date of these orders, FLS must appoint an Arbitrator, who must be a retired justice of the Federal Court or a State Supreme Court, to assess claims made under these orders.
2. An Affected Shareholder is entitled to compensation if the Affected Shareholder can establish to the satisfaction of the Arbitrator that:
  - (a) the Affected Shareholder disposed of a net number of Ludowici shares during the Relevant Period
  - (b) the Affected Shareholder (or a market participant who advised an Affected Shareholder or operated a discretionary account) was aware of the Reuters article at the time the Affected Shareholder sold Ludowici shares and, at least in part, relied on it and
  - (c) some compensation is payable.
3. The Arbitrator must provide a copy to FLS of any material he or she receives from an Affected Shareholder under order 2 and allow FLS a fair opportunity to make written submissions to the Arbitrator.
4. The amount of compensation is to be determined by the Arbitrator but must not exceed the difference between A\$7.20 per Ludowici share and A\$9.87 (being the VWAP of Ludowici shares on the day of FLS's 16 February announcement). The Arbitrator must take into account:
  - (a) the Ludowici share price at the time of the sale
  - (b) the price obtained by the Affected Shareholder
  - (c) the reasons given in a sworn statement by the Affected Shareholder for selling and
  - (d) the likelihood that the Affected Shareholder would have sold irrespective of the Reuters article.
5. The compensation is payable for the net number of Ludowici shares in which an Affected Shareholder disposed of a beneficial interest during the Relevant Period.
6. FLS must compensate any Affected Shareholder the amount determined by the Arbitrator by a date not later than 10 business days after the determination of the amount.

7. The Arbitrator must make a decision within one month of FLS receiving a claim form from an Affected Shareholder.
8. FLS must, within 20 business days of the date of these orders, cause to be published in one newspaper with a national circulation in Australia and one newspaper in each Australian State and Territory circulating in that State or Territory, a notice that is approved by the Panel and is not smaller than 15 cm by 20 cm and placed in the general or business news section of those newspapers which clearly states:
  - (a) the effect of, and a summary of the reasons for, the orders (including how the Arbitrator will determine claims and that claims must be supported by a sworn statement)
  - (b) a description of the group of persons likely to be Affected Shareholders
  - (c) how Affected Shareholders qualify to receive payment
  - (d) what an Affected Shareholder must do to obtain a claim form
  - (e) the applicable time periods in which Affected Shareholders must act to receive payment under the orders
  - (f) the phone number of an enquiry line that can be called in relation entitlements under these orders and
  - (g) that the Affected Shareholders have 10 business days to register to receive a claim form.
9. The information in the notices published under order 8 must also be published on ASX and prominently on FLS's website and Ludowici's website no later than the first publication under order 8.
10. The Panel must approve the claim form and the terms on which FLS appoints the Arbitrator.
11. The claim form must be dispatched to claiming Affected Shareholders within 15 business days of the date of first publication under order 8.
12. To be entitled to payment an Affected Shareholder must sign and return a claim form (together with a sworn statement) within 10 business days from the dispatch of the claim form.
13. FLS must pay the costs of giving effect to these orders.
