Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 1020F(1)(a) Exemption

Under paragraph 1020F(1)(a) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission exempts Vanguard Investments Australia Ltd ACN 072 881 086 (the Responsible Entity) in its capacity as responsible entity of the Vanguard Australian Shares Index Fund ARSN 090 939 718 (the Scheme) from section 1017B of the Act on the condition that the Responsible Entity complies with the Disclosing Entity Provisions as if the undertaking to which the interests in the Scheme relate is a disclosing entity that was subject to those provisions and for so long as this condition is met.

Interpretation

In this instrument

Disclosing Entity Provisions means any provision of the Act that applies to an unlisted disclosing entity.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 926A(2)(b), 992B(1)(b), and 1020F(1)(b) — Exemption

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the
Corporations Act 2001 (the Act).

Exemption

- 2. This exemption applies to an interest in a managed investment scheme (serviced strata scheme) which involves an owner (investor) of real property (strata unit), in the investor's discretion, making their strata unit available for use by a person (Operator) as part of a serviced apartment, hotel, motel or resort complex located at 959 Ann Street, Fortitude Valley, Queensland 4006 (being currently recorded in Queensland Land registry as Lot 1 on RP 92631, Lot 2 on RP 92631, Lot 3 on RP 9285 and Lot 12 on RP 9280) developed in accordance with approval of a local government organisation that has been given to ASIC and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme.
- An interest in the serviced strata scheme is exempt from the following provisions of the Act:
 - (a) Part 7.6 (other than Divisions 4 and 8); and
 - (b) Section 992AA; and
 - (c) Section 1017F.

Where exemption applies

- 4. The exemption in paragraph 3 only applies where all of the following requirements are satisfied:
 - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
 - (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be

bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:

- (i) by a person other than the operator or an associate of the operator; and
- (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is a financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
 - (i) payment of money to buy the strata unit; and
 - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
 - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
 - (B) where a FFE Fund has been established for the investor — no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
 - (iii) where a FFE Fund has been established for the investor one or more payments into the Fund where:
 - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to

the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and

- (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in paragraph 5;
- (h) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (i) where a FFE Fund has been established for an investor, the operator takes reasonable steps to ensure that:
 - (A) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and
 - (B) the balance of the Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first;
- (j) each person that is involved in making an offer of interests in the scheme for issue does not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers;
- (k) the operator complies with the provisions specified in paragraph 5 which are included in the agreement referred to in subparagraph (g).

Terms of agreement between investor and operator

- 5. The agreement specified in subparagraph 4(g) is to contain provisions to the following effect:
 - (a) Transfer of management rights
 - (i) If a majority of scheme members advises the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme; and
 - (ii) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice; and
 - (iii) A transfer referred to in subparagraph (i) or (ii) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in subparagraph (b)(ii) unless the body corporate has consented to the transfer; and
 - (b) Consent of body corporate to new care-taking arrangements
 - If an operator receives a notice under subparagraph (a)(i), the operator must advise all body corporate members of the name of the person to whom the transfer is to be made; and
 - (ii) unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in subparagraph (a)(ii) if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions; and
 - (iii) if a majority of body corporate members make a decision referred to in subparagraph (b)(ii), a majority of scheme members may then at any

time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with subparagraph (a)(ii); and

(iv) this subparagraph does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under subparagraph (a)(ii) or (b)(iii) before that notice is given to the operator; and

(c) Price payable on transfer

The price scheme members specify in a notice under subparagraph (a)(ii) must be one of the following:

- the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or
- (ii) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or
- (iii) the highest bona fide amount tendered (excluding any tender by the operator or its associates) for the management rights following reasonable efforts to market the property for at least 60 days; and

(d) Voting

- (i) In determining if there is a majority of scheme members or body corporate members, the operator and its associates and any person nominated as a replacement operator and associates of that person must not be counted; and
- (ii) for scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have one vote; and
- (iii) for body corporate members, a majority is based on their entitlement to vote at body corporate meetings; and

 (iv) a scheme member or a body corporate member makes a decision by signing a document that sets out the decision; and

(e) Costs

- (i) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in subparagraph (a)(i) for the purposes of determining a price to be specified in a notice under subparagraph (a)(ii); and
- (ii) If a member incurs any reasonable valuation, auction or marketing costs under subparagraph (i) that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator; and

(f) Assistance

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings; and

(g) Definitions

In this paragraph:

scheme members means investors in the scheme excluding the operator and its associates.

management rights means all real or personal property (including contractual rights) held by the operator or any of its associates that facilitates the operation of the scheme.

transfer in relation to management rights means to assign or transfer the management rights or to cause another person to become the holder of those rights or rights substantially the same as those rights.

6. In this instrument:

FFE Fund means a fund established for an investor consisting of money paid by the investor and any interest accrued on that money, to be used from time to time in accordance with the written agreement referred to in subparagraph 4(g) for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit made available by the investor for use as part of the scheme.

offer is to be interpreted in accordance with subsection 1010C(2) of the Act.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) — Exemptions

- Under paragraph 741(1)(a) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) exempts each of the persons specified in Schedule A, from Parts 6D.2 and 6D.3 (except section 736) of the Act where it makes an eligible offer, on the conditions set out in Schedule B and for so long as the conditions are met.
- 2. Under paragraph 911A(2)(l) of the Act, ASIC exempts each of the persons specified in Schedule A, on the conditions set out in Schedule B and for so long as the conditions are met, from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 3. Under paragraph 911A(2)(l) of the Act, ASIC exempts each of the persons specified in Schedule A, from the requirement to hold an Australia financial services licence for the provision of a financial service consisting of dealing in a financial product in connection with an eligible offer, on the conditions set out in Schedule B and for so long as the conditions are met.
- 4. Under paragraph 911A(2)(1) of the Act, ASIC exempts:
 - (a) each of the persons specified in Schedule A; and
 - (b) any associate of a person specified in Schedule A,

from the requirement to hold an Australian financial services licence for the provision of the following financial services, on the conditions set out in Schedule B and for so long as the conditions are met:

- (c) the provision of a custodial or depository service in connection with an eligible offer where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties;
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer where any acquisition by purchase or disposal of the product (by a person specified in Schedule B or an associate that person) occurs either:

- (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
- (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts each of the persons specified in Schedule A where that person makes an eligible offer, from sections 736, 992A and 992AA of the Act in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
- 6. Under paragraph 1020F(1)(a) of the Act, ASIC exempts each of the persons specified in Schedule A from Part 7.9 of the Act where the person:
 - (a) makes an eligible offer; or
 - offers to arrange for the issue of financial products under an eligible offer;
 or
 - (c) issues a financial product under an eligible offer,

on the conditions set out in Schedule B and for so long as the conditions are met.

Schedule A

- (a) FKP Limited ACN 010 729 950 (FKP); and
- (b) FKP Funds Management Limited ACN 089 800 082 (*FFML*), in its capacity as the responsible entity for the FKP Property Trust ARSN 099 648 754,

(collectively referred to as the FKP Property Group).

Schedule B

The following conditions apply:

- 1. The eligible offer must be substantially on the terms set out in the Rules of the Plan;
- The FKP Property Group must:
 - (a) include the offer in an offer document;
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and

- (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an eligible employee;
- The FKP Property Group must comply with any undertaking required to be made in the offer document by reason of this instrument;
- 4. The FKP Property Group must take reasonable steps to ensure that the number of FKP Stapled Securities the subject of the offer when aggregated with:
 - (a) the number of FKP Stapled Securities in the same class which would be issued were each outstanding offer with respect to FKP Stapled Securities under an employee share scheme to be accepted; and
 - (b) the number of FKP Stapled Securities in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer;

but disregarding any offer made, or FKP Stapled Security issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction;
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999;
- (e) an offer that did not need disclosure to investors because of section 708;
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued FKP Stapled Securities in that class of the issuer as at the time of the offer; and

Note: where a document must be provided in writing it may be provided by electronic means. See section 5C of the Act and section 25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

- except where otherwise stated, references to provisions are to provisions of the Act;
- the FKP Employee Security Plan shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
- 3. *approved foreign market* has the meaning given by Class Order [CO 03/184] *Employee Share Schemes*;
- 4. associated body corporate means:
 - (a) a body corporate that is a related body corporate of a person in Schedule A; or
 - (b) a body corporate that has voting power in a person in Schedule A of not less than 20%; or
 - (c) a body corporate in which a person in Schedule A has voting power of not less than 20%;
- current market price means in relation to an FKP Stapled Security, the price
 published by the operator of the principal financial market on which FKP
 Stapled Securities are quoted as the final price for the previous day on which
 FKP Stapled Securities were traded on that financial market;
- 6. custodial or depository service has the meaning given by section 766E;
- 7. *eligible employee* means, in relation to the FKP Property Group, a person who is at the time of an offer under the FKP Employee Security Plan:
 - (a) a full or part-time employee of the FKP Property Group or of an associated body corporate, excluding directors of FKP; or
 - (b) a full or part-time employee of a Gandel Village Company, excluding directors of a Gandel Village Company;
- 8. *eligible offer* means an offer for the issue or sale of fully-paid FKP Stapled Securities where:
 - (a) the FKP Stapled Securities are in the same class as FKP Stapled Securities that have been quoted on the financial market operated by ASX Limited ACN 008 624 691 or an approved foreign market throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; and

- (b) the offer is made under the FKP Employee Security Plan that extends only to eligible employees;
- FKP Employee Security Plan means the employee security plan for the FKP Property Group as governed by a document that is substantially in the terms set out in the Rules of the Plan;
- FKP Property Trust means the managed investment scheme known as the FKP Property Trust ARSN 099 648 754, with the current responsible entity for the scheme being FFML;
- 11. FKP Stapled Securities means an ordinary share in FKP and an interest in the FKP Property Trust, where under the terms on which an ordinary share in FKP and an interest in the FKP Property Trust are to be traded, they must only be transferred together;
- 12. financial product advice has the meaning given by section 766B;
- 13. Gandel Village Company means any of the following companies:
 - (a) Fernbank Management Pty Ltd ACN 003 055 169;
 - (b) The Manors of Mosman Pty Ltd ACN 001 012 193;
 - (c) Pittwater Palms Management Pty Limited ACN 002 720 407; or
 - (d) Regency Services Pty Ltd ACN 002 180 065;
- 14. general advice has the meaning given by section 766B;
- 15. offer has a meaning affected by sections 700, 702 and 1010C;
- 16. offer document means a document setting out an offer under the Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the Rules of the Plan under which the offer is made;
 - (b) if a summary (rather than a copy) of the Rules of the Plan is given includes an undertaking that during the period (the *offer period*) during which an eligible employee may acquire the financial products offered or exercise options acquired under the scheme, the FKP Property Group will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the Plan;
 - (c) specifies in respect of the FKP Stapled Securities:
 - (i) the acquisition price in Australian dollars;

- (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
- (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer;
- (d) includes an undertaking, and an explanation of the way in which, the FKP Property Group will, during the offer period, within a reasonable period of the eligible employee requesting, make available to the employee:
 - the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of FKP Stapled Securities in the same class as those offered; and
 - (ii) where subparagraphs (c)(ii) or (c)(iii) apply, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by FKP, FFML in its own right or as responsible entity for the FKP Property Trust, a Gandel Village Company or an associate of any of these entities, for the purpose of acquiring FKP Stapled Securities under the FKP Employee Security Plan;
- 17. **Rules of the Plan** means the document entitled the FKP Employee Security Plan provided to ASIC on 27 May 2011.



Under paragraph 911A(2)(1) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 4. Under paragraph 911A(2)(1) of the Act, ASIC exempts:
 - (a) the Issuer; and
 - (b) any related body corporate of the Issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depositary service in connection with an eligible offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform these duties; and
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or a related body corporate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably made in connection with the offer.

Schedule

The following conditions apply:

- 1. the Issuer must:
 - (a) include the offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an eligible employee; and
- the Issuer must (or cause a related body corporate which has a registered office in this jurisdiction to) comply with any undertaking required to be made in the offer document by reason of this instrument; and
- 3. the Issuer must take reasonable steps to ensure that the number of shares to be received on the exercise of an option when aggregated with:

- (a) the number of shares in the same class which would be issued were each
 outstanding offer with respect to options to acquire unissued shares under an
 employee share scheme to be exercised; and
- (b) the number of shares in the same class issued during the previous 5 years under an employee share scheme or any other employee share scheme extended only to eligible employees of the Issuer,

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside of this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 of the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708 of the Act; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts Interpretation Act 1901.

Interpretation

In this instrument:

- except where otherwise stated, references to provisions are provisions of the Act;

- an employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee; and
- Australian dollar equivalent in relation to price, means a price calculated by
 reference to the relevant exchange rate published by an Australian bank no earlier
 than the business day before the day to which price relates; and

- 4. current market price means, in relation to a share, the price published by the New York Stock Exchange as the final price for the previous day on which the share was traded on that financial market operated by the New York Stock Exchange; and
- eligible employee means a person who is, at the time of an eligible offer under an
 employee share scheme, a full or part-time employee or director of the Issuer or of
 a related body corporate of the Issuer; and
- 6. eligible offer means an offer for the issue of options for the issue or transfer of fully-paid shares in the same class as shares which will have been quoted on the financial market operated by the New York Stock Exchange throughout the 3 month period immediately before the offer without suspension for more than a total of 5 trading days during that period made under an employee share scheme extended only to eligible employees of the Issuer and provided that each of the options offered under an employee share scheme is for no monetary consideration; and
- 7. financial product advice has the meaning given by section 766B; and
- 8. general advice has the meaning given by section 766B; and
- Issuer means LinkedIn Corporation, a body incorporated under the laws of Delaware, United States; and
- 10. offer has the meaning affected by sections 700, 702 and 1010C; and
- 11. *offer document* means a document setting out an offer under an employee share scheme that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the scheme; and
 - (b) if a summary (rather than a copy) of the rules of the scheme is given includes an undertaking that during the period (the *offer period*) during which an eligible employee may acquire the financial products offered under the scheme, the Issuer (or a related body corporate of the Issuer which has a registered office in this jurisdiction) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the scheme; and
 - (c) specifies in respect of the shares subject of the options, the Australian dollar equivalent of that price at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the Issuer (or a related body corporate of the Issuer which has a registered office in this jurisdiction) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:

- the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares of the same class as those subject to the options offered to the eligible employee; and
- (ii) the information referred to in paragraph (c) as updated to that date; and
- (e) discloses the options may not be exercised until the underlying shares have been quoted on the market operated by the New York Stock Exchange for at least 12 months; and
- (f) discloses the conditions, obligations, and risks associated with any loan or financial assistance offered by the Issuer or any related body corporate of the Issuer for the purpose of acquiring financial products under the scheme; and
- 12. related body corporate has the meaning given by section 50; and
- 13. share means a share in the Issuer.
