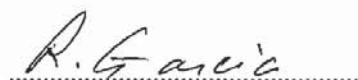

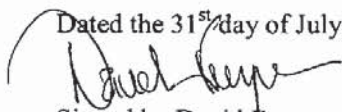

*unlisted MI warrant product* means a financial product that:

- (a) would, apart from the effect of paragraph 761D(3)(c) of the Act and subregulation 7.1.04(7) of the *Corporations Regulations 2001*, be a derivative for section 761D of the Act, and is excluded by that paragraph or subregulation only because it is a legal or equitable right or interest mentioned in subparagraph 764A(1)(b)(ii) of the Act;
- (b) is transferable but not able to be traded on a financial market; and
- (c) derives its value from a financial product of the kind mentioned in subparagraph 764A(1)(b)(i) of the Act that is able to be traded on the financial market operated by ASX Limited.

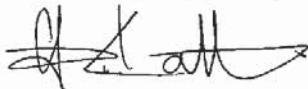
