Enabling power

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 926A(2)(c) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument [11-0864].

Declaration

3. ASIC declares that Part 7.6 (other than Divisions 4 and 8) of the Act applies in relation to Access Prepaid Australia Pty Limited ACN 145 452 044 (*Access Prepaid*) and its distributors as if the provisions of that Part were modified or varied as follows:

(a) in section 910A:

- (i) before the definition of *representative*, insert:

"*distributor* means a person who is authorised by a licensee to provide financial services on behalf of the licensee in relation to a facility through which a person manages financial risk."; and

- (ii) in the definition of *representative*, insert after subparagraph (a)(iii):

"(iii) a distributor of the licensee; or"; and

(b) after paragraph 911B(1)(a) insert:

"(ab) these conditions are satisfied:

- (i) the principal holds an Australian financial services licence covering the provision of the service; and

(ii) the provider is a distributor of the principal;".

Where declaration applies

4. The instrument applies where all the following are satisfied:

(a) the distributor:

- (i) is an Australia financial services (*AFS*) licensee (the *principal distributor*) to whom Access Prepaid has given a written notice (which notice has not been revoked) authorising the principal distributor to provide a financial service on behalf of Access Prepaid; or

- (ii) if the principal distributor is a body corporate—a representative of the principal distributor who has, with the written consent of Access Prepaid, been given a written notice (which notice has not been revoked) authorising them to provide the financial service on behalf of Access Prepaid;
- (b) the distributor is not an authorised representative of Access Prepaid;
- (c) the financial service is dealing in the ATM card on behalf of Access Prepaid;
- (d) Access Prepaid holds an AFS licence covering the provision of the financial service;
- (e) Access Prepaid has taken reasonable steps to ensure that, when the distributor provides the financial service to another person (the *client*) as a retail client, the client is given information in writing about:
 - (i) who the distributor acts for when providing the financial service;
 - (ii) any remuneration (including commission) or other benefits that the distributor, or an associate of the distributor, may receive in respect of, or that is attributable to, the provision of the financial service; and
 - (iii) the availability of a dispute resolution system of Access Prepaid that covers complaints by the client in relation to the financial service and how that system may be accessed.

Interpretation

In this instrument:

ATM card is a facility through which a person manages financial risk known as the Cash Passport ATM card issued by Heritage Building Society Limited ACN 087 652 024 that allows a person to:

- (a) credit the facility with an amount of foreign currency; and
- (b) withdraw the foreign currency while the client is outside or inside this jurisdiction through the use of an automated teller machine;

for a period of three years from the date of acquisition of the ATM card.

authorised representative has the meaning given by section 761A of the Act.

dealing has the meaning given by section 766C of the Act.

distributor means a person who deals in the ATM card on behalf of Access Prepaid.

facility has a meaning affected by section 762C of the Act.

issue has a meaning affected by section 761E of the Act.

manages financial risk has the meaning given by section 763C of the Act.

representative has the meaning given by section 910A of the Act.

Exemption

4. Entrust Funds Management Limited ACN 106 768 012 (*EFML*) in its capacity as the responsible entity of the Esplanade Property Fund ARSN 090 160 768 (*Fund*) does not have to comply with paragraph 601FC(1)(d) of the Act.

Where this instrument applies

5. This instrument applies to EFML in its capacity as responsible entity of the Fund where EFML implements a redemption scheme and:
 - (a) EFML has given all members of the Fund an explanatory memorandum that includes information about the redemption scheme; and
 - (b) after the explanatory memorandum has been provided to the members of the Fund, the members of the Fund have passed resolutions to approve proposed amendments to the constitution of the Fund necessary in order to implement the redemption scheme.



Commencement

3. This instrument commences on the day it is signed.

Exemption

4. Australian Securities Limited ACN 005 428 231 (*ASL*) in its capacity as the responsible entity of Australian Securities Property Fund ARSN 153 029 264 (the *fund*) does not have to comply with subsection 601ED(1) of the Act.

Where this instrument applies

5. This instrument applies in relation to the establishment by ASL of a managed investment scheme (*sub-scheme*) under the terms of the constitution of the fund, where the constitution includes clauses to the following effect:
 - (a) when the members of a sub-scheme:
 - (i) approve the change of the trustee of the sub-scheme from ASL to another entity; or
 - (ii) pass an extraordinary resolution to change the custodian,the sub-scheme must be wound up;
 - (b) where members of a sub-scheme pass a special resolution directing that an amendment to the constitution be made, then ASL must give reasonable consideration to whether the amendment would adversely affect the rights of members of the fund;

- (c) where members of a sub-scheme pass a special resolution directing that an amendment to the constitution be made, then ASL will amend the constitution under paragraph 601GC(1)(b) of the Act where the following requirements are satisfied:
 - (i) there is no adverse effect on the rights of a class of members of the fund; and
 - (ii) the amendment is not contrary to the best interests of members of the fund generally;
 - (d) where a sub-scheme is extended, the sub-scheme will continue so that new entrants will become members of the sub-scheme and will agree to be bound by the terms of that sub-scheme by entering into it;
 - (e) where a sub-scheme is extended, members who choose to not stay in the sub-scheme will be replaced by new members;
 - (f) a statement of the time frame within which ASL is required to accept or reject a request to withdraw interests in a sub-scheme;
 - (g) when ASL accepts a withdrawal request, ASL must pay the withdrawal price to the member and replace the member leaving the sub-scheme with a new member within 30 days;
 - (h) the ability of ASL to raise debt is limited to the specific assets of the sub-scheme for which the funds raised are to be used;
 - (i) members of a sub-scheme cannot be liable for debts of ASL that were incurred in capacity as the trustee of another sub-scheme or for the benefit of members of another sub-scheme;
 - (j) scheme property of a sub-scheme will not be encumbered in relation to a liability entered into for another sub-scheme;
 - (k) ASL is not entitled to be indemnified out the scheme property of a sub-scheme in relation to liabilities or expenses incurred for another sub scheme; and


