Australian Securities and Investments Commission Corporations Act 2001— Paragraph 601QA(1)(b) — Declaration

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraph 601QA(1)(b) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument [10/0926].

Declaration

- 3. ASIC declares that Chapter 5C of the Act applies to National Mutual Funds Management Ltd ACN 006 787 720 (NMFM) in its capacity as responsible entity of the Australian Property Fund ARSN 096 853 619 (APF) as if the following provisions of the Act were modified or varied as follows:
 - (a) omit all words after the second occurrence of "scheme" in subsection 601KB(1);
 - (b) omit paragraph 601KB(3)(b) and substitute:
 - "(b) the kinds of assets that will be used to satisfy withdrawal requests; and"; and
 - (c) omit paragraph 601KB(3)(c) and substitute:
 - "(c) the minimum and maximum amount of money that is expected to be available to satisfy withdrawal requests under the withdrawal offer; and",

in the case specified in the Schedule.

Schedule

Where:

- 1. NMFM makes a withdrawal offer in writing to all members of APF on or about 11 October 2010 (*Withdrawal Offer*); and
- 2. the Withdrawal Offer specifies:

- (a) the amount of money available to satisfy withdrawal requests made in response to the Withdrawal Offer will depend upon participation in a withdrawal offer by NMFM in its capacity as responsible entity of Wholesale Australian Property Fund ARSN 088 996 392 (WAPF) which is made and is to close at the same time as the Withdrawal Offer (WAPF concurrent offer);
- (b) the assets of WAPF that will be used to satisfy withdrawal requests and amount of money that is expected to be available to WAPF when those assets are converted to money in respect of the WAPF concurrent offer;
- (c) the factors that NMFM reasonably considers will influence how much money is available to satisfy withdrawal requests made in response to the Withdrawal Offer;
- (d) that all monies received from the withdrawal of interests in WAPF will be used to satisfy withdrawal requests made in response to the Withdrawal Offer other than an amount NMFM reasonably considers is required to be retained to meet operating expenses;
- (e) that details of the assets used to satisfy withdrawal requests and the amount of money available to satisfy withdrawal requests made in response to the Withdrawal Offer will be notified to each member that made a withdrawal request in response to the Withdrawal Offer as soon as practicable after the Withdrawal Offer closes in writing; and
- (f) that NMFM will maintain a website that contains all relevant and up to date information in relation to the Withdrawal Offer and details of how members can access the website or request information.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 741(1)(a) — Exemption

Under paragraph 741(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts Covidien plc, a company incorporated under the laws of Ireland (*Covidien*), from Parts 6D.2 and 6D.3 (except section 736) of the Act where the person:

- 1. makes an eligible offer;
- 2. offers to arrange for the issue of financial products under an eligible offer;
- 3. issues a financial product under an eligible offer,

that involves a contribution plan but does not involve Covidien or any associated body corporate offering any eligible employee of Covidien a loan or similar financial assistance for the purpose of, or in connection with, the acquisition of financial products to which the offer relates, in the case specified in Schedule A and on the conditions set out in Schedule B for so long as the conditions are met.

Schedule A

Where the eligible offer of shares is made through the Trust:

- 1. the Trustee must hold the shares on trust for each person (a *beneficiary*) who acquires units of shares under an eligible offer; and
- 2. the Trustee must cause proper written records to be maintained in respect of the activities of the Trust and make records available for inspection by an Australian beneficiary at a place of business of Covidien or electronically as agreed to by the eligible employee which set out the total number of shares and other assets held by the Trustee on behalf of all Australian beneficiaries and/or records setting out the shares and other assets held by the Trustee on behalf of that beneficiary, and
- the Trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
- the Trustee must not levy any fees or charges for operating and administering the Trust, either payable directly by the beneficiaries or out of the assets of the Trust; and
- except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the Trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
- the Trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and

 the Plan and the Trust must at all times be approved or authorised under the law of the United States of America.

Schedule B

The following conditions apply:

- 1. Covidien must:
 - (a) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (b) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- Covidien must take reasonable steps to ensure that the number of shares the subject of the offer when aggregated with:
 - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme to be accepted or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the Covidien,

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708 of the Act; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued shares in that class of Covidien as at the time of the offer; and

- Covidien must accept notices, correspondence and service of process at a registered office or principal place of business in Australia; and
- Covidien must make available for public inspection at a registered office or principal place of business in Australia and provide to offerees copies of the constituent documents of the eligible offer and meet all reasonable requests for information; and
- within 14 days of the date of this instrument, ASIC must be provided with certified copies of the rules of the Plan and any other documents comprising the eligible offer; and
- 6. Covidien must keep at a registered office or principal place of business in this jurisdiction, a register of its employees who participate in the eligible offer and enter in the register:
 - (a) the names and addresses of each employee;
 - (b) the extent of the holding of each employee;
 - (c) the date at which the name of each employee was entered in the register; and
 - (d) the date at which any employee's interest ceased; and
- Covidien must comply with any undertaking required to be made in the offer document by reason of this instrument.

Interpretation

In this instrument:

- 1. except where otherwise stated, references to provisions are to provisions of the Act;
- an employee share scheme shall not be regarded as extended to a person other than
 an eligible employee only because such an employee may renounce an offer of
 financial products made to them under the scheme in favour of their nominee;
- 3. associated body corporate of Covidien means:
 - (a) a body corporate that is a related body corporate of Covidien; or
 - (b) a body corporate that has voting power in Covidien of not less than 20%; or
 - (c) a body corporate in which Covidien has voting power of not less than 20%;
- 4. Australian dollar equivalent in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which the price relates;
- 5. contribution plan means a plan under which a participating eligible employee may

save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for units offered for issue or sale under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:

- (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application that is used in respect of the offer, or on a form that is included in or accompanies the offer document;
- (b) before transferring contributions to acquire units, any contributions made by an employee as part of the contribution plan must be held by Covidien in trust for the employee in an account of an Australian ADI which is established and kept by Covidien only for the purpose of depositing contribution moneys and other money paid by employees for the units on offer under the employee share scheme; and
- (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest, must be repaid to that employee;
- current market price means in relation to a share, the price published by the New York Stock Exchange as the final price for the previous day on which the share was traded on that financial market;
- eligible employee means, in relation to Covidien, a person who is at the time of an
 offer under an employee share scheme, a full or part-time employee or director of
 Covidien or an associated body corporate;
- 8. eligible offer means an offer to subscribe for fully-paid shares in Covidien where:
 - (a) the shares are in the same class as shares which have been quoted on the New York Stock Exchange throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period;
 - the offer is made under an employee share scheme extended only to eligible employees; and
 - (c) offer is made on substantially the same terms set out in the letter from PricewaterhouseCoopers to ASIC dated 27 November 2008;
- 9. offer has a meaning affected by sections 700, 702 and 1010C of the Act;
- 10. offer document means a document setting out an offer under an employee share scheme that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan under which the offer is made; and

- (b) if a summary (rather than a copy) of the rules of the Plan is given includes an undertaking that during the period (the offer period) during which an eligible employee may acquire the financial products the subject of the offer under the Plan, Covidien will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
- specifies the means by which the acquisition price will be converted into an amount in Australian dollars; and
- (d) includes an undertaking, and an explanation of the way in which, Covidien will, during the offer period, within a reasonable period of the employee requesting, make available to the employee the Australian dollar equivalent of the current market price of the shares in the same class as those offered; and
- (e) specifies:
 - the Australian ADI where contributions for the purposes of the contribution plan are held;
 - (ii) the length of time they may be held, and
 - (iii) the rate of interest payable (if any) on the contributions held in the account;
- 11. Plan means the "Covidien Employee Stock Purchase Plan" as amended on 4 June 2009 the terms of which were provided to ASIC by PricewaterhouseCoopers on 21 September 2010;
- 12. *Trust* means the SPS Participant Trust governed by the rules of the Plan and trust deed:
- 13. *Trustee* means Fidelity Personal Trust Company FSB, a Federal savings bank organised under the laws of the United States of America];
- 14. *trust deed* means the "SPS Participant Trust Covidien Ltd. Declaration of Trust" entered into by the Trustee and Covidien and dated 15 April 2008; and
- 15. unit in relation to a share means a legal or equitable right or interest in the share.
