## Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) – Exemptions

#### First Exemption: disclosure relief for offers not involving a contribution plan

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts:
  - (a) the Issuer from Parts 6D.2, 6D.3 (except section 736) and 7.9 of the Act where the Issuer:
    - (i) makes an eligible offer;
    - (ii) offers to arrange for the issue of financial products under an eligible offer;
    - (iii) issues a financial product under an eligible offer; or
    - (iv) issues a financial product on the vesting or exercise of a Performance Right that was issued under an eligible offer;

that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.

- 2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
  - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made to acquire the financial product as a retail client; and
  - (b) the person who made the recommendation is not aware, and ought not reasonably be aware, that any of the conditions set out in the Schedule have not been met.

## Second Exemption: licensing and hawking relief

3. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in paragraph 1 (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that recipients of the offer should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

- 4. Under paragraph 911A(2)(l) of the Act, ASIC exempts:
  - (a) the Issuer; and
  - (b) any related body corporate of the Issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by the exemption in paragraph 1 where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by the exemption in paragraph 1 where any acquisition by purchase or disposal of the product (by the Issuer or a subsidiary of the Issuer) occurs either:
  - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
  - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

#### Schedule

The following conditions apply:

- the Issuer must ensure that the eligible offer is substantially on the terms set out in the draft terms of the CO2 Group Limited Employee Incentive Plan Rules provided to ASIC as an attachment to a letter received on 23 August 2011 from Corrs Chambers Westgarth on behalf of the Issuer;
- 2. when making the offer the Issuer must:
  - (a) include that offer in an offer document; and
  - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and

- (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an eligible employee;
- 3. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument;
- 4. the Issuer must take reasonable steps to ensure that the number of shares to be issued on the vesting or exercise of a Performance Right the subject of the offer, when aggregated with:
  - (a) the number of shares in the same class which would be issued were:
    - (i) each Performance Right which has previously vested under the Employee Incentive Plan Rules exercised; and
    - (ii) each outstanding offer with respect to Performance Rights made under the Employee Incentive Plan Rules accepted and the Performance Rights vested or exercised; and
    - (iii) each outstanding offer with respect to shares, units of shares and options to acquire unissued shares under any other employee incentive scheme to be accepted and, if relevant, exercised; and
  - (b) the number of shares in the same class issued during the previous 5 years under;
    - (i) the Employee Performance Rights Plan Rules where the Performance Rights issued under that Plan have been vested or exercised; and
    - (ii) any other employee incentive scheme extended only to eligible employees,

but disregarding any offer made, or Performance Right acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708 of the Act; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or

(g) an offer made under a disclosure document or Product Disclosure Statement, must not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts Interpretation Act 1901.

#### Interpretation

In this instrument:

- 1. except where otherwise stated, references to provisions are to provisions of the Act;
- 2. the Employee Incentive Plan or any other employee incentive scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
- 3. ASX means the financial market operated by ASX Limited ACN 008 624 691;
- 4. *contribution plan* means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for shares offered for issue or sale under the Employee Incentive Plan Rules where the terms and conditions of the contribution plan include terms and conditions to the effect that:
  - (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document;
  - (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the Issuer in trust for the employee in an account of an Australian ADI which is established and kept by the Issuer only for the purpose of depositing contribution moneys and other money paid by employees for the shares on offer under the employee share scheme; and
  - (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest, must be repaid to that employee;
- 5. *current market price* means, in relation to a share, the price published by the operator of the ASX as the final price for the previous day on which the share was traded on the ASX;

- 6. *eligible employee* means, in relation to the Issuer, a person who is at the time of an offer under the Employee Incentive Plan Rules:
  - (a) a full or part-time employee of the Issuer or of a related body corporate of the Issuer; or
  - (b) a director of the Issuer, or of a related body corporate of the Issuer, who holds a salaried employment or office in the Issuer or in a related body corporate of the Issuer;
- 7. *eligible offer* means an offer for the issue of a Performance Right under the Employee Incentive Plan Rules extended only to eligible employees of the Issuer;
- 8. *Employee Incentive Plan* means the Issuer's employee incentive scheme that is known, as at the date of this instrument, as the CO2 Group Limited Employee Incentive Plan where:
  - (a) the scheme is extended only to eligible employees; and
  - (b) the terms of the scheme are substantially on the terms outlined in the letter received by ASIC on 23 August 2011 from Corrs Chambers Westgarth on behalf of the Issuer;
- 9. Employee Performance Rights Plan Rules means the written terms of the Employee Incentive Plan, as at the date of this instrument, that are substantially on the terms set out in the draft terms of the CO2 Group Limited Employee Incentive Plan Rules provided to ASIC as an attachment to a letter received on 23 August 2011 from Corrs Chambers Westgarth on behalf of the Issuer.
- 10. *financial product advice* has the meaning given by section 766B of the Act;
- 11. general advice has the meaning given by section 766B of the Act;
- 12. Issuer means CO2 Group Limited ACN 009 317 846;
- 13. offer has a meaning affected by sections 700, 702 and 1010C of the Act;
- 14. *offer document* means a document setting out an offer under the Employee Incentive Plan that:
  - (a) includes or is accompanied by a copy, or a summary, of the Employee Incentive Plan Rules; and
  - (b) if a summary (rather than a copy) of the Employee Incentive Plan Rules is given — includes an undertaking that during the period (the offer period) during which an eligible employee may acquire or exercise the Performance Rights offered under the Employee Incentive Plan, the Issuer will, within a reasonable period of the eligible employee so requesting, provide the eligible employee without charge with a copy of the Employee Incentive Plan Rules; and

- (c) specifies in respect of the shares that may be acquired on the vesting or exercise of a Performance Right:
  - (i) the acquisition price (if any) in Australian dollars; or
  - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
  - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which the Issuer will, during the offer period, within a reasonable period of the eligible employee requesting, make available to the eligible employee:
  - (i) the current market price (or where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares that will be acquired by the eligible employee when the Performance Right offered to the eligible employee vests or is exercised; and
  - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the Issuer or any related body corporate of the Issuer for the purpose of acquiring any financial products under the Employee Incentive Plan;

#### 15. Performance Right means:

- (a) an unsecured right to acquire, by way of issue or transfer, a fully-paid share in the Issuer in accordance with the Employee Incentive Plan Rules; or
- (b) where the right referred to in paragraph (a) has vested or has been exercised in accordance with the Employee Incentive Plan Rules, but the fully paid share to which the right relates has not been issued or transferred to the eligible employee, an equitable interest in a fully-paid share,

#### where:

- (c) each Performance Right is offered for nil consideration; and
- (d) the share to which the Performance Right relates is a fully-paid share in the same class as shares that have been quoted on the ASX throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period;

## Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(a) and 1020F(1)(a) – Exemption

## **Enabling Legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 601QA(1)(a) and 1020F(1)(a) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument [11-1067].

#### Commencement

This instrument commences on Gazettal.

#### Exemptions

- (a) Centro MCS Manager Limited ACN 051 908 984 in its capacity as the responsible entity of Centro Retail Trust ARSN 104 931 928 (CRT RE);
  - (b) Centro MCS Manager Limited ACN 051 908 984 in its capacity as the responsible entity of Centro DPF Holding Trust ARSN 153 269 759 (**DHT RE**);
  - (c) CPT Manager Limited ACN 054 499 307 in its capacity as the responsible entity of Centro Australia Wholesale Fund ARSN 122 223 974 (*CAWF RE*),
  - (d) Centro Retail Limited ACN 114 757 783 (CRL);
  - (e) each of the Sale Nominee; and
  - (f) Link Market Services Limited ABN 54 083 214 537 (Link),

## do not have to comply with:

- (g) section 601ED of the Act;
- (h) Divisions 2 to 5 of Part 7.9 of the Act; and
- (i) the requirement to hold an Australian financial services license for the provision of the following financial services:
  - (i) dealing in an interest in a Sale Facility; and
  - (ii) the provision of general advice in relation to an interest in the Sale

#### Facility,

to the extent that CRL, CRT RE, DHT RE and CAWF RE (each, an *Issuer*), each Sale Nominee and Link operate a managed investment scheme by reason of operating a Sale Facility.

5. The Issuers, each Sale Nominee and Link do not have to comply with Division 5A of Part 7.9 of the Act to the extent that an Issuer, each Sale Nominee and Link is taken to have invited a holder of a financial product of the Issuer to make an offer to sell the financial product through a Sale Facility.

#### Where this instrument applies

- 6. The following facilities (each, a *Sale Facility*) are offered and implemented:
  - (a) the First Sale Facility, which will operate in connection with the Aggregation proposal referred to in the CER EM and Disclosure Document and will apply to all Ineligible Foreign Securityholders; and
  - (b) the Second Sale Facility, which will operate in connection with the CATS and in accordance with the CATS Terms and the Disclosure Document as they apply to an Ineligible Holder.
- 7. In respect of the First Sale Facility, the First Sale Facility satisfies all of the following:
  - (a) the financial products that may be sold or purchased (as applicable) through the First Sale Facility are shares or interests in a managed investment scheme that are admitted to quotation on a Licensed Market or Approved Foreign Market; and
  - (b) under the terms of the First Sale Facility:
    - (i) the financial products (the *relevant financial products*) of Ineligible Foreign Securityholders to be sold through the First Sale Facility are pooled; and
    - (ii) the Sale Nominee sells the relevant financial products in the ordinary course of trading on the relevant market; and
    - (iii) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by the Issuer) are distributed to Ineligible Foreign Securityholders; and
    - (iv) each Ineligible Foreign Securityholder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the date of implementation of the Aggregation proposal.
- 8. An Issuer must:

- (a) give or send to each Ineligible Foreign Securityholder, the CER EM and the Disclosure Document by:
  - giving the CER EM and the Disclosure Document to the Ineligible Foreign Securityholder personally; or
  - (ii) sending the CER EM and the Disclosure Document:
    - A. by post to the address for the Ineligible Foreign Securityholder in the Register of Members or an alternative address (if any) nominated by the Holder; or
    - B. to the fax number or electronic address (if any) nominated by the Ineligible Foreign Securityholder; and
  - (b) take reasonable steps to ensure the First Sale Facility is not operated during any period where a Control Transaction has been publicly proposed and has not ended.
- 9. The information about how to obtain up-to-date information on the market price of the financial product is made available on the Website.
- 10. In respect of the Second Sale Facility, the Second Sale Facility satisfies all of the following:
  - (a) the financial products that may be sold or purchased (as applicable) through the Second Sale Facility are shares or interests in a managed investment scheme that are admitted to quotation on a Licensed Market or Approved Foreign Market; and
  - (b) under the terms of the Second Sale Facility:
    - (i) the financial products (the *relevant financial products*) of Ineligible Holders to be sold through the Second Sale Facility are pooled; and
    - (ii) the Sale Nominee sells the relevant financial products in the ordinary course of trading on the relevant market; and
    - the proceeds of the sale net of expenses (to the extent (if any) that they are not met by the Issuer) are distributed to Ineligible Holders;
    - (iv) each Ineligible Holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 10 weeks after the date of implementation of the Aggregation proposal.
- 11. An Issuer must:

- (a) give or send to each Ineligible Holder, the Disclosure Document by:
  - (i) giving the Disclosure Document to the Ineligible Holder personally;
  - (ii) sending the Disclosure Document:
    - A. by post to the address for the Ineligible Holder in the Register of Members or an alternative address (if any) nominated by the Holder; or
    - B. to the fax number or electronic address (if any) nominated by the Ineligible Holder; and
- (b) take reasonable steps to ensure the Second Sale Facility is not operated during any period where a Control Transaction has been publicly proposed and has not ended.
- 12. The information about how to obtain up-to-date information on the market price of the financial product is made available on the Website.

#### Interpretation

13. In this instrument:

Aggregation, Aggregation Fund, Aggregation Record Date, CAWF, CATS, Centro Retail Australia, CRT, DHT and Securityholder have the same meaning as in the Disclosure Document.

Approved Foreign Market means each of the following financial markets:

- (a) American Stock Exchange;
- (b) Borsa Italiana;
- (c) Bursa Malaysia Main Board and Bursa Malaysia Second Board;
- (d) Euronext Amsterdam;
- (e) Euronext Paris;
- (f) Frankfurt Stock Exchange;
- (g) Hong Kong Stock Exchange;
- (h) JSE;

- (i) London Stock Exchange;
- (i) NASDAQ Stock Market;
- (k) New York Stock Exchange;
- (l) New Zealand Exchange;
- (m) Singapore Exchange;
- (n) SWX Swiss Exchange;
- (o) Tokyo Stock Exchange; and
- (p) Toronto Stock Exchange.

ASX means the financial market operated by ASX Limited ACN 008 624 691.

**CATS Terms** means the terms of the CATS as contained in the constitution of each of CRT, CAWF and DHT.

CER means CRT and CRL.

CER EM means the explanatory memorandum in respect of the Aggregation proposal issued by CER which is substantially in the same form as that provided to ASIC on or about [4 October 2011]2011.

**Control Transaction** means a transaction or proposed transaction that affects the control, or potential control, of Centro Retail Australia, excluding the Aggregation proposal.

**Disclosure Document** means the joint disclosure document lodged with ASIC on or about 5 October 2011 which is issued by the responsible entities of CRT, CAWF and DHT and which sets out, amongst other things, information concerning Centro Retail Australia and the Aggregation proposal.

First Sale Facility means the facility applicable to Ineligible Foreign Securityholders as referred to in the Disclosure Document.

**Holder** has the meaning given by section 761A of the Act.

**Ineligible Foreign Securityholder** means a Securityholder whose address as at the Aggregation Record Date as shown on the register of the Aggregation Fund Securityholders is a place outside of Australia and New Zealand and their respective external territories.

Ineligible Holder has the same meaning as in the CATS Terms.

Licensed Market has the meaning given by section 761A of the Act.

Register of Members means the register of members required to be set up and maintained under section 169 of the Act.

Sale Facility means the First Sale Facility and/or the Second Sale Facility.

Sale Nominee means each of the following companies provided that they are a participant of a Licensed Market or Approved Foreign Market with whom the Issuer has entered arrangements for the operation of the Sale Facility:

- (i) in relation to the First Sale Facility, UBS AG ARBN 088 129613;
- (ii) in relation to the Second Sale Facility, any one of:
  - (a) UBS AG ARBN 088 129 613; or
  - (b) Macquiarie Group Limited ACN 122 169 279 or any one of its subsidiaries.

**Second Sale Facility** means the facility applicable to Ineligible Holders as referred to in the CATS Terms and the Disclosure Document.

#### Website means:

- (i) in relation to the First Sale Facility, means <u>www.cerinvestor.com.au</u> or such other website as is specified in the ASX release relating to the First Sale Facility; and
- (iii) in relation to the Second Sale Facility, means the website as is specified in the ASX release relating to the Second Sale Facility.

## Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) — Exemption and Revocation

#### **Enabling legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the Corporations Act 2001 (the Act).

#### Revocation

 ASIC Instrument of relief exempting Watpac Developments Pty Ltd ACN 011 033 795; William Ronald Nichol and Valma Joan Nichol dated 19 July 2001 is revoked.

## Exemption

- 3. This exemption applies to an interest in a managed investment scheme (serviced strata scheme) which involves an owner (investor) of real property (strata unit), in the investor's discretion, making their strata unit available for use by a person (operator) as part of a serviced apartment, hotel, motel or resort complex located at "Inn Cairns", at 71-75 Lake Street, Cairns, Queensland, developed in accordance with an approval of a local government organisation that has been given to ASIC and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme.
- 4. An interest in the serviced strata scheme is exempt from the following provisions of the Act:
  - (a) Part 7.6 (other than Divisions 4 and 8); and
  - (b) section 992AA; and
  - (c) section 1017F.

## Where exemption applies

- 5. The exemption in paragraph 4 only applies where all of the following requirements are satisfied:
  - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
  - (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:

- by a person other than the operator or an associate of the operator;
   and
- (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is a financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
  - (i) payment of money to buy the strata unit; and
  - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
    - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
    - (B) where a FFE Fund has been established for the investor no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
  - (iii) where a FFE Fund has been established for the investor one or more payments into the Fund where:
    - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
    - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;

- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in paragraph 5;
- (h) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (i) where a FFE Fund has been established for an investor, the operator takes reasonable steps to ensure that:

## (d) Voting

- (ii) For scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have one vote; and
- (iii) For body corporate members, a majority is based on their entitlement to vote at body corporate meetings; and
- (iv) A scheme member or a body corporate member makes a decision by signing a document that sets out the decision; and

## (e) Costs

- (i) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in subparagraph (a)(i) for the purposes of determining a price to be specified in a notice under subparagraph (a)(ii); and
- (ii) If a member incurs any reasonable valuation, auction or marketing costs under subparagraph (i) that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator; and

#### (f) Assistance

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings; and

#### (g) Definitions

In this paragraph:
